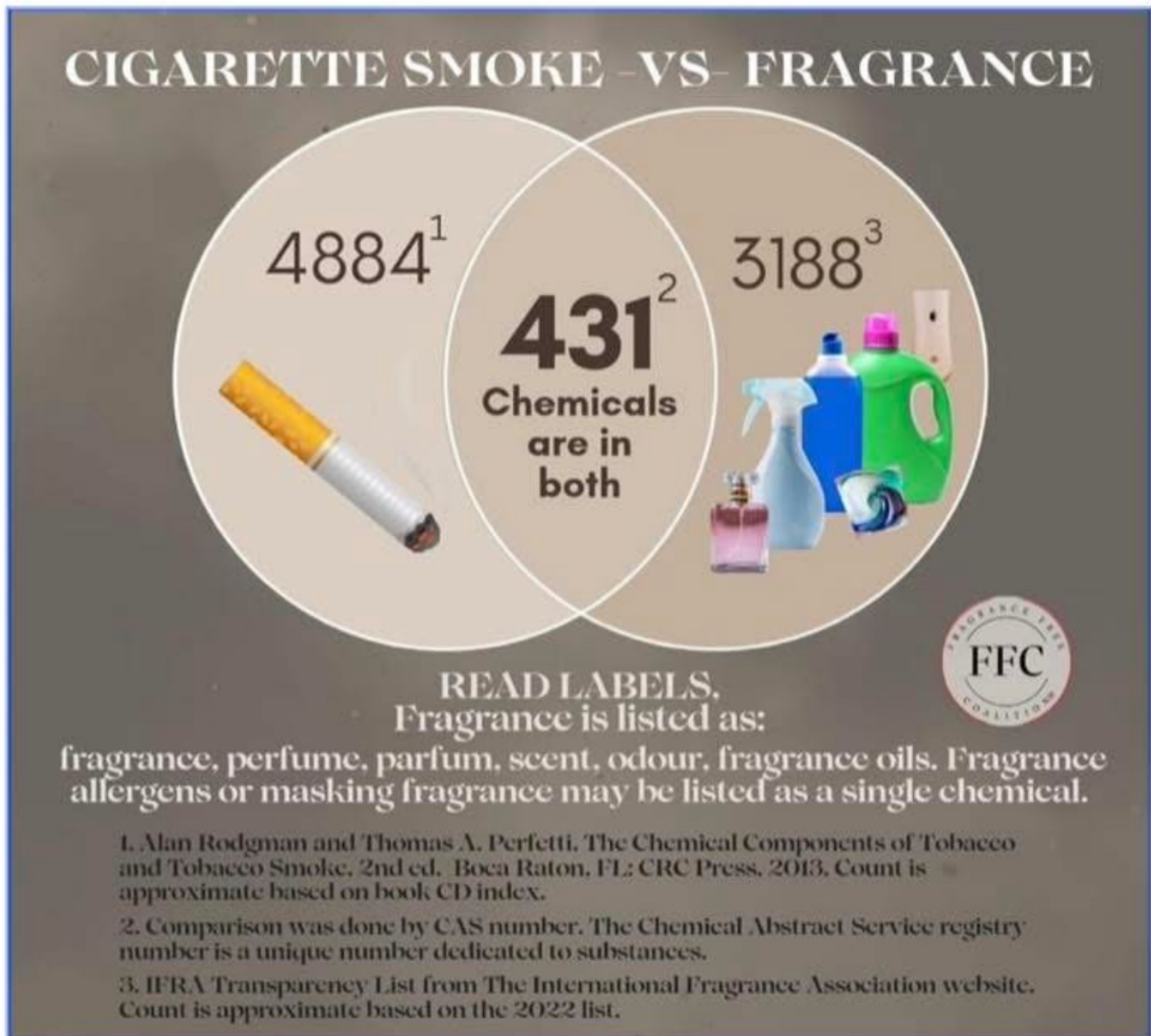

▲ Effected by bias law enforcement agents, engulfed into deliberate multi-agencies' conspiring effort to harm MCS victim, retaliating to MCS accommodation of urgent and critical nature, & helpful counterpoint, demonstrated by other colleagues

Malibu police was also involved into the concerted effort to mischaracterize my detailed to them MCS illness, in order to absolve own role in avoidance of urgent and relevant assistance for my life threatening hardship - contrary to the goodwill of many members of the local community. In fact they were proactively MISguiding other members of city governance and elected city leadership into bias, while feeding with lies to the citywide character assassination campaign to cause distrust along Good Samaritans, instead of promoting just the opposite to this culture of moral atrocity. However, admittedly this was not revealed to me right away.

The problems began during late Fall 2024, when I became the subject of sudden and notorious harassment by the group of teens, who were friendly for several months. It the day after I was harassed by local mechanic, refusing to help me with desperate repair, and making me drive after forgetting to check liquids - for testing (The car turned out to have no cooling liquid at all - added 2.5 gallon of water to refill completely empty container.) After second harassment assault I had to call police to ask for interference, with incivility, but instead, police joined the the outrage of harassment and made it worse(!) (more details may be available upon request)

City of Malibu is the community with many heart-centered people, as well as with likely one of the world's most affluent and influential residents. That is why, it is ever more paradoxical for the city administration to have no dedicated task force assisting homeless populations, especially after the area became the grounds of several vast regional fires, leading to mass population's suffering - the feeling that should be resonant to all locals. And the local elected representatives, elected by voters, chose in 2024 elections the new council member Haylynn Conrad, who vowed to make this her cause. But she refused to make even a brief visit, when I was desperately trying to get ahold of her during hostage situation with very limited internet and taken away access to electricity-charging station - deliberately made my such contact impossible (!!)

From what I understood, this duty of assisting ppl in homeless crisis is paradoxically delegated to ONE police officer Espinoza. But by definition, law enforcement personnel have no credentials in social services and their main job is to respond to emergency calls to restrain violent crimes. They have no time for long term pursuit of issues involving investigation demanding for focus, patience and continuity. But that is impermissible when dealing with people who are in the ongoing crisis solutions. No secret, the current reality of these public servants' training is focused on using force rather than being patient and effective in solving complexities, that lead to dangerous to others and socially unacceptable acts of crimes. And, such cognitive dissonance that was institutionalized through governance, produced results - shocking with human rights violations by institutionalized cruelty.

This short video is evident of I incoherent speech and actions by Malibu Police officer Espinoza on 2/4/25 10:53am falsely claiming "violations" and making no effort to verify lies of biased harassment of me being the victim of unfair security guard, while interjecting irrelevant comments revealing cognitive dissonance re his duties to assist me. 🖱️ <https://youtube.com/shorts/20g4owOxKSw?feature=share>

This officer knew me from a number of extended talks and he seemed to be capable to appraise the value of my scholarship, while at the same time, resented making personal changes in becoming self compassionate by avoiding toxic fragrance as well as “fit for duty” of the first responder: Despite learning from me of data of proven danger of fragrance, officer Espinoza never stopped using fragranced products after learning of their harms for self and others - despite dealing with MCS victims, vulnerable to even short exposures during emergencies, that could easily turn fatal with heart attacks, strokes, seizures, internal bleeding, lung collapses etc. And despite being responsible to help homeless ppl in crisis, he prejudiced me, due to implicit bias, caused by addictive properties of fragrance. It is known for neurotoxins to mess up with clarity of thinking. (I’ve ordered SCENT FREE DEODORANT for him to try to use instead of his scented hygiene products, but don’t know if this may help the mind shift, that needs to be supported by the culture of the community, as the counterpoint to the related culture of moral atrocity that normalized toxic consumer goods for generations). I’ve inspired online community support group, however it takes time and effort to sprout.).

Likely he forgot my real diagnosis related to mold toxicity, and curiously, he used the same verbiage re “refused housing”, and he had not offered any for me. He simply could not do so, since he is not informed to discuss MCS accommodations for housing. He did promised to help me with car repairs either but never called back. And then a day after I had to encounter fraud: I’ve received a call from some agency that offered me the management of psychotropic drugs(!) I was very concerned about this shocking irrelevance I to my needs, oddly linked to police interactions. And to my question about how the agency got my name and number I heard even more surprising answer - *“They had referral from Jimmy Gallardo (People’s Concern), signed(!) by him”* ?... However I spoke with Jimmy, who repeatedly rejected making such referral personally, alluding to fraud under his name. (And it would be fair to say that throughout the time of being in contact with this foot soldier, his method of communication was limited to a few short texts, so it would be hard to imagine this guy being involved into writing referrals, while mostly on the go.) However, when I contacted with this serious concern his supervisor **Tiffany Stewart**, she didn’t reply in any manner, despite several repeated mailings of my request for urgent explanation. And although I’ve never met this unethical member of the ring of thugs, she had been always behind the scenes, in charge of routing and rerouting “the foot soldiers” of the lower rank into manipulative acts of gaining trust with “bait and switch”, so she and her cronies could take advantage of the their vulnerable victims - initially unsuspecting of their premeditated “fowl game”... Luis Flores named her as “his contact” and the key liaison between People’s Concern and City of Malibu administration in this corrupt scheme of conspiring affiliates. And since she never responded to my emails re misuse of Jimmy’s name on the flawed referral to mental health agency, she appears to be the likely lair, who committed triple fraud. 🖐️ This illuminated the fraud that engulfed likely unsuspecting collaboration of police officer Espinoza and People’s Concern.

Notably, when I finally met her in person on 8.28.2025 and confronted both Jimmy and Tiffany, she finally spoke the truth, admitting that Jimmy did sign such fraudulent referral. But she had nothing to argue about, when I’ve explained, that he had no capacity to make any comments about me since he wasn’t in contact with me since 2022. I was increasingly frustrated and shocked by learning of this betrayal, since Jimmy managed to make impression of “a carrying and kind” person. This took place

8.28.25, when she and her foot soldiers tried to make her another manipulative stunt of making impression of offering me housing, by manipulating me to go through filled with toxic fragrance shelter, that set off chest pressure and heart pain, but they were unapologetic for this lack of concern, instead bluntly insisting for me to except this as their “helpful offer of housing”. To my request to make written acknowledgment of viewing and comprehension of the edu video on the danger of deliberate retaliatory “confusion” of MCS with “psychotic delusions”, all three - Tiffany, Brianna and Jimmy, demonstrating their evil intention to continue to practice harmful for me attitude of refuse to follow the discussed in the video legal requirements for accessibility for MCS victims, according to ADA, while under the excuse of the denied true MCS diagnosis, replaced with ridicule of my severe and life threatening symptoms and fraudulent label of denial of reality and mental “disfunction”, resulting in continuing paralysis of every part of my life.

Furthermore, during the course of forced for three years stay in the area of Malibu - the extended hostage conditions, I did run into **the local resident of Malibu, who would be soon in my position of MOLD REFUGEE** and likely persecuted in the similar ways instead of relevant diagnosis and treatment by the self serving medical industry.

Thus, it is important to understand, that the system behind the mindless hostility directed against me, in retaliation to being forced BY PAIN into position of catalyst of change, had been **against OWN community health needs**. It is essential to understand that prevention of accommodations for MCS victims, who have the painful gift to detect HARMFUL FOR ALL, BUT NORMALIZED CHEMICALS WITH CUMULATIVE EFFECTS OF DEADLY AND CHRONIC ILLNESSES AND BIRTH-DEFECTS, is prevention of the rare opportunity to make communities and their individual members healthier(!) and prepared for increasing indiscriminate cumulative effects on ALL. Since today's children already carry genetic impacts of parent's to if exposures, their offsprings are to manifest the related lower tolerance to toxicity that had been left uncurbed from increase leading to the similar to mine condionnrhebfrqnd scale of majority of population(!!)

The lack of acknowledgment of the inconvenient truth are today's data on fast growing casualties of environmental illnesses and lack of any relevant help with recovery and chemicals free shelter facilities that should be within the scope of government agencies of all levels, is impermissible sign of denial of reality. Since this higher than average painful capacity for identification of chemical hazards had been lost by majority of population, most people are NO LONGER ABLE to detect chemical hazards with own pain alarm system of survival instinct, due to habituation and **conformity-driven maladaptive deactivation of pain alarms to toxicity**. It is due to the strive for profit from normalized environmental toxins being legalized and allowed to become “the fabric of our life” in many consumer goods with tangible cumulative effects of off-gassing - dangerously subtle and yet impactful over time. The effect of lowering the level of tolerance of each new generation more and more had been tracked by researchers (such as infertility report), but mindlessly dismissed by the corrupt, driven by unethical profiteering from mass suffering academia and medical industry. Many illnesses based on anthropogenic environmental toxins could be prevented, if they were merely identified, as such - as the related to toxicity exposure by medical providers who are trained to avoid this issue contrary to logic - as if it's “not” preventable. Thus, several generations had been living under the false premise of institutionalized denial of danger to toxicity exposure, based on the irrelevant to

human health and safety standards for manufacturers of products that are used even for care of most vulnerable hospital patients, children, elders etc. The resulting *maladaptive conformity to groupthink and authority pressure made several generations to numb down own alarm system to self defeating state of complicity to toxicity - due to having to live in toxic soup with no or hard to obtain nontoxic alternatives (!)*. Indeed, this dominance of self defeating consciousness of the collective Blindspot of environmental insanity IS the cause of hopelessness among humanity. But there is solution - still available during fast closing window to prevent massive collapse of society by rapidly rising rates of environmental illnesses, most of which still remain unlabelled as “PREVENTABLE” by dominant medical industry systems, based on self defeating consciousness based on senseless corruption at the core of it, driven by the lack of sense of interconnectedness of everything in our reality...

However, at the same time, population deserves to know: There IS hope for humanity to avoid self perpetuating our agony of pain for own offsprings and collapse of humanity at large (as in data forecast to global infertility crisis by 60+studies in various countries). And it starts with THE ONLY LOGICAL STEP of ALIGNING LIFE TO THE TOP PRIORITY of IDENTIFICATION of toxicity - possible with the assistance of MCS individuals, who are informed by pain and thus, remain capable of identifying chemicals hazards in COMMON AND NORMALIZED consumer products, air, water, food - hazardous for all(!) today and in perpetuity of genetic mutations leading to agony of pain among offsprings for generations to come - just as in **autism epidemic, finally identified in April 2025 for the first time by Robert F Kennedy for one of environmental illnesses...**

I had been forced to explain these issues every time I have to face existential challenge from interacting with either any law enforcement or ppl in the position for professional counselors, who were supposed to serve as the advocates for my MCS disability but lacked any info. And due to being in 7.5-7.14.25 hostage situation, I had the same task, while the dangers to my life had elevated to intolerable. And, I've run into the local individual with exceptional among the majority capacity to grasp significance of the global and personal health disaster - **police officer Kasabyan, with above average intellectual leadership** for overcoming collective Blindspot, caused by misfiring social brain due to submission to herd instinct. Since his team of officers got a call to the next incident, we made tentative plans to join mutual forces to help promoting fragrance free living - especially critical among ALL FIRST RESPONDERS, such as his own police team, as well as take it further, by spreading awareness throughout LA police department and setting example for the rest of the world though media coverage. Many lives could be saved by providing yet to be widely available info of health education nature to the first responders...

If any scrips were written down from the body cam videos of multiple interactions of mine with police officers and reviewed by their supervisors, they would read a few of the variations of the above text. However, although none of police officers objected these ideas of mine and some showed sincere admiration, they never would promise to help, but no single action would follow up despite the urgency of the tasks for breaking the state of paralysis in my life that was deliberately created in order to devastate already suffering beyond measure disabled music scholar...

- And, shortly after my report of **commendation for police officer Kasabyan**, contrary to the common sense, he was immediately transferred from the area by

his members of command, making evident the dangerous levels of culture of moral atrocity among its leadership - that had turned into the serious public health hazard(!)

- Furthermore (among variety of other retaliatory misconduct), **police officer Carr Sr** (still part of the command) expressed his unique understanding of “serve and protect” duty of public servant towards visible struggle of disabled music scholar, trapped into failing car, by yelling at me into his megaphone - shamelessly and bluntly: *“One day soon your car won’t start, and that will be A GREAT day!”* This was not his only expression of bias and cruel disregard of visible suffering of human being. For example, my calls and written requests for help were dismissed and He vowed to prevent me from meeting his boss Captain Seetoo, preventing to be merely connected to her secretary ... (My upcoming *Biographicals* will provide more details.) And such pathological and impermissible for public servants attitude I had to endure during several years of being stranded in the area of Malibu, forced into homeless dwelling and with no help, but persecution in response to pleas for help , culminating in the week of 7.5.25-7.14.25 of being **held hostage** by a number of eagerly conspiring ill-minded individuals, practicing the culture of incivility and moral atrocity, making evident it to be thriving as the driving force among public servants of various Malibu based agencies. There is no secret that instead of senseless hostility, they could use abandoned resources in order to help with car repairs according to common sense of their duties to serve and protect. And during this apogee of their unrestrained (!) and intentionally ruthless retaliation to MCS disability they were required to assist but failed to do so deliberately choosing uncivilized methods of retaliation.
- It is sobering to realize that the created culture of moral atrocity pulled in and forced law enforcement staff into enactment of the orders with malicious intent to cause unbearable emotional distress, instead of offering of helpful actions related to repair of broken car... While with *no personal knowledge about hidden agendas of the ring operation by the involved criminal minds*, most of police officers were personally involved into contributing to the above stated efforts of coercion and unlawful breach of confidentiality medical practice. The misuse of law enforcement in the senseless strive to influence with the teamwork of all cronies the production of fraudulent diagnosis had the goal - to continue condoning past and future cruel violations of human rights with abuse by the power institutions IN FUTURE while engaging unsuspecting foot soldiers into LIFE ENDANGERING HARASSMENT with evident use of them as the accessories to the key criminal masterminds.
- And it manifested into the evident pathology of the author(s) of unforgivably ILLOGICAL AND SELF CONFLICTING, bluntly inflammatory for further use of deadly brutality statements of medical fraud. This “perfection” of strategy for misdirecting and abusing brutal force against catalysts of change is no less, but the public health hazard, that found resonance among biases among all above agencies

▲ Appeal for urgent ACTIONS to Risk Management Team at UCLA

Thanks in advance for urgent attention and response to this pressing matter of restraining concerted assault on my health and my safety and on my good causes with global impacts, supported by a number of celebrities.

This statement constitutes my urgent request to members of Risk Management Team at UCLA (originally to the Venice Family Clinic) for taking **required by law actions for prevention of the additional harm from distribution, leaks, releases, etc. of these inflammatory statements of mischaracterisation of my personality and assault on my intelligence, as well as urgent steps of mediation of the impacts from the past acts of malicious misrepresentation of my sever illness - in order to guard my patient's right for PRIVACY and CONFIDENTIALITY, due to past history of the life-threatening risks(!)** (loss of consciousness from forced fragrance exposure of the law enforcement in the position of the first responders and heart attack...

- ✎ Please provide credentials information for Ms Christina Cady, including her education license information.
- ✎ Please provide any credentials and the amount of years of experience in diagnosis and **treating MCS**, that may have allowed Ms Christina Cady to override and to mischaracterize the by expert opinion of MCS, documented by licensed medical doctor.
- ✎ Please provide info on the MD professional with license to practice medicine, who provides supervision for Ms Cady, while she had been operating in the capacity of employee of Venice family Clinic.
- ✎ Who else besides Ms. Cady can make entries under her credentials on the VFC database?
- ✎ Assign trustworthy agents who do not belong to VFC with proven record of handling private medical records. Provide their names
- ✎ Investigate any written and verbal releases of information related to the above criminal acts of intentional character assassination with medical fraud of false psychiatric diagnosis
- ✎ Seal off from distribution and destruct all records related to me directly and indirectly, and provide confirmation for this action to assist in prompt remediation of the above efforts to harm me with medical fraud
- ✎ REPORT ON THE ACTIONS OF ADMINISTRATIVE REPRIMAND for above dismissal and ridicule of my suffering from sever MCS and disregard of reputable expert's diagnosis
- ✎ REPORT TO AUTHORITIES the observed coercion acts with illegal bullying, interruption of discussion of medical issues, and demands to falsely self incriminate myself with non-existing "mental dysfunction" diagnosis, OR suffer from ILLEGAL threats of impounding my car, through illegal abuse of power, while WITH NO required accommodation TO OFFER TO HELP WITH REPAIRS OF MY CAR(!)
- ✎ How did I end up working with department that is focused on mental illness? Who did define me as "mentally dysfunctional", while contrary my colleagues praised me for above average cognitive mastery? And based on what reasons did someone redirect me from working with the team of Jimmy and Dr King to the other team, where Brianna and Nurse Cady appear to misuse psychiatric diagnosis in the routine manner? Pls provide the copies of pertaining recs.

Thus, my urgent request with the purpose of verification of performing timely DUTY to address the above caused by Ms Cady, your inept, irrational and unethical employee harm, includes (but not limited to) IMMEDIATE RESPONSE:

- 1) Production of copies of all records with any and all mentions of my name, including communications with any and all affiliated agencies, including (but not limited to) emails, typed or hand written notes, information in non written formats, still/moving images etc - to be provided to me ASAP, in accordance with CA Sunshine Ordinance
- 2) This message also serves as PATIENT'S REQUEST TO PREVENT PRIVACY AND SEAL OFF ANY WAYS FOR DISTRIBUTION IN BOTH WRITTEN AND VERBAL FORMS of any and all medical recs info in possession of Venice F Clinic.
- 3) This is the statement of revocation of prior permissions (if any?) to share in any forms and ways any medical records information within and outside of Venice Family Clinic and affiliates, as well as any government agencies, UNLESS THE EXPRESSED PERMISSION OF MINE IS GIVEN FOR SUCH PURPOSE(!)
- 4) In the case of any already shared info, related to any and all inferences to any of my distorted medical status of MCS (including with regular affiliates, such as verbal form of disclosure in the video below 📌, made evident in the discussion of the subject by the park maintenance employee Danny Delsi, captured in the evidently notorious retaliatory act of disconnecting electricity to hold me hostage with no communication means, no food, NO WHEEL CHAIR and no help with broken car, with purpose of coercion into detrimental for me subscription to harmful to my health operation), this note serves as
 - 1) request to detail pertaining info re any sharing of my health related info (including formal and informal, written and verbal, with dates, contacts, purpose, uses etc.)
 - 2) followed by the official notice of responsibility to extend the same PATIENT PRIVACY RIGHTS to those in possession of such info due to breach of privacy - with the demand for IMMEDIATE DESTRUCTION of any and all COPIES, with verification by all involved in such distribution entities, by restraining any and all methods of illegal sharing (with NO(!) EXCEPTION), including becoming privy through verbal disclosure, in addition to physical possession of printed forms of such info re any and all aspects of involved statements of malicious medical fraud.

In the **email message from 7.16.2025, the nurse Cady provided sinister and unapologetic reply to the warning about unwise actions of her misconduct along with acknowledgement of her receipt of the book "12,000 canaries can't be wrong", by author Dr Molot, with the evidence of observed by him 12000 cases of MCS (by 2014 - the time of publication). He works as official consultant with Canadian government, that presented the statement of legal warning against above described actions of retaliation to disability accommodation for MCS victims that aren't optional but required by law.)**

But despite such additional and independent source of commonly available information about MCS, she made no effort of voluntary corrections of her evidently injurious statements of deliberate mischaracterization. She demonstrated

- 1) evident paralysis of her logic and ability for sound judgment of presented for her evidence of documented by expert MCS diagnosis, revealing ineptness and loss of cognitive clarity under evident authority pressure to override medical ethics and moral standards (as in the case studies for Milgram Effect) OR
- 2) deliberate statement of distortion and medical fraud in her reflections despite the contrary (RECORDED AND WITNESSED) content of our personal exchange and reviewed by her medical diagnosis of MCS, documented by expert Dr Prescott-Sullivan and daring to dismiss and to call her exemplary expertise also "delusional", while providing cover up for the conspiracy effort of corrupt cronies from several local agencies to profit **from irrelevant and harmful for the patient impression of "treatment" - in denial and retaliation to change, that is now required by the policies for the reset of HHS, led by Secretary Robert F Kennedy.** Or both (!)

Her written derogatory statements re so called "mental dysfunction" of mine are self conflicting and revealing of sinister aim at the futile goal: To distort MCS illness of mine, to diminish its danger, to discredit and to incriminate disability, as well as to incite prejudice and provide

excusiology for past abuse and to invite more of harm and detrimental dismissal of medical necessity. It planted the unfair insult not only to me and my intelligence personally(!), but also to the opinion of licensed medical doctor with esteemed reputation and rare expertise, who documented my diagnosis of MCS, as well as to dismay professional appreciation of my colleagues, as well as to discredit the opinion of various worldwide **celebrities about both me and by extension - represented by me urgent global causes. (See below details 📌)** But such **cognitive dissonance** and evidently self conflicting and incoherent mind of a criminal in the nurse's suit, are inappropriate, injurious and dangerous especially in medical settings and may have no place in any professional settings of health and human services.

Such cover up to the earlier (2022) normalized misuse of medical credentials for promoting unnecessary use of profitable psychotropic drugs with harmful side effects, while being mindless of contrary medical necessity to assure just the opposite - the avoidance of chemical hazards and providing safe conditions for homeless populations, was illegally legalized in the past (In my case it was initiated by caseworker Richard of People's Concern). However, today the voice of people is represented by the new leadership and actions of Robert Kennedy to stop moralization and the cover up of the notorious refusal of detoxing various aspects of personal and communal and shared spaces for living, work, social interaction. And the, the related subjects of assistance with the accessibility to victims of environmental illness, are in the media focus, gaining popularity and are featured as the hot topic in great demand and is to be eagerly received by worldwide audiences, thanks to rising resonance to new initiatives for environmental justice for millions of people awakening more and more...

Individuals with impermissible aim of notorious obstruction of these long overdue new policies are the evident hazard not only for their victims, like me, but also are the barrier to healthier life of their communities, our nation of United States and humanity at large. They impede proclaimed by Secretary Robert F Kennedy objectives of HHS RESET on 4.15.2025, who **cited the terms of my presentation** in his HISTORY altering global broadcast on declaration of preventable nature of epidemic of autism. Other (following that initial presentation) initiatives of RFK JR demand to prioritize the urgency of also preventing many other environmental illnesses, caused by chemical hazards, impacting population with genetic mutations for generations ahead, bound to suffer from birth defects, including my type of immunocompromised conditions... *Initiation of preparedness for helping the rapidly increasing numbers of environmental illnesses (see below **VIDEO reflective of the mindset of Canadian government on MCS**) must be set forth, as the new priority by leadership of any and every institution, especially those involved in dealing with rehabilitation of vulnerable populations, in order to avoid unfolding of the massive humanitarian crisis.*

On 7.22.2025 Nurse Cady issued another self conflicting statement that still projected No clear statement of the inept and unspecified with any details citation of documented by my expert doctor of my MCS diagnosis. Several weeks (!) after the statement of clear instructions was critical to safeguard me from life threatening abuse by ill-minded city employees - the pressing emergency was solved with my own devices and despite all odds. But this misstatement with no clarity on MCS diagnosis (no statement of my Dr's diagnosis!) along with detailing relevant medical necessities is still misunderstood under the fraudulent diagnosis that at the same time ridicules my MCS symptoms and dismisses it as "ill-minded fantasy". This intentionally false impression in retaliation to relevant accommodations for MCS are another sinister and inept effort of deliberate harm.

Finally, the document is deliberately insufficient with medical references to MCS, but gives further ineffective for emergency situation instructions to make the calls for details. However she didn't list the phone number because such logistics are impossible to execute in the context of the clinic where Ms Cady has no personal phone line and she is often out on outdoors calls, traveling in the van most of her scheduled hours.

And the abuse of power has gone into the ugliest form of misusing the fraud by trying to engage police by the ring operators and cheats misusing fraudulent diagnosis for committing more of the hideous crimes against me... Will I be able to ever get out of this swamp?

▲ Announce in the public media institutional commitment for initiating the TASK FORCE charged with collaborative interaction of federal, state and local public authority health and governance agencies on the urgent development & manifestation of the system of legal guardianship and advocacy for relevant accommodations, specialized care and chemicals free housing for the growing number of the victims of environmental illness, such as MCS, including piloting global partnerships with medical research facilities on utilizing their rare pain-informed sensory input for identifying toxicity and making expert recommendations for the revised HEALTH AND SAFETY STANDARDS FOR RAPID DEVELOPMENT AND CREATION OF BIO-IDENTICAL MATERIALS in all parts of manufacturing, based on the relevant to
