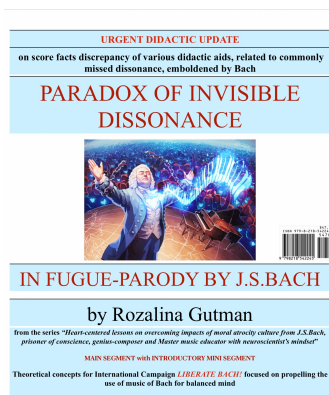

▲ PREFACE

The note about urgent manifestation of this DRAFT version of Volume 3 of *Biographicals* by Rozalina Gutman, in context of her findings of self defeat patterns and their overcoming through music-led self reflection and self growth

The idea for uncommon publication of *Biographicals* was propelled by recognition of the desperate need for sharing information of existential significance, by providing life examples for illustration of the author's findings about deeper understanding of the complex concepts of unconscious mind. And one of its key urgent purposes is ***creation of the global discourse on hardly identified subject of observed with much depth and clarity pattern of subliminal self defeat, resulting from collective Blindspot and effecting every user of evolutionary young and still misfiring human brain.*** This intellectual achievement of Rozalina Gutman allowed for the deeper understanding of the inner mechanisms of self defeat patterns. As the result, the root psychological drivers of ***the variety of self destructive behaviour*** became easier to understand and address for seemingly "unsolvable" problems, that had been earlier tackled in the case studies for the textbook classic concepts of social psychology of maladaptive conformity to the subliminal pressure from groupthink(Asch Effect), authority pressure to lower moral standards (Milgram Effect), culture of moral atrocity (Lucifer Effect),

And in turn, it allowed for this level of ***deeper grasp for the obstacles to prevention of the rapidly approaching global threat of the explosion of the suffering among vast populations from staggering rise of ENVIRONMENTAL ILLNESSES,*** commonly left unlabelled as such by medical industry. It also helped to understand the decades long lack of priority for spotlighting the data (below) on these existential for all issues and instead, hiding them from the public, at the unbearable for humanity price... Discourse on such subject had become most critical now and like never before. And it demands for ***the involvement of the top influencers - capable to set the example of prioritizing the issue over any other tasks on their just to do lists and schedules. And the force of the top media has to assure the reach of various segments of society, in order to raise awareness and build self mobilization along with raising the sense of personal commitment to begin addressing the lack of instinctive awareness of the existential problem - due to DEACTIVATION OF PAIN ALARMS TO TOXICITY, that comes down to reawakening to the actions, based on self compassion and loving care for offsprings.*** And in this context, Ms Rozalina Gutman's ability to identify these psychological drivers brought the new depth of understanding, thanks to the recently discovered by the author aspects of the subliminal mind, that had been observed as self defeat and harm of the evolutionary relics of the human brain and their mediation through music-based applications for learning the skills of self reflection and self growth. And harnessing of these transformative impacts had been tracked by brain scientists, linking them to ***joy-neurochemicals involved in Music instinct.*** Her spotlight in previous publication had been focused on the educational applications for self reflection and self growth, based on music embodiment, that provides high efficacy solutions, and yet - had been paradoxically left out from the didactic aids and from educational policy creators and curriculum designers. She observed this trend through sensory augmented data based on records and books on interpretation of Bach, realizing the discrepancies of teaching aids with the approach, used by the timeless genius and innovative teacher evidently misstated in many

textbooks¹. *One of the most concerning subjects, where her discoveries can make profound global impact, is the realm of self defeating nature of anthropogenic impacts, that are referred as the loss of the clear awareness “environmental insanity” - rightfully so, since it resembles various definitions of the medical term “insanity”, while involving various actions (or the lack of any), that contribute to self demise (and harm to others) in the realm of anthropogenic toxicity, referred as the state of essential for existence environment.*



Only most recently majority of consumers were allowed to begin to learn from investigative media about yet to be estimated dangers for their own health and for the birthright, health and life of their offsprings, caused by previously concealed from them facts about mass exposure to the illegally legalized presence of harmful toxicants in water, air, food, and likely still surprisingly for many consumers - in many common consumer goods in their dwellings, that had been impacting them. And, along with that, the subject of awareness of the resulting genetic mutation, that their children may experience, and then, pass on and on to the next generations in the forms, that we can not merely predict, began to emerge as the concern among at least some part of population, resulting in the rise

of **environmental justice attorney Robert F Kennedy Jr. to the post of Secretary of HHS²**. However, most people (sadly, including many medical professionals and researchers), are yet to recognize, that along with the avoidance of the disclosure on these harms, our society and our medical system are yet to come to the point of addressing the urgent need to face the logical consequence of the longtime institutionalized denial of the need to offer **relevant** medical care for the outcomes of this still left largely uncurbed catastrophe of environmental injuries, that isn't simple to mitigate without **the search for the relevant, but yet to be widely available means of expertise**. (And since many people remain unaware, we provide some brief information on the related subjects here for navigation.).

However, until this response to the raw pain and suffering, the previous publication/presentation by the author had not brought into the spotlight even more shocking the fact of the system, that contributed to the creation of this global problem, while it *still prevents for the incentives for overcoming it despite the urgency. It must be identified in this context*, since it results in the remaining mental inertia for innovation in the form of the entitlement to **IMPUNITY** to public servants for the crimes of harm and misconduct of mistreatment of their sponsors-taxpayers. This unconstitutional invitation to resent the change and avoid innovation, along with committing the acts of retaliatory crimes, that had been engrained into the logistics of facilitating practical aspects of all parts of our democratic state, serves as the in visible inner barrier for the incentives for the much needed rapid integration of innovations of any kind, including in the field of urgent assurance for the very survival of our human species, that is in question within just a few generations, along with the threat to the personal health... However, just the contrary need for higher accountability had been proven by the research on the so called “social brain”: Our

instinctive conformity to social influences demands for MORE SUPERVISION, but not less, when it comes to the methods of governance. And the effective methods for regulation of this aspect with compliance to well known research on conformity to authority and the related danger of creation of culture of moral atrocity are critical for the very sustainability of our human race, that had been left for long time with **no incentives for overcoming the inertia of brain plasticity that allows for habitual comfort zone** of the removed from reality bureaucrats in their cubicles in the chairs of decision makers. Such detached concern vs heart felt empathy leads to misuse of power for ruling over our lives from the position of denial of the reality for self and others. This privilege for having no incentives for being merely aware of such instinctive mental problems as self addiction to pathological mental patterns, resulting from such instinctive evolutionary relics of the human mind, as herd instinct, Fight or Flight/Fright instinct, tribal instinct, patriarchy instinct etc. had been at the core of most of humanity failures, despite the official fall of monarchy. The need to curb the abuse of power with no moral barriers to micro-aggressions with life threatening impacts on the disabled people, based on privilege for cruelty over less privileged or completely underprivileged victims of abusers, had been made visible as the key to propagating culture of moral atrocity through well documented by research rather shocking revelations from the *Stanford Prison Experiment (Lucifer Effect)*, showing the evidence on how seemingly decent people turned evil. Such demand for the compliance to its findings of all institutions is the key to addressing the hidden driver for the ongoing failure to begin at least now the long overdue campaign for tackling the indiscriminate global threat of environmental illnesses, that majority of population is yet to become aware of, as the result of the mindlessly legalized toxicity, allowed to lurk in the form of commonly used consumer goods in everyone's homes. Impermissible toxicants had been allowed to become the fabric of our life during past generations, as **their subtle impact had become hidden from the morphed to harmful concentrations sensory perception of most people, irrespective of their educational and career accomplishments, social status, cultural background - due to multigenerational global trend**. And these forces of conformity to the culture of moral atrocity are the root cause for no healthy alternatives for all, resulting in the staggering collective Blindspot of gradual habituation of the majority of population along with the loss of the sense of **the essential biological need, human right and existential top priority over any other social obligations - the fundamental conditions for healthy existence and productive living**. This collective maladaptive morphing of our social social brains had manifested unrecognized additional challenge in detecting toxicants, allowed to be at the so called **"tolerable for health" minimal amounts of permitted toxicity, that is impossible to test accurately for the forgotten by the sciences CUMULATIVE effect, and it isn't possible to replicate with accuracy in labs(!)**.

And contrary to the other threats to our health and life safety, that we perceive through existing **instinctive pain alarms** (toothache, skin burn etc), the increasing presence of many **chemical toxicants had become hard to grasp for most people, due to the elusive trend of habituation in unconscious mind - the subliminal morphing and deactivation of sensory perception under the pressure of conformity**. (It had been the key contributing factor that had been observed with stunning clarity in the classic groupthink studies for Asch Effect, forcing subjects of experiment to deny visible discrepancy in visual patterns under conformity to the groupthink pressure, due to subliminal pressure of the fear of being an outcast of the tribe.)

This awareness allows to grasp the importance for everyone to recognize the outcomes of the sobering reality as **the result of having to live in the toxic soup, leading to our lowered prioritizing capacity for avoiding toxicity, propelled by DEACTIVATED PAIN ALARMS**

TO TOXICITY. It determines self defeat in our decision making, especially when we let down our conscious awareness and healthy vigilance, due to being distracted by multitudes of other social obligations and stressors. And, this is one of the keys to understanding of **the existential significance to PRIORITIZE intellectual vigilance for practical diligence in avoidance of the products, that are proven to be harmful by the research.** However, the truth of the complexity of the challenge is that many products have no disclosure on the materials of hazardous nature, due to lacking in USA legislation of the law to require for safety proof of the products prior market entry, that is contrary in place in progressive EU and a few other countries). And intellectual accomplishments make no difference among academia members, who are as disabled in such sensory detection capacity, sharing with the rest of population this limitation of decision making by the widespread sensory disability in detection of hazards among the majority. However, this does NOT cancel the remaining cumulative effect, that had been unwisely dismissed for a while.

Luckily, in the midst of the hopelessness of the widespread spread of habituation, there is the way to continue to gain the sensory response to toxicity. Among the limited by sensory-disability majority, there ARE rare individuals with various degree of **higher than average sensitivity to toxicity**, who had NOT been effected by this maladaptive trend for various reasons. This painful and very limiting condition is called MULTIPLE CHEMICAL SENSITIVITY (MCS by). Some among “hyper-sensitives” experience **the early stage of MCS, that is commonly mislabeled as “allergy”**, that medical industry does not bother to address at its root cause. And instead, many pills sold to mitigate just the symptoms, instead of searching and mitigating for off-gassing toxicity products or/and other sources of toxicity in buildings, food, water, air etc. while large amount of profits are made from suffering. However, there are individuals that stand out from the vast population effected by “allergy” level response (although rapidly increasing, due to the rising toxicity), who have much more acute and life endangering forms of MCS and continue to possess such painful, yet invaluable for humanity gift, allowing to detect and avoid the substances, that cause cancers, birth defects and many other health calamities, proven to be linked to the cumulative effects of toxicity.

The logic and common sense demand for making all possible efforts for these individuals to be treasured by the society for this invaluable for the humankind, rare, yet painful gift and to be guarded for the reason of compassion, as well as due to being indispensable for preventing existentially dangerous Blindspots by the majority, in order to be used as the source of life-saving advise.
