In fact their involvement into this subject, especially appearance of Allen T another crony from code enforcement and Luis Flores at the medical appointment, has NO RELEVANCE at all(!). Their bogus threats about impounding of my car had NO URGENCY under the circumstances of claimed need for the potential use of paramedics at this area of FORMERLY (!) ACTIVE COMMUNAL USE OF ARENA FOR PUBLIC EVENTS. But since everyone known that these public events had been on hiatus for a number of past years, such claims of my car being “an obstacle” to anything in reality were BOGUS as well as baseless and thus - deliberately used for intentional infliction of emotional distress to already suffering beyond words victim of left with no help MCS disability - as the shocking manner of coercion into conforming to illegal demands of abandoning true diagnosis for the favor of normalized medical fraud (and related funding). Their lack of sense of sanctity for the human life was made. Visible in the videos of abuse of authority. City administration had used monitoring cameras to track the rare use of area. (Using this area for parking is common, since the arena is mostly empty. **On the image:** White truck of city council **Haylynn Conrad** parked in the red zone, who also refused to offer any advocacy despite desperate pleas for help - evident of the culture of moral atrocity with all its shocking and grotesque elements...)

And an unexpected proof for that manifested when when City Council member Haylynn Conrad came and left her car right in the same area since the arena was empty and not in use. (It had been in use just a few times per year by the small groups for the past several years while I was stranded here...

In response to false accusations *about “refusal of services”* I stated that it was a lie and explained that I was in contact with the PC agency that have the list of my many pressing needs (but they had deliberately done nothing to help me!). In response to false accusations re refusing medical help, I responded saying that contrary to such false assertions, I was waiting for the scheduled appointment with Dr King the next day (Thursday). This statement of mine I now regret, but back then I could not expect that these thugs would find the way to misuse it against me: That is how they knew to show up and intrude into my appointment and act in accord with their pals to coerce me with both threats of unlawful abuses and misleading documents into self denial of my real illness by admitting tailored for their evil agendas non-existing diagnosis of “mental dysfunction” instead.

This is of the great importance since the verbiage of fraudulent diagnosis with flawed and irrelevant descriptions, entered by Cady (beginning 2 hours PRIOR to meeting patient at appointment, present many words and expressions, cited from these bullies - instead of citing my expert MD - Dr Prescott Sullivan.

- As the result of this maddening collective dysfunction and mental paralysis, ***I WAS UNABLE TO PARTICIPATE IN ONLINE SYMPOSIUM that presented for the first time the subjects relevant for my textbook changing discoveries with global impacts(!). But these hostile and primitive minds, capable of misusing the trust for entangling into cronyism the entire machine of city hall, would only delight in being effective in derailing my efforts, as proven in the past, due to being incapable of grasping significance of global urgency for self propelled optimization of the human brain and overcoming evolutionary relics of instinctive retaliation to change with hostility - according to re-discovered by me cognitive technology of revered genius Bach, left undetected and missed in most textbooks due to tradition of political correct distortions of his legacy of Prisoner of Conscience, forced into lifelong suffering from WITCH-HUNT of character assassination by the stigma of false imprisonment, despite committing no crime. The shocking impoverishment and the lack of funds to oppose dire retaliatory human rights violations, that Bach endured, due to marginalisation of musician's profession, came at an affordable for humanity price of limiting one of the kind genius from sharing his gift for generations to come(!)... Ironically, this subject of his legacy brought shocking parallels with similarly shocking disgrace and hostility towards me, the advocate for innovation the 5th evangelist J S Bach, in using music for transformative impacts. Despite centuries overdue changes, the limited minds with no intellectual leadership,***

unfit for presiding over society's power institutions, present public health threat to communities and humanity at large. Sadly, evidently they misused routinely impunity for public servants and thus, have no incentive to evolve beyond incivilities commonly practiced in ethical violations that aren't simple to enforce. They unapologetically propell the tradition of pathological attitude towards transformative capacity of music to elevate consciousness and towards music educators with the unique gift of Consciousness Transformers - the scarce profession with now urgent ability to foster brain optimization and balanced development, in order to address self defeat consciousness that led humanity to having to face anthropogenic global threats(!) rapidly increasing, while prioritizing capacity to reflect them had been wiped out by elevated hormone disruptive impact from chemical toxicity, leading to the collective Blindspot of environmental insanity (involved mechanisms had been covered in case studies for subliminal self defeating, maladaptive conformity to groupthink (Asch Effect), authority pressure to lower moral values (Milgram Effect), subliminal pressure on seemingly nice people to conform to the culture of moral atrocity (Lucifer Effect known best as Stanford Prison Experiment)).

- **7.9.25 Wednesday** My efforts to find details of my upcoming medical appointment with Dr King brought no result - Jimmy did not respond to my text messages about the time of the appointment in time. (Then she lied re fragrance free fitness to duty of her choice of medical provider - her longtime crony Nurse Cady.)
- **7.9.25 Wednesday night:** POLICE CAME AND WOKE ME UP WITH MORE IMPOUNDMENT THREATS. City employees from code enforcement incited this infliction of emotional distress while offering no help with car repairs (!) - deliberately, unblinded effort to devastate me and to find the ways to avoid accountability for hideous acts of blunt cruelty. I explained no progress with busy mechanic, but found no compassion, criminalizing the situation as if I was able to avoid the problems of my car of my disability and the lack of cooperation of ppl charged with the duties to accommodate my disability of MCS. They gave **72 HOUR NOTICE TO IMPOUND MY CAR**, while no restorative solution was offered to help the problem instead threatening to turn the life of disabled individual into impossible to survive situation of being under the siege. **They told security to NOT open the bathroom when in pleaded about the human need to use it.** The test for moral failure is by nearing the simple question: Would they tell their sister that instead of taking care of the vital for health common practice, they'd call ambulance, AS IF such cars come with bathrooms..? This was just one example of the abhorrent human rights violations I had to endure on and on ...

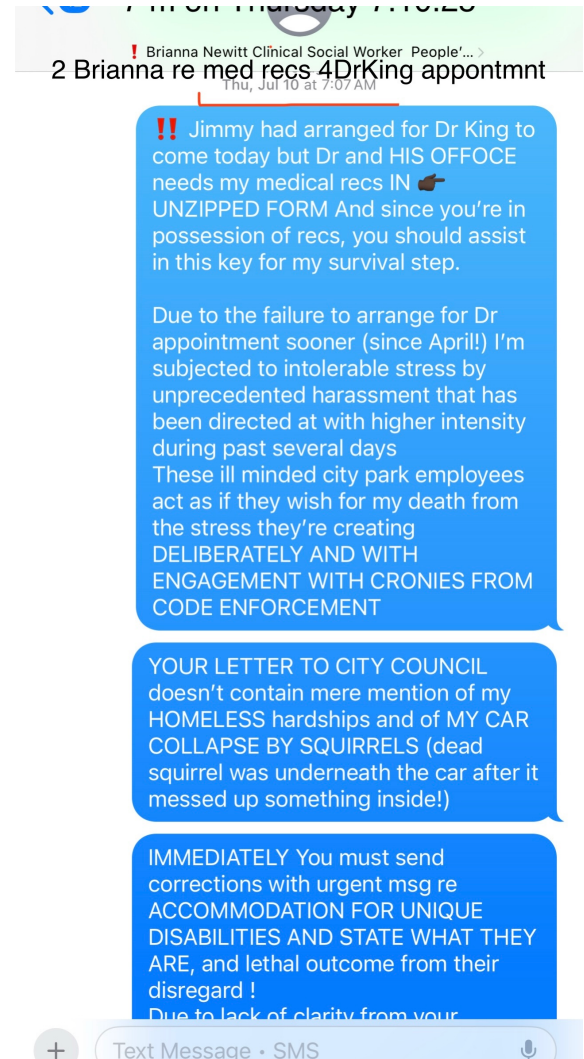
- **7.10.25 Thursday early morning** I continued to try to connect with Jimmy via texts, but no response came from him, despite his assurances earlier about arranged for me appointment with Dr King. I had to send the text message to Brianna - to ask that she assures for my medical recs to be available to Dr King - in advance of my appointment, to allow for him to become familiar with the documented by expert diagnosis. I was UNABLE to send the email to Dr King since he had no direct email for confidential medical recs info. And I was stranded on the area with no viable internet

- But... Instead of responding to my request re assisting Dr King, Brianna suddenly sent the text about bringing a different medical provider. I was skeptics and asked if the substitute is practicing fragrance free living and has awareness of the danger for MCS from exposure. She assured me that the medic would be fit for duty. (But later on when they came with Nurse Cady, I've immediately understood that Brianna LIED. Nurse Cady said she never heard of the hazards of fragrance (for ALL) And she thanked me for providing important warning and data - for the sake of own children. She sounded sincere... but I had no choice but to suffer from exposure, since I needed her urgent NOTE RE MEDICALLY NECESSARY ACCOMMODATIONS due to MY MCS DIAGNOSIS(!)

- But our appointment was interrupted by the sudden appearance of the bullies form city code enforcement and public safety, who came to harass me the day before.

- Jimmy called Brianna about them - during my medical appointment, suggesting that we go to the parking lot in order to talk to them, while nurse Cady was present. I didn't know what to make of that at first and followed the request along with Brianna and nurse. When Allen Tripolsky began pressuring the nurse to write his version of my medical diagnosis by suggesting repeated and the same as captured on the video on 7.9.25 - well-tailored to accommodate criminal scheme, bogus accusations. Now he spelled out lies to pliable nurse (falsely stating that "I must have refused shelter and hotel stay and other

"services", "forgetting" that they need to be relevant to MCS. I underscored to nurse Cady that a day prior he and Carrie Rios came to bully me and tried to deny my acute MCS diagnosis and my inability to tolerate common practice for most hotels and shelters to use fragrances, chlorinated products, other toxicants... I voiced my protest about this unlawful intrusion into my medical appointment by the individuals with their ill-minded agendas but with no medical background. But it should have been her saying that they had no right to force their presence and their demands - by committing **unlawful breach of confidentiality and patient's privacy during medical practice. But since she was welcoming them, I had to urge nurse Cady to report the unethical violation according to the medical ethics code. But, NO - instead she welcomed this intrusion and dismissed my serious concern(!) And her "clinical notes" resemble her unethical & malicious collusion with my harassers, resulting into ordered by these criminal minds MEDICAL FRAUD.** O wonder that since she gladly and eagerly produced shameless written lie, it inherited the same verbiage as on the recording of bullying from the scene of coercion they put me through on 7.9.25. She met with Luis Flores eye-to-eye, as if they were long time partners in crime, abandoning her duties of setting the ethical boundaries for the patient's life saving



needs. (And Brianna also did nothing -just contrary to her duties of facilitator - including after my repeated urging to restore medical ethics for o er month of patient and repeated explanations of the risks for such reckless act of cruel LIES for ALL INVOLVED...). At times I was in doubts whether it resulted from learning disability, OR from confidence of these seemingly nice predators in following the long time and well calculated scam pattern of ruthless ring operation of cronies. Their meeting drastic led to drastic change of the attitude of Nurse Cady towards me - instantly, from curiosity to learn from me as much as possible the precious information to protect her own children from deadly toxicants - to her expression of sinister face **expression "Get lost... No need for the inconvenient truth!"** **She didn't say out loud "No more need to exam the symptoms", but the chart is evident of her lost interest to conduct medical exam for the 1st patient's assessment, as if she didn't learn of importance of triage - fundamental for initiation of medical history of a patient. Due to such sudden shift to recklessness in her attitude towards me, I've even asked her repeatedly, several times to take notes for memory of the discussed issues before leaving, since unlike most medical professionals, she did NOT(!).** This link to ruling power of evil in the community made her feel, that she must have been absolved from the rule of professional ethics that begins with "DO NOT HARM!" and must be focused on the medical necessities to alleviate suffering, and in my case - potential lethal outcome as well. Indeed, why would exam of the patient matter, if A PATIENT'S SLAUGHTER was in the making? She knew well their internally established protocols and rules for skipping basic triage questions, critical for interpretation for real symptoms, that would be unfit for we'll-mastered terms of menacing medical fraud(!). Nurse Cady decisively turned to her car, relying to my pleas for her honesty with cold tones in her voice and sinister ill-pride expression **"I came and I saw"...** But contrary, the records of her fraud demonstrated that she had no intention use her medical visit TO SEE AND TO REFLECT IN HER NOTES of the suffering and terrible limitations of real health calamity of MCS in acute form of mine, and cite related previous medical history's details documented by EXPERT MD. Her deliberate uttering of her duty, despite the evident lack of following it revealed her cynical cruelty of **premeditated and malicious intent of misusing the trust to being a medical witness...** (also evident from what actually happened and recorded). The shocking discrepancies in her self conflicting statements under her name are so flawed, that it is hard to attribute them to be written by the same individual - revealing of lacking professional integrity and profound cognitive dissonance in captured in evident written form.). She suddenly became firm and her voice no longer projected misleading initial impression of "care", when she began to act, as if she didn't need(!) to remember any more, that our appointment was interrupted from its MEDICAL purpose. When I reminded her of that, she very reluctantly went back, revealing resentment in her body language. No, still didn't take notes according to my pleas for medical diligence and she stayed before leaving for very short time - just for appearance of reminded civility. But her now new intent was - only to continue to hammer in the same objective, stated by her cronies Luis and Allen, who came in person to remind her of her role in their ring operation: to mislead or to force the patient to SIGN THE DOCUMENTS - to make it look in records, as patient's "voluntary choice" ! Their scenario of putting incredible pressure of suffering from abuses and threats of many more(!) acts of torture were performed with perfect timing and to flawless perfection. And, i have to admit feeling enough of panic, that made me curious if somehow the selected pages from the huge set of documents could be somehow used without having to commit self harming self denial of true diagnosis. (Earlier I ve asked Brianna to provide such documentation forms, but it was refused.)But my hopes were dead wrong: the MISLEADING context of paperwork forced indirectly(!) the signee into admission of FALSE illnesses of MENTAL DYSFUNCTION, hazardous for actual illness(!), but essential for providing the harassers with the opportunity to take advantage of the suffering from crisis, vulnerable victim of the predators who also looked as if they deserved trust in their uniforms of the nurse and public servants. Due to no better choice for a person in crisis, it is not simple to be aware of such well hidden and skillful scam, as well as to refuse the conditions of stipulated on vague terms "voluntarily" submission to accompanying outcome - discredited own reputation of the person whose opinion can be dismissed or not merely heard. This highly misleading form of written documentation along with coercion allows to rip off the victim of such skilled manipulation from any further chance for the objections against misconduct and cruelty of any degree. That is what provides the feeling of being blunt (as in my case with existing real diagnosis of MCS) and being certain of taken away all chances for being trusted(!) in case of description of my true symptoms as

well as in the case of any complaints from the victims of moral atrocity. In fact, such opportunities may be automatically dismissed to the “non-credible”(!) status - coerced by pressure. Thus the funds for proper assistance and treatment of the individuals in crisis could be funneled and misappropriated on the regular basis and with **guaranteed lack of any recourse(!) for the results of the obvious malpractice.** For example, my complaints would be likely discredited, dismissed and ignored re the help with accessibility for MCS - both in the future and re promised to me for 3 months and never delivered by People’s Concern since April 2025, as well as initially refused since 2022 (!). (In April 2025 Brianna explained that **accessibility services for ppl with NO mental dysfunction (including ppl like me with MCS accessibility needs) are NOT FUNDED by City of Malibu.** But that isn’t due to the lack of funds among this affluent community, but due to lack of compassion among individuals misfit for public service jobs and acting as the walking public health hazards for all due to culture of moral atrocity created by psychopaths in disconnect with reality in authority chairs.)

- Even such rather elemental subject as clothes was avoided among many other solutions of pressing urgency - such as the senseless loss of my functional car Prius that needed additional off-gassing, but I could not find on my own any space for it, after it was shipped from another state(!) (The subject that needs special coverage for the enormity of human rights violations and cruelty malice in misusing power institutions will be available in separate volume!)

Short Video clip provides stunning evidence of collusion : Dannie takes proud(!) action to hold hostage the disabled music scholar w/no electricity, verbalizing his personal link to the scam of playing integral part in coercion into subscribing for irrelevant to my diagnosis “assistance” with so called “services for ppl with mental dysfunction” + His remarks are evident of patient-Dr confidentiality breach, revealing his hands on involvement into being among masterminds of the ordeal. Events on Thursday were developing with intense speed and recalculated precision for making sure to be effective in devastating the victim of the ring of predators, who didn’t follow their rules and broke their sinister game... **Note** Before the nurse Cady even could begin to enter details in her lies in the section of “clinical notes” with fraudulent diagnosis (that I was not aware of yet at the time), just several hours after her departure, malicious liar **Dannie Delsi working as corrupt and ill minded park maintenance employee of city of Malibu** stated that he was somehow “**entitled to turn off electricity in the isolated area of park**”... His malice to harm me had been causing much suffering for several years of the time I had to stay in this park in order to keep working on my ebook in the unprecedented conditions of hardship. But he had become emboldened in his now openly unleashed display of nasty attitude - far beyond the sense of appearance he had to maintain in the past... No, as my car collapsed both He and other cronies of his began to act with no breaks for expression of their incivility, as they gained the permission from their well trained co-conspirators to harm and devastate with no reservations my fragile health and seek to exterminate me with well propagated slanderous rumors, as excusiology for their thirst for

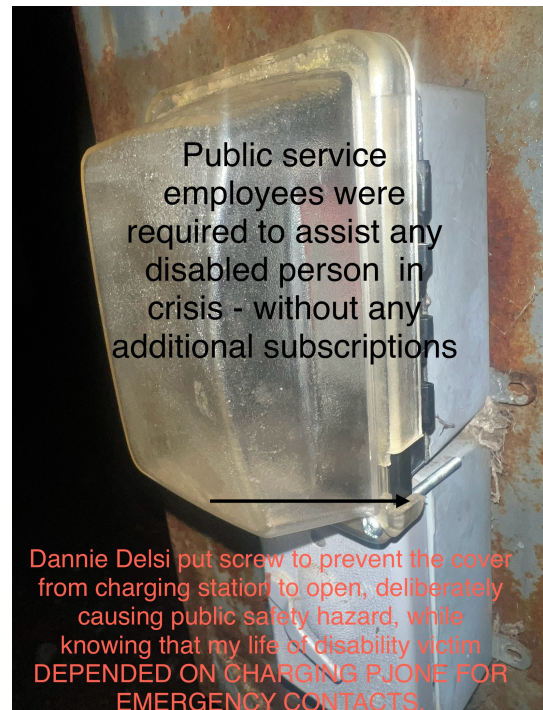

Pretending that he didn't hear me is the most immature way of solving problems and is evident of his profound cognitive dissonance about avoidance of being cognizant about the harms caused by his intentional creation of known to him public health hazard. Indeed such odd behavior of a grown up man, acting out his tantrum is no less but bizarre. This act of revenge over his lost intellectual dominance over an old frail and disabled lady with only little physical strength left to battle with bully is notorious and despicable. His proud retaliatory act based on the achieved by him with cronies help official (!) permission

from the upper management to act out any of his ill-minded outrage and get away with it was enabled by the official license in the form of fraudulent diagnosis from nurse Cady. And his confidence in his act of criminal misconduct is based on being among masterminds, that allowed to him to know of desired by him verbiage in Cady's medical fraud SEVERAL HOURS PRIOR TO ITS ENTRY INTO THE DATABASE (!) by corrupt nurse Cady(!)

My remarks in the video the logical course of action (that didn't take place) were based on the fact, that no reasonable medical professional would put their license on the line, just because of refusal for accommodations of doing some rather simple things for accommodations were refused, reveal that I could not know of such unimaginable nuisance that as deadly health hazard of fraudulent diagnosis, along with being self destructive for nurse Cady and all involved. But, this level of moral degradation has been made evident in the routine ring operation among these barbaric “reptilians” in human appearance(!)

Who and why could enable this stranger to medical field to become privy to such issues of my health, as my so called “refusal of services”?.. While this question demands for investigation, Dannie's remarks make a lot of related aspects of this collective scam to be self-explanatory: The same false verbiage is used by both him, code enforcement, police, People's Concern staff. And thus, the entries of corrupt nurse Cady were tailored to make a perfect fit to this excusiology - with criminal lack of any concern for my health and life(!) Indeed, the achieved perfection in the developed mechanism of institutionalized crime reminds of the saying “practice makes perfect” (used in reference to the need for repetition to acquire perfection of the new psychomotor skills in music studies).

However, Dannie's celebration was premature. The clear visibility of the flaws in the evil scam of targeting my life in automatic time stamps for data entry escaped the criminal minds of his cronies and led to dire miscalculation of their tuned to perfection system for smooth and profitable processing of the human lives. Indeed, the mystery in creating the false impression of anyone who crossed their path, by accusing their unsuspecting victims of so called “mental



dysfunction”, as a part of the recalculated human slaughter by slow demise with the wrong prescription of irrelevant drugs, must have been in place for a while... Of course, such unimaginable level of cruelty and the depth in the degradation of ethics would be hard to suspect among seemingly nice looking individuals. And their use of official uniforms plays the important part in their success in pulling this off with predictable certainty, based on the common collective Blindspot of public trust, extended automatically and instinctively by most people to representatives of government and official organizations (such as clinics).

This phenomenon of instinctive subliminal conformity of our social minds capable to effect public opinion is the key reason why such indisputable evidence of notorious and ongoing crimes was MISSED (!) in plain sight and left unnoticed, leaving every observer bewildered as well as disgusted and frightened by the ease of loosing elemental human rights, due to crossing paths with such predators, that thrive in the shadows and dwell, thanks to the invitation to be above the law, generously provided by IMPUNITY for the public servants of any ranks (including giving upper hand to the limited minds in the uniform of a park ranger and maintenance expert over internationally recognised scholar - all enabled by the unknown to majority clauses of unconstitutional(!) and yet normalized and currently effective laws... putting at risk every single citizen, being unaware of legalized manner of taking away their fundamental human rights.

- Indeed, I had refused to submit to the pressure to the criminal insistence on my so called “voluntary subscription” to my own disregard of my pressing health needs, by admitting the false and NONEXISTENT “mental dysfunction “ diagnosis, that had been documented as very dangerous by my expert MD Dr Prescott-Sullivan. It would officially permit further uses of deliberate endangerment of my health by dangerously irrelevant methods of handling my actual symptoms, THAT NURSE CADY CASUALLY SKIPPED IN TRIAGE SECTION OF HER PERSONAL NOTES. But merciless efforts to disparage my character, disabling me from getting any kind of urgent and relevant help and providing criminal cover up for unlawful refusals of medically necessary accommodations for my severe life threatening case of MCS disability is evident of the fact that she is either ILLITERATE or UNWILLING TO READ AND COMPREHEND THE RECORDS OF MY DOCUMENTED MCS DIAGNOSIS.
 - Sinister abuser Dannie helped making all of the above crystal clear, while this limited minds didn’t have to say and do much to throw the wrench into his own creation of the mechanism for excusiology for the human slaughter. His revealed integral part of the team of cronies, involved into the unlawful breach of patient-Dr confidentiality and privacy agreement provided the key to understanding of cronies’ covert operation. And his “matter of fact” statement of being “informed” of my so called “refusal of assistance” at my medical appointment (!) at the time of **two hours ahead of entry of the “clinical notes” of blunt medical fraud by conspiring nurse Cady** is the critical evidence of such blunt violation of patient’s rights...
 - Creation of the days-long stress of coercion pressure by causing torturous suffering by Dannie Delsi (after he failed in many ways to offer accommodations for my suffering, while I had been struggling to write my ebook on textbook changing discoveries in the park he had been mismanaging, could not work alone in this scam of targeting my life (that I came close to loose, if the car would be irreparable). He was joined by his cronies, threatening with many more life threatening power abuses, in order to force me into signing the docs, that skillfully misled(!) into admission of non-existing “mental dysfunction” with pressure and threats to impound my car otherwise (illegally), along with refused accessibility accommodations, demands to be addressed as the notorious and illegal scam routine. With the rapid rise of environmental illnesses epidemic caused by uncurbed by laws normality for toxicants’ inclusion into many consumer goods, such fate of cruel persecution instead of medical care is currently permitted to materialize for the vast numbers of unsuspecting citizens, who currently have no protection to avoid the same outrage - indiscriminate of their educational and career accomplishments...

7.10.25 Thursday evening - after painful long walk to get to the area with reception for internet I went to the electronic board for VFC and I ...gaspd ...when I found my newly created recs from the medical appointment that I was so hopeful about. It seemed that someone else but NOT nurse Cady wrote the contents of the shamelessly false and deliberately FRAUDULENT MEDICAL DIAGNOSIS - AS IF that person never spoke with me and never saw my actual

documented by expert MD MCS DIAGNOSIS. This was indeed moment of surreal sense of hopeless lunacy of criminal minds acting with unprecedented emboldened entitlement to commit to the death sentence their unsuspecting victim who trusted their misleading appearances... (I was glad about making recording of the proceedings that easily disprove every FALSE nasty and derogatory statements making deliberate efforts to assert bias re my so called "lack of intelligence" and so called "mental dysfunction" - while cruelly ridiculing my very painful and hard to tolerate symptoms of MCS, that were peppered with misused and abused psychiatric terms(!). These highly inflammatory statements, leading other readers who would follow them - medics, law enforcement, etc. into committing crimes and being responsible for potential lethal outcome, is no less but the expression of shocking degree of cruelty in action(!), evident of aiming at my life. The lack of citation to true and well documented diagnosis of MCS and avoidance of citations of related specified in my medical recs about potentially lethal condition of mine (including history of heart attack (!)), was revealing of bluntness and recklessness of the ring operators. I suddenly realized that I was dealing with cruel professional criminals thriving on the regular, well developed practice of conspiring together against their unsuspecting victims, whom they strip off credibility for a mere chance to object power abuses and to exercise their legal right for appealing shocking cruelty of human rights violations that I began to taste along with the threats to worsen them far more (!)

But after the initial shock from seeing the written evidence of the crime, I began examining its details one more time and began ...laughing at the easy to proof falsification, caught finally in the rotten format - making it indisputable and self explanatory: The malicious instructions for making exactly contrary actions in order to "help" improve my condition we entered in clearly premeditated manner - **2 hours PRIOR TO MEETING THE PATIENT FIRST TIME(!).**

And the observed collusion along with unlawful breach of confidentiality of medical procedure and patient's privacy was NOT reported, due to the conspiring ring operation of cronies covering for each other's misconduct and crimes(!)

• **7.11.25 Friday** Meanwhile, the day after I still had a task of trying to fix the car, since the promise for local mechanic never manifested for unknown to me reason. (Since the appeared "Good Samaritan" stopped responding to my text messages I began to worry if he got hit by a car on the way...) All the previous days since Monday my mechanic, located almost an hour away from me(!) was too busy, revolving from accumulated unfinished business due to 4th of July weekend. But finally on Friday he said he was available. Except, I had to walk somewhere despite badly swollen legs and feet to find the place to charge my phone, since the access to the charging station in the park was still deliberately prevented by wicked men Dannie and with approval of his supervisor Drew. (They didn't have any reasons to hate me, since I had nothing to do with them, except they had to come on time to open the gate for the park, when I needed to use the bathroom. And just didn't feel like doing it, since they had no need for that before I became forced to come down. It is hard to imagine that adult men would act in such immature and uncivilized manner, making various obstacles for my use of the toilet - in the most shameless and hideous manner...)

Despite the terrible bias at the church, I decided to go there since there was no other public bindings in the area with most residential housing. I went there very early and plugged in the phone into the outlet on the outside stage, but the charging was very slow... And when the hostile property manager came, he began harassing me with the leaf blower, as if there was the need for its use... It was increasingly dehumanizing but I was not surprised any more after previous incidents. When the secretary came, he didn't let me talk to her by rudely interrupting me and not allowing me to explain how urgent the situation was for me... She left indoors without knowing what brought me to beg for charging the phone. She could have taken it

inside and kept plugged, but that is not what “kind Christians” usually do at this house of prayer...

- I had nowhere to walk long distance despite the pain in swollen feet and legs to the beach where the lifeguards had headquarters. But I was there yet for one more surprise - no, the supervisor came and said that he “didn’t see any reasons to treat this as emergency”. And despite looking at y badly swollen legs and feet, he suggested that I walk several miles to the Starbucks... When police was patrolling on beach motorcycles I turned to them, but ... I was yet for one more surprise: No, they refused to call the city to report the hate crime of leaving a disabled woman stranded and without electricity for phone making impossible to make any energy contacts. It was hard to believe but both first responders agencies actually were no ashamed to pronounce such outrageously cruel refusals for such urgent help. In fact, while trying to find help from beach visitors, I was shocked yet one more time - police came to warn me(!) from distracting (!) lifeguards for no good reason(!)... I was in tears, sobbing in despair and thinking of the high numbers of suicidal deaths among my fellows with MCS disability... Indeed, such terrifying cruelty from those who are on their duty to edge the public - everywhere I went to ask for help ... was very disheartening and hopeless... If not for my pledge to deliver my discoveries with global impact, who knows where would I be as well... But I had to re-discover lost to oblivion unique toolset of Bach to help overcome such shocking cognitive dissonance that brought tangible hope for humanity to pivot from self defeat and harm of evolutionary relics of still evolving human brain...

Meanwhile, as I contacted AAA for tow service, I was on the phone for long time since operators kept transferring me to wrong places on and on and by the time I made the request it was close to noon. I was told that ETA of the truck is about an hour but instead it took three hours and since my phone was completely discharged, I was unable to call but only texted mechanic and received NO response from someone while he was away, staying late time... I was in tears since my broken car was in fire lane zone and under expiring 72 hour ticket... Although the need for “emergency use” of the area was minimal since the park was mostly empty most of the time.... But this didn’t matter for people on the mission to harass someone away. And in order to avoid the threats of impound I had to avoid human caused hostage related catastrophe: I had to use one of four tow calls for moving the car to the adjacent space for disabled cars, and then, make another order for the actual transport.

- **7.12.2025 Saturday** And finally on Saturday it happened - a week after my car arrived to be examined by mechanic. One thing that was worth waiting for this guy is his honesty. He had no space for cars in his lot and came to look at mine just where it was dropped on the street. But the fixing was simple and fast. The local mechanic could have done it easily several days prior and with no ordeal I had to live through...
- **8.1.2025** - IN ADDITION to hour long review of my med r Ed’s during the ride to my appointment, Brianna N provided physical copies of my med history with documented MCS diagnosis (three weeks after I could have died without the right diagnosis IF my car would be irreparable). But, even after receipt of it, she deleted fraud only where the time stamp revealed premeditated nature of the crime. However heart condition remained downplayed falsely stating “no angina”. And the rest of the evil verbiage of distortion remained with no changes in her clinical notes. After contacting Brianna to get the status on reporting witnessed by her misconduct of collusion in concocting the fraud with life threatening impacts through the breach of confidentiality of medical practice by city employees, I was astounded by the fact that she refused to perform her direct duties of proper facilitation of such activities. She responded with retaliatory verbiage to my request to provide copies of all related to me records in the agency, required within 10 days based on CA Sunshine law
