



• However, while these "semantic elements" of executing concerted crime effort(!) to devastate my existence provide the important evidence for the creation of culture of moral atrocity, the act of validation for such outrage of cruelty towards the disabled music scholar and author came from the least conceivable place - the medical clinic: the promptly disclosed and concocted in close partnership with city employees medical fraud to deny my documented MCS DIAGNOSIS, requiring by law for medically necessary ACCESSIBILITY ACCOMMODATIONS, provided to nurse Cqdy and facilitated by Brianna N, were based on the blunt and harmful crime of withholding documented diagnosis in my recs from MEDICAL DOCTOR, need no more additional proof. Sadly lots of suffering was involved, demonstrating self explanatory (!) fact that Delsi was fully aware of fraudulent diagnosis and begun misusing it in his wicked manner of continued coercion - several hours PRIOR to approx 5 pm - the time, when clinical notes actually appeared on the screen of VFC. And as in earlier entries, it was accompanied with time stamp - the subject of the fraudulent contents that the cruel liars were unaware of... Indeed, it is revealing of Dannie's deep and intimate personal involvement into the effort of the ring operation to discredit me in

the eyes of the public with the false portrayal of some "lunatic", in futile for its purpose, and yet cruel and harmful strive to excuse his past and future retaliatory acts towards me. And evidently, this "green light" invitation to continue and elevate the nature of harassment began to manifest in more and more ugly forms of uncurbed incivility -all made possible thanks to cronies scam to avoid justice for routine practice of conspiring in unlawful operations of hideous degree of cruelty. This crime of routinely normalized into large scale policy turned into easy to carry machinations against me - earlier living the life of normalized music education, turned easily into one of those most vulnerable people, who are challenged with disabilities for accomplishing everything. And just during Bach's time, finding legal defense for the most vulnerable among the society (!) remains the great challenge. However, my well documented case with obvious evidence serves the cause for the abatement of the rodent alike public health hazard of terrible potency to harm and kill with no recourse for the acts of brutal incivility both today and to be normalized into modus operandi in the future.

- And without notorious contributions of willingly collaborating affiliates Nurse Cady in obvious partnership with the thugs from People's Concern, working hand in hand to condone their and own hate crimes with medical fraud, it would be hard to make this appear to be "believable" to the upper management and to the public. The revealing bragging of Dennis Delsi re "the permission" to use torturous methods of harassment against me also implied, that if I were "to bite their bait"and agree to self incrimination with nonexistent mental health diagnosis, I could be "rewarded" with restored electricity by the members of the satanic cult allowed to dwell under the name "park management". Fortunately, despite getting electricity for Emergency repair of my car, I did a chance for life. However, due to systemic corruption and power abuse, even the fact that I knew that disability assistance should have been provided to me with NO CONDITIONS and NO COERCION, the cronies went on on their spree of ill-minded delight crime sickening power abuses.
- The wicked plot of false incrimination and bias to excuse the cruelty of holding me hostage effectively involved a number of conspiring individuals. For example, visible actions of **Luis Flores had no right to engage in calls Jimmy and Brianna during my medical appointment** in order to use THREATS of UNLAWFUL(!) IMPOUNDING of my car contrary to the legally allotted time to handle repairs by police, that revealed his leading role of mastermind among the local power institution, however paid by generous taxpayer donations NIT for the collective coercion campaign by the bulling gang appearance of City employees, but for solving crisis situations according to job duties of public servants. None of the decent members of the community would support such outrage, as led by Flores group for purposeful interruption and cutting short my medical appointment, misusing pressure to concoct suitable for predatory minds excusiology for allowing him and his cronies for boundless excuse to practice more of the similarly hideous acts of harm according to deliberately dismissive of life-threatening danger of my acute MCS and bluntly fraudulent diagnosis, signed with the name of Nurse Cady.
- However, her crime of leaving WITH NO MERE MENTION disabling her lies and well documented by Dr Prescott-Sullivan my MCS diagnosis is the invaluable illustration of the concerted crime that turned out to be the epitome of the exposed by RFK trend of profiteering from getting paid from medicating irrelevant environmental health conditions with drugs (And that can be LETHAL in cases like mine...). This criminal and unprofessional strive of ridiculing my Dr.'s expertise and invalidating my medically necessary life-saving MCS accommodations - in dire ethical violations, she committed eagerly, while allowing for her ineptness and ethical bankruptcy to be boldly visible through absurd and self conflicting statements. The bluntness of her left unapologetic criminal act may not be dismissed(!). Such individuals, who appear to act "kindly" while effectively misleading and covering up serious ethical violations and acts of crime are the serious PUBLIC HEALTH HAZARD, intolerable for communities and society at large. How could she forget so guickly our exchange, captured on recording?.. In fact, in the presence of Brianna N., I went into details to explain to Nurse Cady that my MCS is the result of untreated mold toxicity, while detailing the causes of very painful reaction in my personal case, due to additional toxic exposures, described by Dr Prescott-Sullivan in shared with nurse Cady medical records of mine. - How could extensive information dedicated to warning of my health struggles, that was found in my recs and verbal exchanges, was somehow "missed" by the nurse Cady? It could be possible only, if she was cognitively impaired, OR intentionally LIED, knowing of the damaging outcomes, but routinely excused through the culture of thriving corruption (!) And as the result of injurious lies by these cruel creatures with misleading smile and in the trust-promoting medical uniform of nurse and her team of cronies, I had been already subjected to many days of intolerable stress of unstoppable harassment, threats and intimidation to cause harm by illegal impound of my car - all to achieve increasing degree of deliberate infliction of emotional distress. The threats repeated on and on by several cronies were not simple to dismiss while being in my position of being held hostage by mutually coordinated strive to mislead me into submission to deliberately false and contradictory to my urgent health needs, clearly fraudulent diagnosis of NONEXISTENT "mental dysfunction". The blunt lawlessness of routine operations in such mode must have allowed for the ease of engaging in easily proven efforts to discredit and to assassinate my character and help to provide cover up for unlawful refusals of medically necessary accommodations for my severe life-threatening case of MCS disability(!) Such mode of legitimising cruel misconduct and human rights violations may have no place in medicine and public service...

- This is one example among many other shocking acts of coercion and threats during this week of being held hostage, due to ruined by rodents car and taking advantage of related additional challenges, made deliberately to try to devastate my fragile health, contrary to duty of public servants to help with disability accommodations. - Contrary to the manipulative demands for signing up for some "services" of questionable nature, implying justification for getting funding for paying to assist people in crisis like me, all this time these evil doers knew that I was NOT required to sign anything, in order to get public service assistance through dedicated programs. And when it comes to such issues as finding resources for the assistance for the emergency needs, like repairs of my car, especially the fact that it was damaged due to sinister mismanagement of the park issues, the offers for elected should have been countered volunteered immediately... And the resources for assistance with accessibility accommodations for my medical necessaries, caused by disabling MCS could be easily found since the budget of the City administration of Malibu with one of the world's most affluent population and with no desperate financial shortfall could be found for rescuing disabled music scholar and master music educator in distress, stranded in the area and disabled to project the full value of global impacts of the innovative methods of brain optimisation, originated by Bach and left unnoticed for centuries. My requests to assist me in filing complaint with the agency was left with no responses by assigned case worker Brianna Newitt. She and her higher ups decided to take advantage of my desperation after getting no assistance for three years, by conspiring to continue retaliation with cover up to earlier crimes, committed by the employees of the agency. I voiced frustration about getting no help despite promises of it after hours of repeated discussions of pressing tasks that needed accessibility assistance due to MCS that created social barriers for entry of most building due to acute painful intolerance of fragrances and other commonly normalized toxic chemicals (dry

cleaning, degreasers, fire retardants, pesticides for animal control etc that normal ppl don't register through pain any longer due to habituation and maladaptive conformity).

One of the false accusations in "mental dysfunction" that had been cited as "the valid reasons" for MISlabelling me with bluntly derogatory references and terms had been my suffering from being subjected to being bound to antisocial appearance - due to the deliberate failure to provide decent clothes. This sinister effort of misleading the public into deliberately created bias against me is one more illustration of conspiring effort for the committed crime of harm and endangerment of health and life(!) of suffering from MCS disability MOLD. Notably, Brianna Newitt admitted failing to provide decent clothes and stated that she was to inform Ms Cady of the problem, caused by what appeared as Brianna's cruel and ill-minded supervisors, who disallowed her to provide critical and urgent help for several past months deliberately and in dire violation of own agency's rules, requiring no signatures of any kind. are contrary to recording(!) and in conflict with the mention of MCS in the medical records (as if this slanderous statement had several incompetent authors, or the one with serious cognitive impairment, or combination of both..?)

Due to the fact of written statements of MALICIOUS MEDICAL FRAUD signed with the name of nurse Cady, they carry very harmful impact of justification, incitement and setting the example of cruel mistreatment by others, **inciting avoidance of medically necessary**, **life saving**(!!)

accommodations for my sever case of MCS. Blunt conspiring efforts with NO RESPONSIBILITY for cruel harm manifested as soon as couple of hours after Ms Cady chose to mingle with city employees, who came to interrupt(!) my medical appointment in the midst of it with their UNLAWFUL (!) and irrelevant to my health threats of illegal impounding of my car, serving as my only shelter.

Indeed, it was rather astonishing to observe Ms Cady welcoming with obedient smile, greeting familiar to her blunt intruders into medical appointment, who came to lie and bully me with the false and illegal threats, while in the uniform of city administration. This unethical attitude was evident of her immoral complicity to the cruel Blindspot, caused by conformity to authority pressure (Milgram Effect) and social influence of culture of moral atrocity (Lucifer Effect), that numbed down her vigilance to unlawful demands from authority figures, despite my vocal pleas and warnings to resist the pressure to lower her moral standards - harmful and most impermissible in medicine! And her direct benefits from breach of patient-Dr confidentiality of practice and privacy were part of belonging to the normalized culture of moral atrocity (Lucifer Effect) made her deaf to my urging calls to report unlawful breach of confidentiality of medical practice along with coercion and threats, despite the duty to do so on her own. Her failure to call off blunt pressure and illegal threats to her patient demanded for her firm adherence to medical ethics, but instead she was gleefully open to their attempts to influence her into convenient for them medical fraud. Orders from men in uniform made her forget my actual life threatening medical needs... Signed by Her written statements are evident of her irrational and yet habitual complicity to routine distortion of patient's medical needs. It didn't take much effort among cronies working hand in hand to numb down the sacred for all medics duty to cause NO HARM(!). And even voiced by me complaints for caused by her fragrance, increasing chest pressure and heartache escaped her attention through her glance of routine conspirator and a crony of flawed operation, based on the lack of ability to voice legal objection for trying to take advantage of the most underprivileged, suffering victim of years of persecution in addition to blunt neglect. (Her notes have no remarks on observed (!) by her angina (contrary to recording), despite her awareness of the lethal risks of such symptom(!) and NO MERE MENTION of impaired walking for long distances due to serious swelling of my legs/feet, relating from toxicity intolerance combined with chronic heart disease due to left unresolved heart attack.

In fact, instead of guarding the patient from intrusive bullying during appointment, instead of calling upon them to abstain from putting pressure on MCS. Victim, she didn't prevent for the long awaited appointment to be cut twice shorter by period liars in uniform(!). She happily teamed up with them and reinforced their message of coercion. This, false, but convenient for them, yet cruel and fraudulent diagnosis gave her senseless permission to continue to harm and to devastate health and life of MCS victim. Even without my vocal warnings, she should have never allowed for the UNETHICAL interruption and reduction of time of medical appointment in half.

However, she continued maintaining her notorious avoidance of my online message with call to report coercion acts, finally made undeniable (and captured on recording) the inter-agencies cronyism and collusion of ill-minded entities with clear conflict of interest to continue their brutal hostility against left with no access to medical necessities Victim of MCS diagnosis, stranded with no means for making car repairs to drive to destination.

Psychopathic lack of empathy and care for visibly suffering and vulnerable MCS victim along with stereotypical mindset made her fail to grasp the obvious fact listed on the website of my book and covered in a number of related radio interviews - the praise for demonstrated in my ebook ABOVE AVERAGE MENTAL CAPACITY for textbook changing discoveries - making her sickening lies to sound self incriminating of own mental dysfunction.

Indeed, my ebook is about some of the most complex music ever written in western music tradition - polyphony by Bach. And writing about related discrepancies in many didactic aids for it demanded for much of no stereotypical thinking - the challenge for anyone even in the mixups normally. But in my case it had to be written in the face of conditions of unprecedented hardships, despite all odds and in defiance of endless and senseless retaliatory

persecution for the inconvenience of disability of mine that demands for systemic changes that are actually **existential and critical for all...**

Captured by recording my discussion and mentions of my advise, implemented by world celebrities (!) should have helped anyone in the place of Ms Cady to recognize the absurdity of the imprudent, **self revealing of own cognitive flaws** scam she was invited to join. But she chose cruelty of inflammatory efforts to expose me to many more life risks and to try to portray me. Her attempt to portray me as "incoherent lunatic" is the perfect act for The Comedy of Absurd. It is laughable. But the unprecedented misuse of her medical credentials in psychiatric nursing promotes stigma against the field of mental health services. And the shocking display of ruthless incivility in the position of power over the lives of the least fortunate among the society who are at the great disadvantage to disprove such assault on reputation, health and the very sanctity of human life, is the sadistic expression of her criminal mindset...

Upon my delayed for several weeks meeting with Brianna Newitt on 07.25.25 (who did NOT show up during above weeklong hostage crisis) the additional details became clarified finally about involvement of nurse Cady into premeditated production of medical fraud - in wicked partnership with "People's Concern". While nurse Cady played the central role in intentional misrepresentation of my and her exchange (recorded), and had at least an hour to have clear grasp of the fact of the matter of uncommonly painful response to even minor exposure to toxic chemicals (such as fragrance), among other serious and life threatening symptoms, Brianna finally revealed her personal motivation in the fact of engaging nurse Cady without my prior approval - deliberate creation of fraudulent diagnosis for cover up of her agency's similar misconduct of refusing to treat me according to my true diagnosis. She was supposed to assist me in the process of informing headquarters about this dire human right violation, but despite several urgent reminders, she DID NOT (since her arrival to meet me in April).

Meanwhile, Jimmy also stopped responding to me about his coordination of the critical for my breaking away from hostage situation appointment for verification of my MCS with Dr King - a day prior to his arrangement. No response came from him re the exact time and other issues like the providing my records on MCS to Dr King in advance to his arrival. In fact, Jimmy didn't respond to me at all even on the morning of the appointment day. Jimmy tole me later that Brianna contacted him about taking over the issue. But Brianna has been very consistent in disrespect to my MCS needs and never provided me with any answer to my questions about HER reasons, why she AVOIDED (WITHOUT ADVANCED WARNING) MY SPECIFIC INSTRUCTIONS OF FORWARDING UNZIPPED FILES TO DR KING, since my OWN capacity for unzipping files was limited by being held hostage - in the area with bad reception and deliberate barrier to charging phone. This act of hers appears to be premeditated and was in alignment with previous effort of hers and her other coworkers to coerce me into admitting nonexisting and thus dangerous for my health, yet profitable for "People's Concern" agency's creation of fraudulent diagnosis, in order to drum up funding for her own and her department of mental health services financial benefits. And in her own words, she said my signatures are needed, "in order to get paid" for them. I would not mind to do whatever helps with pay of counselors, but I kept on repeating that it cannot be at the expense of my health and life- through fraudulent replacement of my true diagnosis of MCS.

Meanwhile, she also stated that during **first three months no signatures were needed** for getting help from the agency. But no helpful actions followed my detailed explanations on and and on, on several occasions of what was needed and why. I tried and tried explaining why I had to ask for assistance with several dysfunctional aspects in my life that I was unable to solve due to the need for accessibility accommodations and assistance. But no actionable response came

Her and her supervisors' normalized unapologetic lack of concern for **having (since early June 2025)** in personal possession of my true and well documented diagnosis of severe **MCS** is evident of profound lack of empathy and deficit of compassionate sense of urgency for

help during prolonged and left with no solution crisis in my life - by leaving unattended well known case of severe MCS. At this point further investigation will tell how much of her personal contribution was intentional and what in her actions was the result of pressure from her higher ups and being their accessory. But, the results of her misleading with lies actions appear as the deliberate interference with earlier scheduled appointment of mine with **Dr King** (by Jimmy) - disrespectfully and with no mere effort to find my approval had been causing yet additional devastation, that she had failed to grasp despite repeaters and in-depth explanation of harm from false approach to handling illness under fraudulent diagnosis(!). Her many ethical failures of intentional actions behind my back also included contrary to my expressed directions, unapologetic mishandling of my medical records - by withholding them from Dr. King, despite my request via text messages - while I was held in hostage situation with taken away personal capacity to use phone for communication in emergency situation. And then, she also did NOT provide them to Ms Cady - neither in the physical, nor in electronic form, that may be useful for her additional reference during writing down of her recollections from the appointment with me and from hour long reading of my MCS related records with documentation of my MCS diagnosis related to Mold toxicity. (It is unclear if Ms Cady requested for these recs from Brianna. She did NOT request them from me in her response to receiving the book by Dr Molot with his research in over 12,000 (!) cases of MCS similar to mine(!)). Brianna's choice of highly deceptive and manipulative actions of forcing me into no choice, but to have medical appointment with HER choice of medical provider, whom she could manipulate easier into following ill-minded agendas of inconsiderate liars from People's Concern, were known to her to be contrary to my pressing needs and medical necessities of my severe MCS illness. The time of three months with no mere single effort of hers to help after several in-depth discussions with me on this subject, amounting to a number of hours, led to nothing, but weeks of additional suffering from additional catastrophic impacts of her facilitation of medical fraud - with no known to me remorse, no effort to report it, no aspirations to correct the error in case of gross lack of competence, instead beginning to openly assert additional insults of both cruel and ludicrous justification of the criminal conspiring actions of retaliatory harm. Why did Brianna read records with medical opinion of my expert Dr Prescott-Sullivan and yet, brought her cronie-nurse, in order to continue coercing me into denying my real diagnosis and signing for "services" not appropriate for ppl without mental disorders, it needing URGENT ACCESSIBILITY ASSISTANCE? The answer is evident: Such acceptance of the offer of "services" for fraudulent diagnosis of mental disorder would absolve PC and City reps from any responsibility for providing accommodations for my pressing MCS needs. And that is the cruel motif for withholding my clearly spelled out medical needs by Dr Prescott-Sullivan. This inconvenient to abide by TRUTH for People's Concern, requiring them to admit the fault of EARLIER misconduct by their employees and to declare commitment to stop such medical malpractice in the future, was dismissed with increasingly blunt cruelty. In fact, I had asked Brianna to communicate this call for change of their operations policy to CEO, by helping me to file COMPLAINT while inviting him to join me in such voluntary declaration in the media - to demonstrate commitment to restoring healthy environments for American people, initiated by Robert F Kennedy. But this logical for all actions never manifested, due to ethical bankruptcy of Brianna and her coworkers, engulfed into corruption that is the evident fabric of their daily operations based on the culture of moral atrocity at the core of predatory philosophy of lacking concern for its victims' health, as in my telling and pitiful example...

These were the key reasons why Brianna engaged into deception of me - by deliberate lying about nurse Cady's "awareness of fragrance free living", that is often based on the broader awareness of the danger of fragrance and understanding why ppl with acute MCS often experience severe pain and other dangerous for health and life symptoms. Her personal knowledge of my past heart attack history (also referenced in my recs!) should have warned her against acting with no concern for life-threatening games and taking irresponsible steps of deliberately diminishing and denying such serious health threats in the flawed reference to my chronic problem of unresolved ACUTE MI. I didn't ask Brianna to take upon herself LOGIC LACKING decision to bring nurse Cady and allow her to read my records from her device, while withholding the electronic or physical copy of my MCS RELATED RECORDS that is essential for citing specific details, such as reference to the EXPERT ON MCS for questions re handling my illness - VITAL FOR PATIENT'S HEALTH AND LIFE. And her deliberate actions of trying to prevent this medical recs file on my MCS from being used by medical professionals, in order to assist in improvement of my health condition, led to lethal threat (ambulance had to be called

by police during the ordeal of hostage situation, due to severe heart malfunction symptoms. Her failure of any assistance contributed great deal to that...). She made no remarks on the fact that I was PREVENTED FROM CALLING AMBULANCE a number of times due to INCREASING CHEST PRESSURE WND HEARTACHE, while under unending emotional pressure attacks and fragrance exposures during hostage situation that she did NOT report after contributing to creating it...). Jimmy stated that based on the initiated by Brianna phone calls to him, he too acted contrary to my specific directions to share the zip file with my medical recs on DOCUMENTED MCS DIAGNOSIS with Dr King were concealed by him from me deliberately. Likely Brianna and her cronies at PC knew that would be unlikely for Dr King to allow any "arm twisting" and manipulation of him into denying of my true diagnosis of acute MCS and entering some irrelevant nonsense into database of clinic as my "NEW diagnosis" even prior to seeing me and conducting exam of my symptoms(!), as in the case of pliable to criminal culture and unapologetic for cruel scheme of malpractice nurse Cady. And according to Brianna's own words, nurse Cady had been in routine collaboration partnership with her team, that uses documentation evident of institutionalized crime of ROUTINELY concocting fraudulent diagnosis of mental dysfunction to have a normalized pattern of paid fraudulent claims of the victims of crisis like me WITHOUT SUCH MENTAL CONDITIONS and yet deserving help with crisis situations. (Brianna stated self conflicting facts: She helped other clients with accessibility accommodations, but she refused to do so for me, unless I'd submit to the fraudulent claims for "mental dysfunction", at the great price of harm to my health.). As the result of withholding of my medical records on MCS, their specific details (including Dr.'s name, medications used and the critical adverse reactions, causations of my MCS illness, among many other critical for my health issues) were left with NO reference and with NO PROPER CITATION OF MCS DIAGNOSIS and its author. This premeditated and unapologetic failure of projecting truth was the key for falsely misconstrued and irrelevant accusations of desired for alibi CONTRARY TO THE TRUTH dismissal of my acute illness of MCS with misuse of such psychiatric terms as "delusions", false causation of "anxiety" vs MOLD never mentioned once, etc.

Indeed, for this sickening and harmful aim of retaliatory false and purposefully fraudulent medical diagnosis entered at 8:30 am (to hours prior to seeing me!) my MCS records aren't necessary to be listed for reference for BENEFICIAL for my health medical treatment and assistance. And time stamps provide all the necessary evidence for navigating the criminal minds of the cruel creators of my fraudulent electronic chart at VFC. Fortunately, this key evidence is self explanatory and helping to simplify investigation for the crime of casual issuance for me DELIBERATELY FRAUDULENT DIAGNOSIS serving as my "death sentence" - while accompanying it with the smile of normalcy. But inflammatory incitement of actions to devastate me, deliberately labelling my life threatening inability to sustain intolerable for me exposures, while diminishing know from the past shocking outcomes deserves special attention. They were spelled out by nurse Cady(!) in exact wording as they were uttered by evil doers from code enforcement led by Carrie Rios, Allen Tripolsky along with Luis Flores and another in men with no name tag - all despite (!) my categorical protests for such attitude of these ppl suddenly barging in in the end of our interrupted by them medical appointment.

While being aware of my suffering from being trapped into hostage situation, neither Brianna nor Jimmy were any longer involved with me with any support relevant to the suffering from the deliberate hostage situation for a number of days, while the criminal minds immediately began to misuse the fraudulent diagnosis against me, as justification of their own crimes of hideous intent - aiming to devastate my fragile health and life... while continued coercing went on to force me into self harming submission to irrelevant to my real MCS diagnosis and harmful for me, the victim of illness "approaches" to mishandling it. And related persecution by retaliatory malpractice was the key for the scheme to look "validated" in order to dismiss any obligation for help with ANY of the solutions for the paralysis of my life that was facilitated in the deliberate manner as well. But in fact, related crisis assistance(!) from the public servants and their affiliates should not require for any subscriptions to any additional "services"...

And the involved heartless malice of knowingly exacerbating of already terrible problems in my life by the manipulative betrayal of trust during desperate circumstances is no less but evil, since its devastating impact isn't openly spelled out - deliberately(!)

These unethical efforts to justify with false excusiology the earlier deliberate misconduct of the refusals by People's Concern to address the real and pressing urgent

medical necessities of MCS ILLNESS became revealed through undeniable evidence for unstoppable, persistent and ongoing strive by hostile criminal minds, instructing through FRAUDULENT DIAGNOSIS to dismiss the expertise of my doctor ~ MCS specialist. Deliberately withheld by the duo of Nurse Cady and Brianna (!) clearly stated INTOLERANCE OF MINE TO MOST SYNTHETIC DRUGS IN WITHHELD AND LEFT WITH NO MERE REFERENCE (!) MED RECS extend their crime of medical fraud to other readers of such malicious directions to harm me and BE HELD RESPONSIBLE FOR THE ADDITIONAL CRIMES AND THEIR OUTCOMES(!)

The special note deserves the unapologetic certainty among People's Concern and eager to lie nurse Cady for being able to get paid for causing harm, while creating bias with the FALSE impression in the records of "cognitive incoherence" of their victim. It is both absurd (revealing author's incoherence and cognitive dissonance!) and it is shocking for hoping to get away with this - likely because these predators were torturing with no recourse a number of their other earlier victims. Indeed, most of people in such crisis circumstances have no ability, no resources for bring up the evident contradictory of derogatory and libellous statements of wicked individuals with smiles covering their predatory minds. The "matter of fact" routine approach to distorting the health issues of people in deep crisis could be caught with the evidence for what transpired as their daily criminal ring operation, based on taking advantage of people, usually prevented by hardship from with no means for legal defence from committed acts of malpractice for targeting human life. It is hard to think of more serious



danger than the conspiring deceptive and concealing menacing cruelty thugs with the smiles of their faces and the name tags proclaiming FALSELY their non-existing "concern" for the sacredness of human life, while planting a Blindspot of trust for their incivility committed on the behalf of all people.
