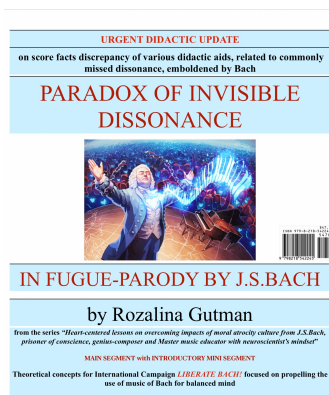

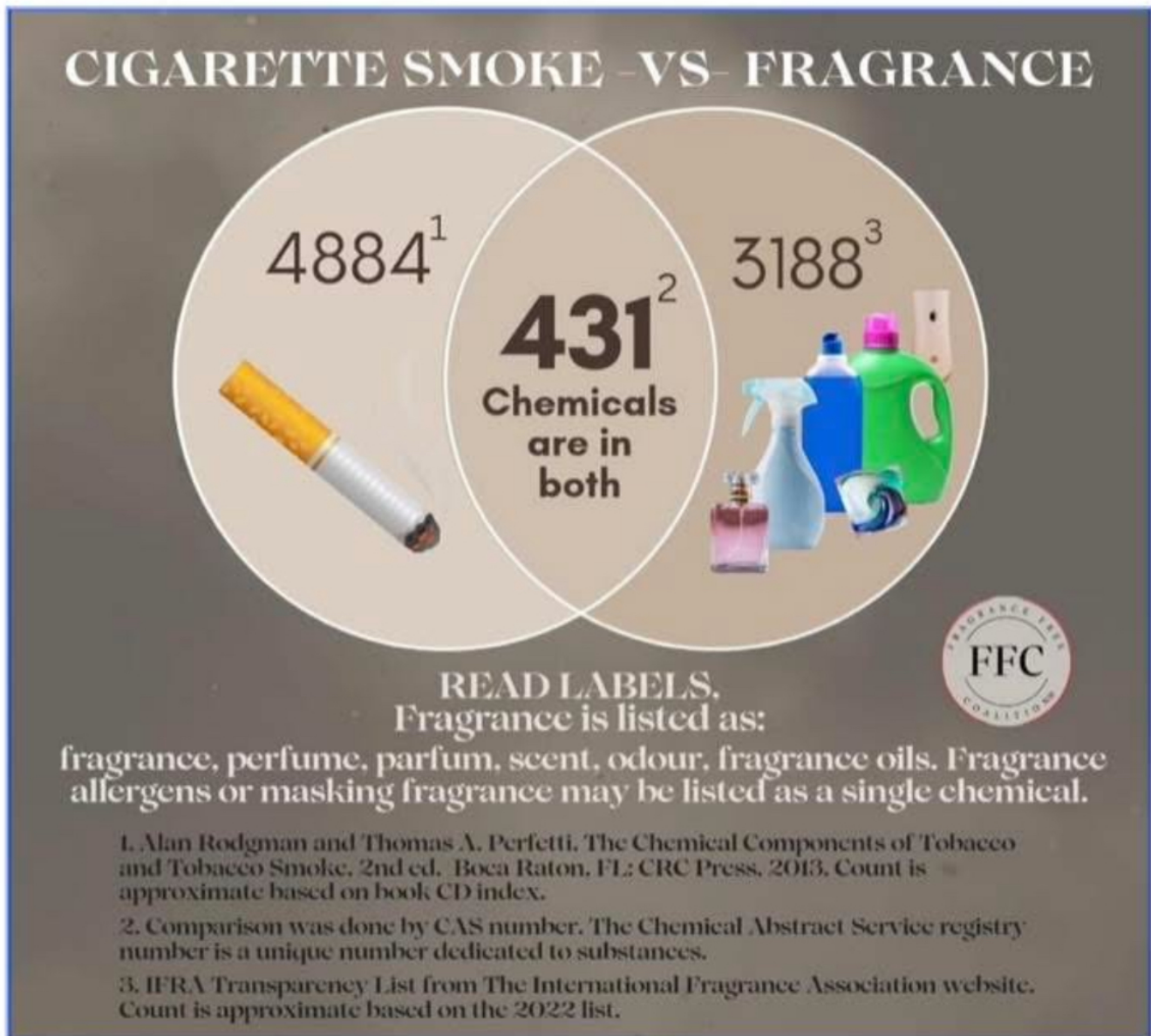

The following text contains copies of evident communications and some videos of live interactions with conspirators, who collectively aimed at devastating her health and life, while notoriously and yet routinely mistreating other vulnerable populations. This is a part of the actual appeal of Ms Rozalina Gutman for urgent solutions to address bluntly retaliatory medical diagnosis with inflammatory message to harm her - the MCS victim by misstating key symptoms of painful reactions to even minimal exposures to **fragrances & other chemicals, that should have been banned from the use by First Responders, since they are HARMFUL FOR ALL & may cause strokes, heart attacks, seizures, lung collapse**

These are mentioned below criminal minds, due to repeated active involvement (among other important masterminds in the shadows and behind the scenes):

Christina Cady (Venice Family Clinic) - employed as Physician's Assistant WITHOUT OWN LICENSE TO PRACTICE MEDICINE, inept and corrupt Nurse, who admitted to have no expertise to override expert MD, experienced in MCS illness.

Brianna Newitt (People's Concern, homeless crisis agency) - clinical social worker who met with Ms Gutman in April 2025 in order to help with accessibility accommodations for her MCS, but didn't provide even decent clothing. She suddenly interfered with planning of medical appointment with Dr King. She acted with no concern of patient and lied while bringing Nurse Cady instead, while she was unfit to duty, unqualified and thus, was NOT supposed to be involved in dealing with Ms Rozalina Gutman. But, she was forced to deal with her, due to being held hostage and unlawful threats of car impound - by city of Malibu code enforcement and public safety reps

Jimmy Gallardo (People's Concern, homeless crisis agency) - (comes with newer coworker William) - "foot soldier" for the criminal masterminds with no concern for health and life of suffering victims of MCS while in the comfort of their cubicles, making mockery on the name of their agency. Ms Gutman asked him to help obtaining her medical recs for Dr King in 2022 & texted him email of her doctor with expertise in MCS

Luis Flores (city of Malibu, public safety) - decision maker on dealing with affiliated homeless assistance agencies. Showed up to interrupt medical appointment with the aim to coerce fraudulent diagnosis personally breaching legal regulations for confidentiality of medical practice

Carrie Rios (supervisor), Allen Tripolsky + unnamed Hispanic male (city of Malibu code enforcement) - showed up for repeated acts bullying and harassment, with the aim to coerce and mislead the victim of MCS into voluntary acceptance of the fraudulent diagnosis in retaliatory ring operation for avoiding responsibility for refusals of relevant to MCS medically necessary accommodations for disability. Made false appearance of "offering help being refused by Ms Gutman". The verbiage of their misleading actions manifested in the medical recs of Venice Family Clinic in the form of FRAUDULENT DIAGNOSIS with inflammatory incitement of lethal threatening actions, JUST THE CONTRARY TO HER PRESSING URGENT NEEDS.

Dannie Delsi and Andrew Belter (Park Maintenance, city of Malibu) - involved in notorious efforts to make Ms Gutman's stay in the park intolerable, involving torturous acts of inflicting pain, misusing their knowledge of her chemical intolerances MCS during her forced stay in hostage situation - both during several past years and especially, being proactive in efforts to devastate her by making inaccessible electricity and trying to create a trap for her - to cause her car's impound(!)

Below is one of the key evident facts of medical fraud - display of the copies of records with time stamps, that clearly demonstrate the evidence of notorious violations of law and ethics, in order to absolve each other from their duties of accommodation for the medical necessities of the patient, by distorting serious life threatening diagnosis - intentionally. They reveal that the initial entry of fraudulent diagnosis was premeditated and entered ahead of the time (8:30 am) of the actual meeting of the patient (10:30 am) , providing evidence of malice of the intentional nature of the criminal act of fraud by nurse Cady in collaboration with

the involved ring of thugs with appearance of seemingly nice individuals, effectively covering their criminal intentions:

The top left copy of the message from Brianna stated the arrival time to appointment location 10:30 am. But on the segment with fraudulent diagnosis the time stamp is 8:30 am - 2 hours PRIOR to the arrival and meeting the patient for the first time(!). This is one of the evident facts of the crime of concocting fraud, irrelevant to reality. Then there are two more time stamps both around 5 pm for fraudulent clinical notes, that appear to be entered either by someone, who was not at the appointment, or by Ms Cady, who deliberately distorted the meaning of interaction with the patient, deliberately misrepresenting the actual details and general content of the discussion - in conjunction with the unlawful act of **deliberate breach of confidentiality of medical process and patient privacy, evident of collusion with other entities**, who refused to obtain diagnosis since 2022, and based on that refused to provide medical assistance, housing and assistance with accessibility personal hygiene, replacement of stolen documents, special accommodation for transportation and other medically necessary accessibility accommodations for serious life threatening illness of under-publicized nature - as described in above instructional video on accommodations for MCS. And the criminal intent of conspiring together parties is reflected and made **self evident in self conflict** in the author's statements of the fraudulent entries with each other, deliberately making only casual mention of the acute MCS - the problem of painful intolerance of chemical exposure, that is stated, but left with no detailed reference to documented MCS diagnosis, initially left with NO CITATION at all and with no attribution to the name of expert MD, along with initially missing such significant details, as the link to related ACUTE MI HOSPITALIZATION etc.). At the same time, the other notes deny and cruelly ridicule the very nature of documented acute MCS by calling it "delusional", as if the result from "psychotic imagination", thus **DELIBERATELY INCITING** any readers of this statement - care givers, 1st responders of any kind, law enforcement, other medics etc. to act IN **DELIBERATELY HARMFUL FOR PATIENT MANNER**, while being aware of causing **LETHAL THREAT(!)**, based on discussion of ACUTE MI history (that is downplayed in the history and deliberately misstated as "no (!) angina"). Contrary, **AVOIDANCE** of the mention of actual and observed by the nurse complaints for heart malfunction symptoms of chest pressure and painful sensations, in response to wearing fragrance are retaliatory covert-up for being unfit for medical duty of nurse Cady (!) and for lying about it by counselor Brianna Cady, who lied about this precaution, while making the replacement on the day of appointment of another scheduled medical provider - Dr King - due to long time partnership with Cady in similar acts of collusion and mutual coverup for medical malpractice for gaining funding for inappropriate for diagnosis applications, by **FALSELY** replacing, adding and emphasizing fraudulent concepts related to "mental dysfunction" instead(!) - while being mindless of serious adverse reactions from irrelevant medications and lack of **MEDICAL NECESSITIES - LIFE SAVING** in the case of acute MCS(!). The related false accusations against the patient in "refusing housing" are revealing of the **INTENTIONAL** coverup for affiliates' lack of mere effort to provide special accommodations of MCS-SUITABLE HOUSING - **INSTEAD OF STRESSING ITS CRITICAL NEED FOR ASSURING for AVOIDANCE OF INJURIOUS FOR PATIENT CHEMICAL EXPOSURE** in housing, temporary hygiene assistance, transportation etc. other assistance. Furthermore, under to provide mutual coverup in agency's failure to facilitate MCS-suitable and detoxed clothing - for three months in in 2025 and since 2022, the nurse misplaced false accusations against the patient, forced into suffering from being prejudiced in multiple ways from undignifying and antisocial appearance in deliberate act of creating **FALSE IMPRESSION** of patient's less common medical needs - all to advise the premeditated actions of retaliatory harm to the patient with differing

from average medical requirements. Thus various parts of the entries conflict with each other and show dangerous degree of cognitive dissonance while they come across as if they were made by several different ppl, revealing that the author Cady suffers from pathological lying in conjunction with psychopathic disability to sense compassion to caused suffering (and/or other serious mental disorders).

Additionally, while Brianna was supposed to provide my recs with documented diagnosis of MCS to the medical provider for the purpose of urgent reference related to urgent prevention of actions with potentially lethal impact of exposure, she did so, but in the limited manner - only for reading from iPad during the hourlong ride to the appointment and avoiding to send recs for further reference in either electronic or in written form. Brianna revealed in the past her department's financial interest in gaining rights for care of ppl misdiagnosed with "mental disorders" and dealing with individuals with other disabilities (like MCS), stating that the agency has "no finding" for providing accessibility accommodations. After initially She learned that I had documented diagnosis of MCS, she stated she find another agency to refer patient to another department of some other agency, but then, made misleading appearance in intending to help me anyway "as required during first three months" and misused her trust to continue misleading me about "delay" of assistance for "bureaucracy reasons". She was NOT supposed to be involved into facilitating medical appointment scheduled by other counselor for the department, that does NOT presume any additional subscription to specialized for "mental health" assistance, but nevertheless, acted to contribute to coerce me into signing misleading documents that would override my true diagnosis under pressure of potential loss of my car due to impound, unless I wound practice self defeat of denying my true urgent medical needs in favor of false "mental dysfunction" diagnosis, in order to derive lucrative pay for the agency's murky agendas, facilitated by the criminal minds of higherups bureaucrats - working in collusion with corrupt nurse. Brianna's choice of nurse Cady was based on their ongoing cronyism-relationship, and they consistently cover up for each other's misconduct. Thus the actions of Brianna to prevent for my initially scheduled appointment with Dr King appears deliberately premeditated and with NO patient's approval for downgrading it from licensed MD known to practice NO FRAGRANCE (!) lifestyle and with relevant familiarity to its general danger for all, helpful to making sense of ACUTE case of allergic response to it and other chemicals - see EVIDENT copies of related communications and details (below section). NOTE: Special section was added recently to provide evidence of hopeless malice in the actions of involved parties to deepen deceit, with shocking cruelty of intentional retaliatory LETHAL HARM - by concocting **deceptive** records on **underpublicized immunocompromised condition of mold-related MCS**, counting on the lack of familiarity with it of most medics and the public. After delayed for 3 weeks upload of MCS documentation recs, following my demonstrated evidence (that would have resulted in lethal outcome by then, if my car would be irreparable), inflammatory of violence fraud was NOT replaced with truth. It continues ridiculing urgent MCS medical necessity for avoiding exposures to chemical hazards - no matter how "small" their amounts may be and instead invites for the contrary actions(!)

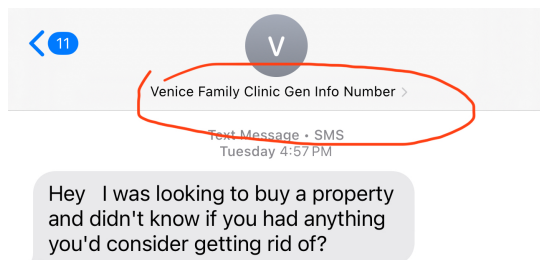

Systemic patient privacy violations at every level in Venice Family Clinic (VFC)



In the face of the urgent need for guardianship from the deeply flawed and conspiring together perpetrators of serious crimes including unapologetic and thus malicious and retaliatory medical fraud, targeting my health and life, and involving employees of VFC in the role of key enablers of the flawed and yet very misleading and thus, giving intentional instructions to harm and devastate me, I wished to convey immediately and directly these issues of suffering from manifesting into more and more health and life threats. *But in*

*addition, I found **no ways for direct and confidential communication** re complaint resolution, involving **CONFIDENTIAL CONTENT OF MEDICAL ISSUES.***

Furthermore, shortly after contacting your clinic's Venice location to request medical recs I've received this text message from the main number for the clinic, offering me some shady RE services. I spoke with Records Dept rep and supervisor. While they are likely the primary suspects of already misusing my private info, your duty is to engage reputable independent cyber security for conducting thorough and urgent investigation, by tracking employees' visits to my files, without my asking for any specific questions for needing to look up my chart. You need to present evidence about who became privy to my private patient's info displayed, by misusing their access to what may be sensitive issues. You have to notify all users and employees of the problem had been exposing their personal information as well while eroding the trust and making impossible to deal with your clinic in the safe ways, unless law and order are restored and commitment to medical ethics is reaffirmed among the new employees who would replace those frauds, manipulators and other types of walking public health hazards.

That is one of the reason, why I demand for any and all of my information to be destroyed & sealed off from any access by any employees/affiliated of VFC. Additionally, there is no reason for any of my records to exist in VFC, due to the evident intent for shameless and abhorrent medical fraud in my diagnosis, in retaliation to

proper citation of my MCS DIAGNOSIS & related accommodations of my disability-caused medically necessary accessibility assistance, refused since summer 2022.

👉 **This list of evident info demands for the urgent restraint of any employees of VFC and their immediate affiliates,** caught in the evident, **deliberate and malicious hate crimes of premeditated breach of confidentiality and privacy of medical practice in conspiring effort to concoct medical fraud, while using coercion** for misleading me into subscribing to irrelevant to my health fraudulent diagnosis, with known harmful outcomes, while refusing to obtain my **MCS diagnosis (since 2022** - by Richard People's Concern and Dr. King and Dr. Ryan). And lately, retaliatory refusals to my pleas and calls to restore medical ethics to finding suitable solutions for disability accommodation suddenly manifested into dangerous for health and life medical fraud in medical diagnosis, along with threatening for my chemical safety ridicule and mischaracterization of MCS symptoms, initially in manipulative and deliberate refusals to cite its records of documentation provided by earlier provider - the expert in the immunocompromised conditions, despite being in possession of it since **June 2025** (by Brianna Newitt, rep of "People's Concern" - facilitator of medical appointment for crisis solutions). Then, since **July 10, 2025, when Ms Cady of VFC** became familiar with the content during hourlong drive - through reading of files offered by Brianna (when Dr. King was supposed to come), as well as the latest Cady's notorious avoidance of using finally scanned by her recs on **August 1, 2025(!) - providing self conflicting account of my illness.** She provided instructions of deliberate health and life endangerment in the future and excusiology for the last notorious criminal misconduct of leaving with no correct medical fraud. She attempted to further mislead and create false represent of my symptoms of illness and disability.

Thus, I request for IMMEDIATE (!) production of copies of existing records, followed by seal off from any release, distribution or sharing during investigation and providing recs re investigation results, followed by the proof of destruction of any and all records related to me, including revocation of any and all signed by me in the past permission(s) (if any?) to share any and all information among the clinic's personnel and/or with any outside affiliates or government agencies in both electronic, written and verbal forms, further contributing to intentional injurious character assassination, with inflammatory intend of biased misuse of other agencies to provoke the actions, that would intentionally expose me to potentially lethal outcomes, in deliberate contradiction to my medical necessities that should contrary provide the urgent warning for taking measures for

providing isolation from even minimal impacts of toxic chemical residue (including fragranced products of personal hygiene of first responders, among other normalized environmental hazards.

Below evidence for **the breach of patient-doctor confidentiality and privacy rights, with deliberate aim to concoct the records of NOTORIOUS MEDICAL FRAUD with retaliatory and malicious intent for harm and devastation** is the additional element to the other revealing components of the crime (additional details for the effort to falsely incriminate me and to subject to additional hate crime are available upon request as well.)

[NOTE: Initially this complaint was addressed To DR MITESH POTAT, the interim medical director and CEO of Venice Family Clinic or VFC, affiliated with UCLA. But breach of privacy violation by personnel prevented me from engaging any more personnel into related affairs]

!! Important navigation points to know for grasping multitude of systemic and deeply rooted degradation of employees' morale:

1. If a patient with heart attack would be taken to the appendicitis surgery, DESPITE STATED CORRECT DIAGNOSIS, with no rational explanation for such act, such deliberate act would be classified as a notorious hate crime. And the medics who would commit such outrage, would be banned from misusing their professional license for prevention of additional invention harm or cruel malpractice. And since there is no difference in deliberate denial 1) to obtain and then 2) to cite my documented **Multiple Chemical Sensitivity or MCS** diagnosis, followed by 3) replacement of it with the notorious dismissal of the documented serious symptoms,'while misusing the terms of psychiatry, in retaliation to the obligation to address with accommodations the medical necessities of my disability, the same swift measures must be taken towards everyone, involved into conspiring to cause harm and to fail to report it. Such cruelty of DELIBERATE avoidance of my MCS DIAGNOSIS, resulting form Mold exposure and bio-toxicity with strong immunocompromising effects had been documented by the experienced in the field **expert Dr Prescott-Sullivan**. Thus, the outrageous replacement of it by inept nurse with FALSE, nonexistent and irrelevant diagnosis of "mental dysfunction" in order to justify the lack of accommodation for MCS, while using the same verbiage that had been captured in the scenes of harassment by code enforcement reps Carrie Rios and Allen Tripolsky, and the demands from the group led by Luis Flores, that barged into appointment and interrupted it, are evident of the motifs for the notorious medical fraud with known to lead to harm impacts.
2. The key complaint - **MEDICAL FRAUD with retaliatory intent of harmful misconduct with deliberately inflammatory verbiage to incite potentially lethal threat of forced exposure to fragrant personal hygiene products, worn by law enforcement that are medically necessary for MCS to avoid**. Also this fraud involving deliberate avoidance of mere citation to my TRUE DIAGNOSIS OF MCS, documented by expert, and HER NAME FOR ADDITIONAL REFERENCE, reflected in evident acts of falsification in VFC database medical records, along with coercion of patient to sign misleading documents that would constitute appearing to be "voluntary" submission of the victim to the fraudulent diagnosis and related harms. (The assault on MCS victim involved other crimes, including efforts of false

incrimination, involving community members into deliberate hate crimes, and campaign for character assassination

3. This notorious crime was committed as the result of the ring operation of conspiring affiliates from local agencies and signed with name of VFC employee nurse Cady. This is abhorrent retaliation to accommodate accessibility needs for my MCS in various ways, in violation of my fundamental human rights. The fraudulent diagnosis (entered several hours prior to mere meeting the patient(!) and clinical notes ridiculed my severe case of intolerance of even minor chemical exposure as "delusional", "imagined as the result of anxiety" along with other irrelevant references of with deliberate derogatory intent for my misconstrued intelligence, in order to discredit intentionally my reputation and credibility of the author, multidisciplinary scholar in BRAIN/MUSIC field, concert pianist and internationally recognized music educator and presenter at world conferences(!)
4. The fraudulent clinical notes continue to reference potential and implied threats of misusing force towards me, despite knowing, that currently - **due to the lack of the official ban on dangerous fragrance use by First**

Responders, such interactions for

me can be deadly (Ms Cady deliberately diminished my history of Acute MI with 5 days of hospitalization in ICU in 2010, as well as more recent episodes described to nurse at the visit that involved lost of consciousness due to the exposure to fragranced products of law enforcement.)

5. The subject of medical fraud necessary to retaliated to accessibility accommodations for my MCE. has the three yearlong history of notorious refusals of obtaining my MCS diagnosis and prejudicing me from any crisis-assistance by responsible for that agencies, while subjecting to active persecution with misuse of various conspiring law enforcement agencies (in fact, involving top judicial officers of the Justice system into witch-hunt style, unlawful and unconstitutional practices with the notorious intent of harm and incrimination of life threatening disability.

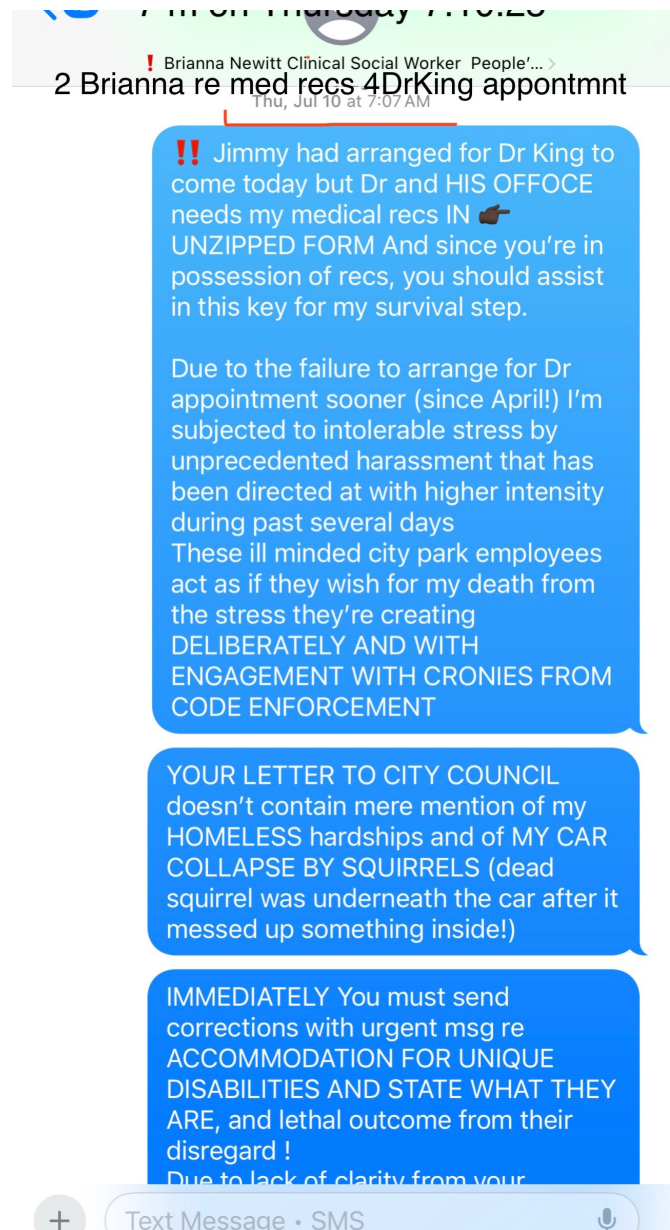
court into judicial misconduct, including witch-hunt style, shocking violation of constitutional and human rights for the right to ask the court to provide evidence for FALSE accusations are in separate Volume.) **Since April 2025, since** my first meeting with Brianna Newitt, she avoided and failed to assist me with request to file complaints with PC headquarters re the list of these and other similar events, since they originated with the most odd response to my pleas to Dr King (VFC) and Richard (People's Concern) to obtain my medical recs with documentation for my MCS diagnosis by the expert in this field. **Instead, (in 2022)** psychiatrist **Dr. Ryan** (VFC) without patient exam began suggesting, that I begin taking psychotropic drugs - irrelevant and dangerous for my illness of MCS, while ridiculing it openly in public - in front of serving food volunteers. But, **he too refused to obtain the recs re my real MCS illness, dismissing the fact that it was caused by mold toxicity, despite commonality of the problem for this humid area.** This retaliatory act to duty to accommodate MCS was deliberate for causing devastating distress to me and for creating cruel excusiology for own betrayal of medical duties... This prompted me in **Sept 2022 to write to the team member Jimmy Gallardo (PC) (see the date on the copy)** while asking to help with communication with medics on the pressing issues. But this didn't make any difference in changing the bias as well... However, not only I got no help, but instead, these interactions were linked to misuse of my information, in order to promote false stigma of the nonexistent mental dysfunction among Good Samaritans in the community- including by police and city personnel that became evident later - during unprecedented act of unfair harassment in winter 2025 (see details below)

6. This and similar acts of public ridicule led to the very damaging in my case bias among community members, assisting other ppl with crisis solutions, but prejudicing me. This damaging stigma promoted unfair distrust and injurious for my reputation prejudice throughout the small community, discouraging Good Samaritans from engaging with me after initially offering help in distress.
7. In the beginning of **June 2025** after long delay from April 2025, Brianna Newitt of People's Concern accepted and since then, had in possession the zip file with my medic records from Dr Prescott-Sullivan including documented by her DIAGNOSIS of MCS. But, instead of applying them for addressing the pertinent problem, after many hours of discussing various aspects of suffering from it, and after discussing the related data, no action had been taken to provide ANY assistance with the urgent demands of life threatening illness, while making an impression of trying to address it in misleading communications. (+ No report of earlier MEDICAL FRAUD and prejudice from medical care and **relevant medically necessary** services (committed in 2022) had been made, despite repeated reminders of such duty.)
8. Current entries of **self contradictory and self evident** of malicious fraud statements contain SELF EXCLUDING STATEMENTS and are in blunt conflict with reality - misconduct of citing false statements from city code enforcement by nurse Cady, committed as the result of breach of confidentiality of medical practice and privacy (while in conjunction with the actions of Brianna Newitt, other failing to report illegal act during medical appointment). These fraudulent slurs are **also in conflict with the recording I made for the patient's review and reference of medical advice.** Later correspondence with nurse Cady proved her intentional, direct, and PERSONAL involvement in the criminal act of deliberate avoidance of utilizing lifesaving documented medical diagnosis of my acute state of MCS illness, DESPITE becoming in possession of the medical data about reviewed similar

12,000+ cases of MCS in the mailed (by me) to her office **book by Dr Molot(!)**. Furthermore, she admitted the lack of her personal expertise in the subject of related info on the danger of fragrance of human health (recorded), and yet, her efforts of active misinformation involved OVERRIDING of the expert opinion and proving unapologetic cover up for earlier medical fraud by her cronies, revealing cruel lack of any concern for the harmful outcomes of their suffering victim(!). The sinister tone of her response to my protest of her unlawful actions are evident of her the likely systemic misuse of the fraudulent medical diagnosing, due to effective written form of misleading strategies for getting away from being held responsible for the outrage of retaliatory misuse of FALSE psychiatric diagnosis against the victims in crisis, by taking advantage of individuals already vulnerable and desperate for urgent help by predatory minds.

9. In the act of denial of documented diagnosis of MCS, she committed breach of confidentiality and privacy of handling medical appointments contrary to medical ethics protocols, and her refusal to document intrusion of city of Malibu employees and their acts of coercion are evident of their routine cronyism and ongoing conspiring cover up for each other, in committing serious violations with intentional harm to vulnerable disabled victims of unapologetic acts of malice, involving coercion into appearing to be “voluntary” subscription to “mental services” of their victim with nonexistent “mental dysfunction”. This allows for discrediting complaints and for excusiology for the ruthless acts in the past and for absolving of duties for assistance in the present and the future.

10. From phone communication in late **June 2025 with highly uncaring and dismissive of my MCS diagnosis supervisor Freeland Colby** (unsure of spelling?) of People’s Concern it became clear, that the the agency does not provide crisis assistance unless the ppl like me falsely call themselves “mentally dysfunctional”. It I loved dire misuse of positive agency’s name as a part of mockery on its meaning. And the documents of the agency proved that its executives had been using it as the clever coverup - by gaining public and personal trust, while misusing it with the routine and notorious criminal intent: People in crisis and desperate for help with life -threatening illnesses would not be provided some handouts of elemental services, except only upon their coerced submission



to own admission of nonexistent “mental disorder” that isn’t spelled out with clarity and hard to grasp. That is why, due to my refusal to submit to hideous demands upon me to commit this potentially deadly for me medical fraud (irrelevant to my MCS), I was refused any help from both People’s Concern, city of Malibu, police reps, responsible for crisis assistance, who linked to this coercion their worsening of retaliation. The media was used for intentionally misleading into hate crimes the community I fear of joining opposition by ppl with above average affluence and presence of many influential catalysts of environmental activism and other progressive causes(!). Even the church that had been involved with helping homeless populations refused any help, even including receiving medication in the mail and other important documents for restoring functionality, lost due to suffering from multitude of crimes and systemic injustice. (See more on hate crime cheered by church members.)

11. Predatory minds demonstrated in evident actions, that they had been playing a part of the long term ring operation with misleading front and officially looking documents and policies for manipulating vulnerable victims, involving into notorious scam unsuspecting individuals, as a part of consistent culture of moral atrocity. The involved individuals in practicing routine and normalized crimes demonstrated entitlement for perpetuating the unlawful acts of premeditated, notorious and malicious misconduct, while being excused by MEDICAL FRAUD with injurious impact of severe harm, that served as deliberate ill-minded **exclusiology for torturous practices in perpetual, blunt and dire violation of human rights of people for whom legal defense would be likely insurmountable, due to known financial vulnerabilities and disadvantages for providing similarly solid evidence, as I managed to present - however at enormous personal sacrifice and limitations to global causes, unaffordable for humanity.** (These involved agencies demonstrated their disability to function without independent oversight.). Community members and org had been misled into witch-hunt like collective hate crimes against disabled scholar(!)
12. Hostile thugs enjoyed making impossible for me to join online international symposium on 07.09.25 (!) - also courtesy of ring operation, involving nurse Cady, consistently giving her “license” to harm the victim of crisis, despite documented diagnosis of MCS, that she ridiculed and dismissed as “delusional”, caused by “anxiety”, along with other mischaracterizations. And that was instantly turned into the weapon of harm and character assassination ... manifesting into the unspeakable OUTRAGE OF DELIBERATELY CREATED HOSTAGE SITUATION, implemented by the unfit to public service Dannie Delsi (city park maintenance), who was deliberately encouraged and was left unrestrained by biased Drew/ Andrew Belter and their upper city management, refusing to interfere with their cruel lunacy (among other incivilities 🙄)

Shameless acts to facilitate profiteering from suffering of the most vulnerable members of the society. But today, in light of reset of HHS, declared by visionary advocate for environmental justice Robert F Kennedy and his team of holistic medical providers, this notorious act is in blunt discontent and disregard of the overdue, concerted and existential for humanity effort for overcoming of the legacy of corruption in the medical/ scientific field, that resulted in leaving for decades with no official declaration of documented with data pandemic of environmental illnesses. Instead, millions of people paid with their and loved ones’ lives for falsely left UNLABELLED AS ENVIRONMENTAL ILLNESS and PREVENTABLE health calamities, caused by legalized chemical hazards(!),

including profitable misuse of drugs with known serious side effects, that were irrelevant to patients' health - as in my personal case(!).

And to speed up the process of regaining sobriety from festering culture of moral atrocity revolving around environmental insanity (as observed among reps of the city of Malibu administration, VFC and PC), I call upon leadership of all public health agencies, medical institutions and public service organizations to make commitment for pioneering the alternative exemplary steps to prevent systemic root causes for deliberate suffering of mine along with compromising my important global causes:

MAKE JOINT MEDIA-COVERED APPEARANCE FOR ANNOUNCEMENTS OF OVERDUE COMMITMENT TO JOIN ME AND OTHER MCS VICTIMS IN OUR DAILY PLIGHT OF FIGHTING FOR THE MERE SURVIVAL IN RIDDEN BY HARMFUL FOR ALL TOXICITY WITH NO ELEMENTAL MEANS FOR LOWERED TOLERANCE TO NORMALIZED TOXICANTS, MAKING INACCESSIBLE TO MCS VICTIMS MOST PUBLIC SPACES (even including ridden by FRAGRANCE/CHLORINE BATHROOMS!)

Civility of the society is measured by how the most powerful treat the weakest.

Professionals of relevant expertise, who would join the righteous fight to safeguard victims of MCS, will lead the work in the hand-in-hand collaboration with MCS medical experts in the field of

environmental justice of global prominence and volunteers.

Their forward looking intellectual leadership on the battlefield for physical and mental health of millions of people will be written into the history for fighting against the rapidly growing global threat with indiscriminate impact to the efforts of bringing closer to the time, when the society would be free from living in agony of suffering from anthropogenic environmental toxins for assuring better future for generations to come.



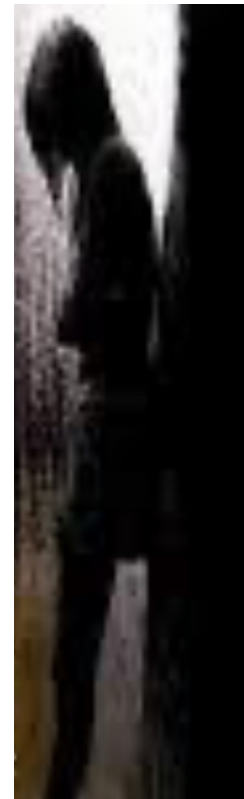
▲ RETALIATORY ENTRY OF FRAUDULENT DIAGNOSIS - 2 HOURS PRIOR(!) TO MEETING THE PATIENT, INPUTTING VERBIAGE FROM BREACH OF CONFIDENTIALITY OF MEDICAL PRACTICE, IN CRUEL DISREGARD OF HARM

Timeline of events on July 10, 2025 and related issues

(My car was damaged by squirrel on **July 5, 2025**, adding more to already unbearable challenges (due to mismanagement of the city park). And since no help was offered, but threats of harmful hostility, I had to rely on own means. Details are available in the Timeline of events that started from this and were documented by **Police with incident report #LHS0191**. These events provide evidence of cronyism and misleading community into hate crimes, by using slander for inflaming prejudice and bias.)

On **July 9, 2025** day prior to scheduled by Jimmy appointment with Dr.King I was trying to get confirmation for it. But I heard nothing back from him... That's why, on **July 10, 2025 in desperate strive to equip Dr King with recs on my documented medical diagnosis for MCS I sent text msg to Brianna (around 7 am)**. But I heard nothing in response to that.

(Later on I realized the evidence of fraud:) On **July 10, 2025** the entry of FRAUDULENT MEDICAL DIAGNOSIS appeared in the VFC database under the name of employee of VFC nurse Cady (later Brianna stated, that she routinely worked with her unit, dedicated to psychiatric disorders, that had nothing to do with my MCS diagnosis, except to provide COVER UP FOR 2022 refusals to obtain my real diagnosis(!) requiring for out of the box solutions.). This entry is listed **at 8:30 am PRIOR TO MERE MEETING OF NURSE CADY WITH ME**. This blunt violation of fraudulent entry was also made prior to mere meeting of Ms Cady with her ride provider and facilitator of my medical appointment Brianna Newitt (People's Concern). And in fact, my appointment was to take place with different medical provider - Dr King (who was known to me for fragrance free living and better awareness of the problem, but who prevented (!) from helping me in 2022 by People's Concern employees). This appointment on July 10 was arranged by another counselor from People's Concern Jimmy Gallardo. But in the morning of the day of the appointment, suddenly and with no prior approval by me this arrangement was changed, in order to engage nurse Cady, despite her ineptness and despite her lack of awareness of injurious impact of fragrance for me, and unaware of my **MCS diagnosis**.



Around 9 am I've received messages from Brianna informing me of sudden switch and causing my serious concern. She was informing me of the arrival **at 10:30 am** of not approved by me Nurse Cady. ***Contrary to FALSE misrepresentation by Brianna Newitt, sent in response to my verification of medical necessity for fragrance free facilitation, nurse Cady was wearing fragrance. However, due to created situation of holding me HOSTAGE,*** I was forced to accept sudden substitute of Dr King, despite suffering from painful impacts from exposure to fragrance - in hope for the note re medical necessity for MCS (due to desperate solutions for being held HOSTAGE - see details of preventing access to electricity charging for emergency use of phone On **July 10, 2025** uses below 📌)

Not long after my exchange with nurse Cady began, suddenly Brianna received a phone call from Jimmy, demanding that we interrupt our process and instead begin interaction **with city employees, presided by Luis Flores along with code enforcement reps Allen Tripolsky and another Hispanic male with NO ID** displayed in uniform of code enforcement. (When their supervisor Carrie Rios came a day before to harass me with unlawful threats re my car and to force me to exposure of her fragrance, causing symptoms of heartache and chest pressure, while deliberately forcing me to be in their close presence. She repeatedly asserted rejections of my medically necessary needs for special accommodations of my acute intolerance, claiming that "I had refused" offered to me "services", forcing me to repeat on and on and on, that no relevant for my ACUTE MCS help had been offered YET, explaining that shelter, hotel, other communal housing forms are sadly INACCESSIBLE(!) for people with my higher than average intolerance of widespread and normalized chemicals - due to immunocompromised condition of MCS. **Even the fact that a child of Robert Kennedy has MCS (announced during congressional hearing), made no difference to her and her cronies.** When I stated that the day after I have scheduled appointment, nurse was very interested in details of it. But city employees interrupted and deliberately intruded into my appointment with nurse Cady, manifesting into impermissible for medical appointments influence on her about misstating my true symptoms, in order to continue to avoid accommodating my pressing medically necessary needs - critical for every human being. (And they pressured me with false threats into singing

misleading documents right there and then as well, or be retaliated in worse manner.). By then, Ms Cady had a chance to read through files with my documented by MD DIAGNOSIS OF MCS during the drive **for over an hour to the appointment**. Respect to this expert medical assessment should have been enough for nurse Cady to dismiss the breach of confidentiality for imposing false assertions and mischaracterizations of any and all aims to dismiss the danger of the ACUTE and life threatening form of my MCS case. And she should have adhered to the Code of Ethics for confidentiality of medical practice and patient's privacy, requiring for her to be firm in preventing such unethical intrusion of individuals, along with report to authorities of misused by them their power position to dictate convenient for them and LIFE THREATENING FOR ME definitions of fraudulent medical diagnosis, while they no business to pry on the issues of mt health...). Upon this unrelated to my health issues imposition of med fraud by physical bullying intrusion, I voiced vocal protests, pointing to earlier use of the same impermissible strategies of coercion, bullying, unlawful threats of power abuse to impound unlawfully(!) my car - all to pressure me I admit irrelevant and nonexistent "mental dysfunction" with my signature on highly misleading documents, that stated no intention to accommodate my ACCESSIBILITY needs. I spoke against such proactive efforts to dictate to medical provider irrelevant mischaracterization of both me, my MCS illness and my expert Dr. who documented my severe case of MCS. But when I offered to show video evidence for the similar outrage of the earlier scenes, Brianna and nurse Cady had no interest and not only dismissed my warnings. They bluntly invalidated my complaints with cordial interaction and welcoming smiles to individuals who they should have contrary restrained from barging into my private appointment with medical provider. (But their lack of firm adherence to medical ethics stipulations re **the duty for providing confidentiality of the medical process and patient's privacy went on afterwards - they refused to report this unethical practice afterwards despite my demands for that**. Brianna N had made no advocacy statement either, appearing in agreement with unethical act of harm to severely impacted by MCS patient, despite bluntly unlawful breach of ethics, in deliberate effort to suggest for using medical settings for creating suitable cover up of their past misconduct. And as the result of PREMEDITATED CRIME OF COLLUSION TO CREATE HARMFUL FRAUDULENT DIAGNOSIS OF NONEXISTENT "MENTAL DYSFUNCTION" was entered into my electronic chart even PRIOR to my first time meeting with the criminal in the nurse uniform Ms Cady, in conspiring with them Brianna (as recordings confirm). Indeed, the same verbiage of smearing with lies my character and intelligence, along with peppering blunt lies with medical terms - intentionally(!) harmful for my health, were allowed to manifest and sustain in my electronic chart in the form of irrelevant to reality accusations of "delusions". Reporting in confidential form was also made to be impossible, despite the fact that such criminal mind in attire of a medical professional may not be allowed to continue practicing even for another additional day(!). However, this instance of shockingly consistent practice (rerun of the similar deliberate refusal to obtain and use my true diagnosis of MCS in 2022) is the evidence of the systemic cruelty, serving as the foundation for ruthless yet consistent policy of concocting excusiology for denial of relevant care and medically necessary services for accessibility (!) for victims of environmental illness, is no less, but the shocking malicious crime. Documentation of People's Concern agency is evident of the lack of services for individuals in crisis with no mental conditions but needing assistance nevertheless and without medication with profitable yet dangerous for health psychotropic drugs(!). Misleading tactics of coercion of desperate for help homeless individuals is created to trap vulnerable individuals into unjustifiable misuse of psychotropic drugs and other irrelevant practices, as the condition to get help, essential and existential for basic functionality, such as assistance with valid documents, legal services, care and personal solutions that are relevant(!) to their health needs, etc.

Such institutionalized practice of subjecting vulnerable and weakened by crisis and other than mental health victims to misleading practices of self incrimination into position of the individuals whose complaints FOR BAD CARE would be EASY TO DISCREDIT - based on FALSE(!) MENTAL DYSFUNCTION DIAGNOSIS, is the ABHORRENT, EVIDENT OF PSYCHOPATHIC DEGRADATION state of collective consciousness, that creates vicious circle of "death row" for the victims of such culture of moral atrocity. And, the fraudulent diagnosis is by all means, the key element to excuse and to permit for being "official" such outrageous approach to routine, daily operation of assault against the basic human rights of the weakest and the most vulnerable individuals, who have no choice, but to trust - with no way of verifying

these shady strategies, due to being desperate for any type of help - such as the case on mine...

And the fact, that lacking compassion culture of moral atrocity permitted for creation of sophisticated RING OPERATION in the community of affluence and great wealth of famous philanthropists, and with no budgetary deficit makes ever more shocking the normality of consistent DEFRAUDING OF GOVERNMENT AGENCIES - all made possible by involving consistent misuse of MEDICAL FRAUD of false mental dysfunction, as the official permission to continue to practice outrage of inhumane incivility towards the most vulnerable members of the society, by the individuals empowered by public service mandate, systematically abusing public trust...

The insistence on my signing up for "services for individuals with mental dysfunction" while threatening that otherwise, the abuse to deepen my suffering from crisis will go on had manifested into written form and is now self evident - at the shocking price of my suffering as well as unbearable for humanity limitations for my causes with global impacts. The murky tactics to force signees for "services" that lead to self incrimination with lack of credibility giving green light and permission to justify cruel abuses in my case amounted to life threatening harm, due to ACUTE case of MCS and lack of relevant assistance with accessibility for MCS majority of social venues like DMV, courts, stores, mail facilities, grooming and care services etc.

Following the appearance of power representatives from City Hall, Nurse Cady suddenly and immediately lost her seemingly genuine interest in continuing to gain medical assessment of my MCS related condition. In fact, her obligations to concoct requested from her FRAUDULENT DIAGNOSIS is THE reason why she felt entitled to turn the lies of character assassination into "official medical opinion", in order to condemn already suffering beyond words victim of LOFE THREATENING MCS. That is the clear reason why she ended what was supposed to be "medical appointment" **without conducting a patient exam(!)** and initially headed straight to her car. (Thus there is no mere mention of my physical manifestation of severe symptoms of intolerance to chemicals, such as severe leg and foot swelling, toxicity related rash, severe digestive, lungs and heartache, severe tongue deformities and other symptoms, including dysfunctions caused by NO ACCESS to fragrance free bathroom and no access to it when I need it, along with NO CHEMICALS FREE SHELTER my isolation and protection from toxic exposures that I was unable to find on the rental market without special assistance. As the result, I had been bound to car dwelling staying in shielded from deadly for MCS exposures, despite desperate need for that... The recording proves that only in response to my reminder to get back to where we left off, Ms Cady did make the reluctant appearance of returning to the area with tables, where we had begun our conversation. However, she had no interest to conduct the usual exam of a patient, as she was on alternative mission - to create deliberately fraudulent diagnosis for discrediting of medical necessities and turning them into "lacking credibility delusions". Along with betraying patients bill of rights, along with basic human rights, she betrayed her own vital need for advocacy for healthy future of her own and HER OFFSPRINGS. Many of next generations members will be blind to similar suffering from agony of painful symptoms due to currently "painless" maladaptive habituation to environmental toxicity, lowering the level of tolerance to cumulative effect of normalized chemical hazards allowed to become the fabric of our life... Under the illegal pressure from the power figures Ms Cady's earlier seemingly genuine interest to learn about my **unique ability to detect and avoid chemical hazards - due to my painful gift of MCS, regretting that she and her kids were unable to grasp(!)**, but still endured cumulative effects of toxicity nevertheless (!) along with genetic mutations for generations ahead(!) and related BIRTH DEFECTS.... Nurse Cady forgot her professional duties and became no longer motivated to continue the intake of my health related issues, DESPITE EXISTENTIAL beneficial for herself and her children's health and safety lessons, that she admitted to be completely unaware of-prior to our meeting with me... I've explained that the widespread condition of **deactivated pain alarms to toxicity was one of the findings of mine, thanks to deeper grasp of social influences for maladaptive conformity to groupthink and authority pressure...**

But along with pressure from authority figures, appearing in city uniform, instead of dealing with the issues of my REAL AND LIFE THREATENING ACUTE ILLNESS, Brianna and nurse Cady began coercing me into signing the paperwork, that deliberately misleads the signee into discrediting the TRUE medical necessities and instead, paved the way for self incrimination into lacking credibility state of “mental dysfunction”, that in turn, makes impossible for credibility of complaints for violations. Both Brianna and Ms Cady had no interest in helping with compassion and care to ease my suffering from earlier violations, that had already mounted to the full paralysis of my life. They were both PAID to providing on a regular basis the green light-invitation for more harassment and doing nothing to help people like me - by preying on their desperate victims and forcing them into signing up to their “services”. The free of malice is particularly clear in my case of holding me hostage with no relevant help, but threats to devastate my life completely with illegal impound of my car, while providing the ONLY alternative to the blunt abuse of power - forcing me to put my signature, as the sign of agreement with lacking any merit assertions of “mental dysfunction”. In fact, their certainty for the ease of getting away from this “license to kill” with irrelevant to acute and life threatening MCS condition manifested into blunt confidence for getting away from the crime of medical fraud, committed IN WRITING PRIOR TO A MERE MEETING WITH PATIENT.

Recording helps to grasp that due to being rewarded with the financial benefits of getting paid for routine production of medical fraud, Brianna and Ms Cady acted eagerly under the wicked leadership of authority figures by measurably lowering common and established for millennia moral standards for avoiding infliction of suffering even to enemies of war, AS IF these seemingly nice individuals with the mindset of predators were suddenly “unable to make sense” of what they heard and saw about the patient, AS IF they “didn’t respond with wonder and seemingly sincere compassion” to my blood chilling narratives of having to suffer and managing to overcome life threats related to MCS - just minutes prior to the appearance of the evil authority figures, encouraging them to continue committing their routines of cruel acts of medical fraud and criminal misconduct, while being aware of the harmful and potentially lethal outcomes.

Indeed, if I were no longer able to depend on my own devices and relied upon these malicious liars and frauds... I’d be likely dead by now according to the proposed by them acts of cruelty and deliberately harmful disregard of my pressing medical necessities - already spelled out by expert doctor and not maliciously LEFT OUT from being included into my chart MCS DIAGNOSIS. In fact, I had sent to Jimmy the file with related medical records from my doctor, since he arranged for my medical appointment with Dr. King. He stated that he was contacted by Brianna, stating that she would take over facilitation of the appointment - WITHOUT MERE EFFORT OF MY APPROVAL, that I would not provide, given the fact of my needs for Dr. King’s familiarity with the dangers of fragrance and his MD credentials(!)

The forms that I had expressly refused to sign in the past, I’ve been handed yet again - this time with two choices: to sign, or to be subjected to lethal dangers of impound of my car(!), forced upon me by Luis Flores, Allen Tripolsky, and his coworker from code enforcement dept under wicked guidance of Carrie Rios, who came to incriminate my disability a day earlier and took advantage of the information re my medical appointment that I stated in efforts to disprove her assertions of refusals of medical help. (Instead, I was explaining my limitations for getting medical help due to lack accessibility to MCS victims, resulting from the lack of ban for using toxic substances in medical settings and among first responders - police, security guards, park rangers and other law enforcement, along with public servants (such as Carrie Rios).

The forms they forced me to sign were printed on scented paper, that was the terrible illustration of the warning message along with research quotations in **documentary on fragrance dangers “STINK!”**. Freshly printed copies had more VOC’s than earlier printed ones. While in the midst of dealing with this issue that seemed to be “the new focus” of my medical appointment, now dominated by the promised to city employees medical fraud by their cronies and accomplices, Brianna received yet one more call from Allen Tripolsky from code enforcement about his intent to abuse his power by impounding my car as soon as the night time of that day, asserting that he had some excusiology for that - despite (!) given by police time for my search for solutions for fixing the car. Instead Luis Flores should have met with me and asked me what was needed to help me overcome the crisis situation with help for

car repairs. But despite his duties to be proactive in this task, he avoided my emails and calls for help, while aggravating panic with false threats alongside of code enforcement reps.¹

I've explained that to Brianna and Nurse Cady, as well as the acts of earlier bluntly harmful misconduct a day earlier by park maintenance reps, involving cut off access to electricity charge, but they continued dismissing the pressure of coercion, revealing the fact of being the part of the effort. Their humane care and desire to attend to my pressing needs of disabled scholar were forced by agency's policy to be dependent on my self incrimination into nonexistent "mental dysfunction". Otherwise, they refused to do anything, even such simple thing as to provide decent clothing.

In the desperate strive to get the discussion of my MCS captured in the form of written note and in fear for distortion of my diagnosis under the circumstances of violated confidentiality and privacy of medical practice, I pleaded to nurse Cady to provide her hand written statement before she left, in order to show it to threatening to appear at night bullies from code enforcement, but she categorically refused, although promised to help addressing the observed MCS problems. She added a strange and shocking with systemic malice phrase about her experience of the routine neglect of medical advise by power abusers, while avoiding specifics... due to having to leave...

This exchange after returning back to the tables area was very short. BUT, since I was counting on Brianna's effort of providing the records of my documented MCE diagnosis, I was certain, that the reference of this medical opinion from my Dr - the expert in the subject and licensed MD with credential and years of experience in treating immunocompromised illnesses Dr. Prescott-Sullivan would be finally incorporated into the medically necessary recommendations for accommodations of my severe and left with no medical attention and accessibility assistance for MCS. Otherwise, it would be simply impossible for involved professionals to maintain their licenses... I was certain that no one in their right mind would act in such irrational manner(!) acting in impermissible self defeat, not to mention, to leave written statement of incitement of abuse by law enforcement- being responsible for lethal threat to me, the advocate of their children's and generations of their offsprings' health and birthright(!)

But I was deadly wrong... I've discovered that instead, I was there for unfolding of the reality of impermissible for all inertia of environmental insanity culture with tentacles rooted deeply into the toxicity allowed to become the fabric of our life(!) by the limited by senseless corruption and hostility predatory minds in power chairs...

And to my grave surprise, I had to cover that before the extended written fraudulent "clinical notes" could have the chance to even barely be entered and manifest in the database of VFC and **while nurse Cady was still in route driving back to her office**, the ill-minded agent of evil Dannie Delsi was on his way to cause what came close to total devastation of my sustainability. Soon after he was vocally (!) bragging and enjoying the fact of being a part of the crime of violation of basic privacy of the patient - as the result of the premeditated FRAUD and outcomes of entered under her name statement of medical fraud (already in the system at 8:30 am - PRIOR to meeting with me at around 10:30 am). (Indeed, even Shakespeare would have to compete in his fictional works with the shocking truth of the realities of my life...)
