on broken car of disabled internationally recognized music teacher and multidisciplinary scholar Rozalina Gutman on July 5, 2025, at Malibu, Equestrian park, used for creating hostage situation in retaliation to accommodation of severe disability, with the aim to mislead & coerce her into subscribing to false "mental disability" diagnosis, revealing abhorrent cruelty & lacking lol sanctity for human life, while involving blunt medical fraud, evident from discrepancy of time stamps and self conflicting entries.

The incident in July 5, 2025 was witnessed by Malibu police, and reported by officer **Kasabyan**. (Not long after officer was transferred to another area.)

The victim of hostage situation Ms. Rozalina Gutman's outstanding intellectual leadership was honored by US Secretary ROBERT F KENNEDY JR at the pivotal moment in human history - in his global broadcast on RESET OF HHS AGENCY, by his citation of the terms of her presentation on multidisciplinary implications of deeper understanding of inner mechanisms of self defeat and other aspects of subliminal mind, enabled by lessons from Bach on self reflection through music-embodied sensory augmented data, that she provided upon invitation by the chair of ISME Research Commission.



The below described INCIDENT #LHS0191 began with involved the case of ruined rodent car of disabled internationally recognized music teacher and multidisciplinary scholar and presenter at intl conferences Rozalina Gutman on July 5, 2025, at Malibu, at Equestrian park. But it had been maliciously used for creating hostage situation in retaliation to accommodation of severe disability - by preventing access to electricity for charging phone and her devices critical for emergency uses, in order to mislead and coerce her with abuses into subscribing to "services" for individuals with "mental disability" on the misleading forms created by agency "People's Concern", that imply voluntary acceptance of such fraudulent diagnosis, contrary to the legal warning against such unlawful practice of its confusion, especially when it comes to the life threatening danger of the lacking relevance to Ms Gutman's real and documented earlier by expert MD disability of acute Multiple chemical sensitivity (MCS) diagnosis, combined with history of UNRESOLVED heart attack (accompanied with refusals to obtain medical history files for 3 years based on openly stated bias against such condition.). And as the result, the actions of the stuff of several conspiring agencies lead to climax of hostage situation in retaliation to accommodation of MCS disability, revealing the failure to practice medical ethics of "DO NOT HARM", while dismissing her real symptoms, related to her MCS and brush off with the lethal danger of heart dysfunction and instead, ridiculing her severe disability with sinister labels along with inflammatory verbiage for taking actions, while knowing of their danger of fatality, based on her true diagnosis. Such malicious misconduct was committed contrary to logical instructions that should have explained the reason why the involved agencies should do everything to prevent such harm - by summarizing MCS-related medical history after becoming familiar with it while driving to appointment for over an hour, or at least a month later upon finally downloading them into the system.

All involved individuals demonstrated the abhorrent degree of cruelty & lacking sanctity for human life. However, the involved blunt medical fraud in the written form of electronic records and breach of related medical ethics (HEPA) had been detected by Rozalina Gutman through evident discrepancy of time stamps and self conflicting entries, making evident primitive mind failure of conspiring liars (also easily debunked by the patient's recording). Such malice had been practiced with the aim to mislead the public and members of the community leadership into notoriously misconstrued and deliberately distorted misrepresentation of Ms Rozalina Gutman's good character ruled by the Golden Rule of Hillel, outstanding and above average intelligence. However, such ambitions are at the same time absurd in their aims to disparage her lifelong internationally recognized, unique capacity to share her gift of music, including fostering prodigious success in young students, as well as her service for the global causes, such as organizing international symposium on advocacy for music education for ALL, in light of compliance with brain/music research. And the life threatening attack on this messenger of change about overcoming at the root psychological drivers of the impacts of the widespread warped priorities of addressing public health and safety issues, are consequential to the normalized anthropogenic toxicants in many consumer products. It serves as the illustration of the concepts related to her most recent observations of the pattern of self defeat/harm, that are evident public health hazard, caused by lacking skills for the mediation for the primitive incivilities of the evolutionary relics of the human brain, such as maladaptive conformity to groupthink, pressure of authority and culture of moral atrocity, resulting in collective Blindspot of DEACTIVATED PAIN ALARMS TO (CHEMICAL) TOXICITY.

This solid evidence is instrumental not only for this single case, but it sets the tone for the trend: While today such acute form of MCS is fairly rare (compared to cancers, autism etc), such mechanisms of ring operation, based on using medical fraud of using false diagnosis of "mental dysfunction" for rejecting care and necessary accommodations for environmental illnesses and leading to criminalisation of intolerable suffering has to be stopped, and perpetrators should be apprehended! Or, if a blind eye is given to this smooth mechanisms of human slaughter, millions of victims of these illnesses will be mistreated in similarly undignifying ways among the next generations of children and grandchildren of today's adults, who will unlikely escape the plight of agony of pain and suffering from birth defects, due to inherited genetic mutations from past and today's generations, based on the data from various research studies, pointing to the rapid increase of environmental illnesses. Every member of progressive forces should be aware of this underpublicized yet rapidly growing problem from cumulative effects of hard to identify toxic conveniences,

On July 5, 2025 during evening hours Police was called by park security to witness that the car I was using as the means of sustaining the life with MCS disability (MULTIPLE CHEMICAL SENSITIVITY) became inoperable, due to the damage by squirrel, that was found dead after the rodent got inside and got injured by the car's mechanical parts (resulting from mismanagement of the park). And as the result of needing assistance with repairs, while being uncertain about whether my car could be repairable and capable to support my life with disability, I ended up at the mercy of several members of the local crisis solutions agencies (likely referred by police?). But instead of help both in the past and at the time of this elevated crisis due to car dysfunction, they continued conspiring together to retaliate to the need to provide relevant (!) to MCS help, with no change to their earlier openly expressed bias towards victims of MCS diagnosis. Instead of help according to duties of public servants and their affiliates, in fact, they made evident concerted effort to take advantage of this suddenly worsened danger for my health/life and made many efforts to make it impossible for me to sustain my life, by creating with unprecedented cruelty the hostage situation, in retaliation to duties of public servants, that they had been failing for 3+ years, since the time when I got stranded in the area.

Since the car was suddenly damaged by rodent and would not start, I was stuck in the park and unable to leave to get the only meal for the the day. And I was distraught by the challenges of the yet to be upraised damage to already old, malfunctioning and needing significant repairs car (Ford Taurus 2001), that I had no choice, but to use as the only tolerable for me shelter, since I was unable to find chemicals free housing on my own (with no assistance) to be able to tolerate commonly used in hotels and rentals toxic (for all) chemicals (fragranced cleaning products, chlorine etc), due to my MCS diagnosis. (I became stranded in the area, since I needed to repair the car, while traveling and searching for treatment and chemicals free housing, after returning from the fruitless trip across half of the continent with little hope left - please, see my related biographical info relevant to my struggles with under-publicized environmental illness of MCS.)

The deliberate effort to mischaracterize as "mental dysfunction" the already documented earlier by expert MD facts of my illness and related medical diagnosis of MULTIPLE CHEMICAL SENSITIVITY (MCS) began in verbal form then, in 2022 when for the first time in the medics in traveling van from Venice Family Clinic along with People's Concern invited me to be served through their outreach facilitation of help to ppl in homeless crisis. And, as the extension of this premeditated, vocally announced policy of bias towards MCS victims, the involved cronies continued to commit injurious acts of misconduct and crimes, in efforts to try to absolve each other from responsibility for demonstrating their good will effort of remediation of the problems - both, caused earlier and left to pile up for three years, as well as for the current lack of will to step outside of the box for complying with even rather simple accommodations for medical necessities for this condition - by assuring for the avoidance of chemical toxicants - harmful for all, yet allowed to be normalized and widely spread in many consumer goods.²

While encountering any first responders (such as police - in this case), I have to ask to deal with those, who wear no fragrant products, and warn them of my symptoms of my history of heart attack and fainting - as the result of my acute intolerance of fragrant products due to my acute MCS condition, that includes higher than average physically painful sensation in response to even brief exposures to commonly used (yet normalized and still dangerous for all) chemical toxicants, while having to provide under-publicized health warning, explaining that they had been permitted to be a part of many consumer goods, despite cumulative effect of their known dangers (especially injurious for MCS victims, endangering health/life of all ppl with current exposure and for their offsprings for generations ahead... (see info on this rapidly growing and yet under-publicized illness of MCS, that is THE PAINFUL, BUT ALSO PRECIOUS GIFT TO HUMANITY. (First responders often lack such fitness to their duty, being unaware of non-fragrant alternatives to hygiene products.). Luckily, one of the officers knew of the issue and practiced fragrance free approach to life.

Due to July 4 weekend I was unable to find my own solutions for car repair right away, while no help was offered by the public servants to the internationally recognised music educator/scholar with disabilities in crisis. Instead the wicked *park employees* went out of their way to try to portray me as "unworthy" of any public assistance, trying to criminalize my disability with false claim and abused their duties for coercion. They used my known to them illness, worsened by the three year long lack of assistance with accommodation of my disability, now along with worsened dangers due to being stuck in the broken car, in order to deflate the focus for responsibility from their own lack of fitness to their duties. And in order to do that, they conspired with other cronies with criminal minds from the agency and clinic for crisis solutions for homeless. Along with other City staff, they refused to help me with elemental things of accessibility assistance for MCS for 3+ years, while I got stranded n the area, as the result of

² In response to their offer for medical assistance from Venice Family Clinic, facilitated by People's Concern (on behalf of City of Malibu), I asked for rather simple thing - to obtain via email my medical diagnosis and history from my earlier see MD re my illness, caused by left untreated Mold toxicity. But their answer revealed blunt prejudice: "We don't deal with people with such illness, since it was impossible to please them with our resources...". And during this recent hostage situation, the similar concerted effort was taken to create fraudulent documents to find a formal way to mischaracterize my condition as "mental dysfunction" - as the method of discrediting any of the complaints re their blunt actions of openly biased abuses and mistreatment with the lack of mere concern for health and safety of the human life.

needing and not being able to find solutions for more than a day-long repair for the malfunctioning car, in order to continue my travel to Northern California...)

The demands for my signature on the forms for accepting what was referred as "services" had subtle and undisclosed agenda: It didn't reveal to the desperate for any help signee that their acceptance of "services" automatically entails self identification and admission of mental disability - whether they suffer from it or not(?) Unless they would "willingly agree" to submit to the sneaky mischaracterization of the proposed medical fraud of substituting real diagnoses (in my case it is my acute illness of MCS) with false diagnosis of "mental disorder", they would be the subject of unprecedented harassment, worsening from misuse of power. This heartless approach to easily deadly impact for my acute MCS showed no real concern for the patient's health. It should be simple to grasp that, just as the heart attack patient would be at the life risk at the surgery for appendicitis, the same risk of serious health and life (!) danger comes with mishandling mindlessly and contrary to warnings my MCS illness, as "anxiety", product of "psychotic imagination", while ridiculing my symptoms as "delusional" and thus, giving permission to neglect my symptoms-related complaints of life endangering level... But even after delayed for almost a month and finally download weeks later related files of MCS medical history, the issue was left with no correction by corrupt and inept nurse, poised to revise diagnosis from the expert MD.

Such blunt abuse of the public servants' duties by cronies from several agencies to achieve mischaracterized portrayals of me as some "lunatic" would provide cover up for past and future misconduct and refusals of any required for illness help. And the use by agency People's Concern of the highly misleading forms, appearing as the generous offer of "voluntary subscription" into "services for ppl with mental dysfunctions", revealed the normality of such facilitation tool for the ongoing machine of manipulative scam at the expense of tax payers that is hardly supervised for accountability for such issues.

This hideous crime of manipulation of the desperate for help victim of crisis was also executed through such threats of abusing power from **public safety and code enforcement reps of city of Malibu**, as to impound my car, stuck in the red zone for emergency parking, however, at the horse ring that for a while had fell out of operation and for a number of years had no large public events with audiences etc. Thus the claim of pressing urgency for impounding my car had no real urgency, since the intended use of emergency vehicles would have no real reason for serving the public at this time. And yet, the illegal power abuse had been bluntly used as the tangible threat... Thus, the pressure related to avoiding such abuse was deliberately inflated and used as the tool for coercion by deliberately inflicting emotional distress for me.

However, these threats to create deliberately emotional distress and terror were only a part of bigger hostage situation outrage: And the same attachment to my refusal to sign documents re voluntary submission to the false diagnosis was vocalized by the ill-minded and psychotic **city's park maintenance employee Dannie Delsi** during his act of shocking incivility of blocking public access to electrical charge station that I needed for using the phone for emergency assistance of all kinds, including food delivery, car repair arrangements, tow truck services, medical emergencies, public authorities that supervise his employment, police, contact of social network and

professional obligations etc.³ These individuals with rather primitive mindset were incapable of comprehending shocking in lack of self compassion self defeat. they were torturing the advocate for the health and birthright of *their own offsprings*, cited by RFK JR....^{4 5}

Additionally as the result of failure to provide relevant(!) to my medical necessities help, and retaliating with the actions of making hard and impossible every part of my already compromised life, I was forced by the deliberately created pressure to agree to the medical appointment, in hopes for the summary of my MCS-related records for urgently needed clear statement for medically necessary accommodations, in the hopes for the humane treatment by the city code/law enforcement. After these records were finally accepted, I could not possibly imagine for the disregard of this written factual info... But instead, to my shocking surprise, in addition to already very difficult situation, due to being left with no assistance for long time, the involvement of long time pals - nurse Cady (Venice F Clinic) and facilitator Brianna Newitt (People's Concern) led to the bluntness of denial of these facts. And it was intended to worsen even much more those already problems, that piled up unresolved, due to lack of help, in deliberate effort to burden me with now insurmountable and intolerable challenges for my existence - making statements of medical fraud, that inflamed the deliberate harm, by revising (with no MD license!) my diagnosis of MCS disability-spelled out with clarity by my expert MD. And to make her fraud appear more realistic, nurse Cady deliberately avoided to conduct triage of my actual symptoms, instead ridiculing the signs of my painful intolerance, as "delusional" misleading every unsuspecting of illminded intentions reader of her lies into criminal acts, with potential danger of fatality.

Medical fraud was committed in the stunningly blunt manner -made 2 hours PRIOR TO THE MEDICAL APPOINTMENT. This lack of logical action of focus on the rather simple task of verification of EXISTING MCS, in writing, by entering electronic records into the database of VENICE FAMILY CLINIC (VFC), with proven to be questionable ethics in various parts of ring operation.

³ In April 2025 R.F.K. JR openly called to stop the crime of profitable overmedication of mental conditions with psychotropic drugs, instead of first focusing on removal of the chemical hazards (chemical food dyes even in children's products), that cause the problems, in order for diminishing the symptoms and eventually leading to recovery. The same toxicity problem is at play with toxic indoor air pollution by the products that effect mental and physical health through inhalation. RFK JR had stressed the resolve to begin research on these matters that had been suppressed(!) deliberately by corruption of the government system by funding from pharma industry. During his history altering broadcast for HHS reset, RFK JR cited the terms of my multidisciplinary presentation for ISME Research Commission'2022, on the psychological drivers of subliminal, self defeating patterns of maladaptive conformity to harmful conventions, using the telling example of existential threat of left for decades unannounced pandemic of rapidly rising environmental illnesses, caused by anthropogenic toxicants.

⁵ Thus the decision had been made to initiate **CHRONICLES OF COUNTDOWN2045** - as the depository of data on track record on the cruel lack of awareness of the self defeat practices of environmental hazards that lead to damages for the future generations through genetic mutations, in order to enable the future victims with the info for the recourse

- along with lack of SUMMARY on MCS diagnosis with the purpose of clarifying ACTIONS OF ACCOMMODATION OF ACCESSIBILITY for me was consistent with the earlier biased malpractice of denial any relevant medical care and other matters of related help and and advocacy. Finally, as the result of indisputable and self explanatory evidence for the criminal act of notorious medical fraud, after 3 years these nasty criminals, who routinely took advantage of ppl in crisis (like me) was captured in the written form and made clear and possible to observe in all of its "anatomical details". It makes investigation of this part fairly simple. (See details in dedicated section - Anatomy of FRAUDULENT DIAGNOSIS OF MCS with details on these entries.)

Indeed, it is hard to imagine that medical professionals and counselors would act out such degree of menace, as well as reveal own lack of logic and empathy-lacking detachment from caused by them suffering, while putting their careers in question with retaliatory reckless fraudulent denial of finally accepted records of the true diagnosis for the purpose of specifying medically necessary accommodations. (In June 2025 Brianna N. accepted my medical history on MCS and she provided the files, However, it is unclear why she only let Cady use them only for reading during her hour long ride to 7.10.25, however, long enough to grasp the essence. Why nurse Cady didn't ask for electronic transfer or print out of these MCS recs for the use for her reference is a mystery for lacking logic actions of hers. Although even after Brianna did deliver hard copy of the docs on 8.1.25, the voluntary corrections and deletions of errors that were made by Nurse Cady were limited only to the childish attempt to destroy already captured evidence of the time stamps' discrepancies. But the verbiage of the slanderous lies and disparaging my character insults for my intelligence, peppered with irrelevant misuse of psychiatric terms with inflammatory incitement of life threatening actions against me, while ridiculing my severe acute MCS diagnosis is the hideous act of retaliatory malice. Records also show dire SELF CONFLICT, making SELF EVIDENT INCOHERENCE OF THE COGNITIVE PROCESSES OT THE AUTHOR(S), thus serving as SELF-INCRIMINATING evidence, SELF DISQUALIFYING from practicing medical and counseling profession.

Notably, the verbiage of false misstatements and lies is similar to the verbiage of the crooks from code enforcement, trying extra hard to create misrepresentation of my MCS disability. The entries were made to tailor them to the ill-minded agenda - in order absolve their cronies from the responsibility for past and current duty to accommodate medically necessary accessibility of my disability of MCS according to ADA law. The malicious nature of cruel disregard for the patient, due to pathological culture of moral atrocity appears to make such crimes to be the common pattern and the normality for the abusers of power over the least privileged populations of disabled by illness victims of predatory misuse of hard copies of the medical history and diagnosis in retaliation to facing the inconvenient truth about the needs of rapidly growing population with environmental illnesses, caused by self defeat of anthropogenic toxicants. Such pathological mindset is in dire disconnect with much needed alternative, logic based and heart-centered leadership, grounded in the capacity to facilitate the shift to NO BUSINESS AS USUAL attitude - the key to self propelled mobilization for the global fight for preserving endangered health of most inhabitants of contaminated planet and for assuring birthright - also in question among generation starting with grandchildren of today's adults. I trust that my intellectual victory of grasping the shadowy patterns of this pathological ring operation can alleviate the burdens of torturous patterns of such evident crime of malpractice

from the shoulders of many other powerless victims. This quite rare case of clear evidence of malicious acts towards MCS can finally serve universal need for establishing guardianship for many today's and rapidly increasing future victims of MCS and other environmental illnesses - never labeled as Preventable by medical industry.

▲ Timeline of events of creating 7.5.-7.14.25 hostage conditions for coercion into admission of fraudulent medical diagnosis, in retaliation to MCS disability accommodation

The below documented evidence of enacted moral atrocity culture is only one example of modus operandi of 3 yearlong efforts of several local agencies, conspiring together in retaliation to professional duties to provide lifesaving disability accommodations. This evidence of normalized and unapologetic routine in operation had been captured, demonstrating dangerous level of ethical confusion re the very nature of the public service and medical care of individuals, whose pathological detachment from reality is the evident health hazard and the source of suffering due to normalized routine of cruel acts, that had been mandated by the false polity.

Just line most of people, I could never imagine to become the victim of malicious actions and threats, along with avid insults to my intelligence, in dire disrespect and disregard of being a disabled music instructor, internationally recognized for fostering prodigious success in students, presenter and organizer of events at intl conferences. multidisciplinary scholar, author, advocate for compliance of music education for ALL through **brain/music research**, who had been stranded and homeless in the Malibu area, due to broken car since summer 2022.

Conspiring local agencies to harm and to attack my character, my intelligence and to distort the true medical necessities of disabled by MCS victim in retaliation to required accessibility accommodations for medical necessities and assistance, involved conspiring staff of several affiliated agencies for crisis prevention, including

- homeless services agency "People's Concern", providing mutual cover up for predatory profiteering from homelessness by fraudulent diagnosis in cruel disregard for health/life threat by
- 2) affiliated Venice Family Clinic,

- 3) both encouraged by shamelessly malicious **City of Malibu employees** of various departments, engulfed into cronyism and profiting from fostering of moral atrocity culture.
- 4) (Other agencies's reps were involved in other similar retaliatory misconduct, contributing to malicious harm to devastate disabled individual, contrary to professional duties of public servants to be covered separately)
- 7.5.25 Saturday evening I was unable to drive the car after movement for only several feet. It would not operate even with charger, due to damage done by squirrels. One of them was laying Idead after being caught into car mechanism.
- The security guard called police, but Police officers didn't offer any resources for assistance with tow and car repair, AS IF this community had shortage of funding for such community service in emergency situations. (Due to the high concentration of celebrities' estates, the area is likely one of the world's most affluent... But the leadership has not made logical arrangement for providing vital Emery's d crisis services for population, since it suffers from the shocking ethical deficit and moral bankruptcy that effected the morale of entire administration.).
- Among 4 police officers, Of **Kasabyan** responded positively to my **request for being fragrance free communication contact.** He also praised me for sharing related data info on universal danger of avoidable fragrance. And I suggested that we give presentation for all members of 1st responders, in order to save lives of ppl who may pay with lethal outcome for exposure to this known hazard, esp those with compromised health... I told them that I intend to arrange for taking my car on Monday morning to my rare mechanic who would work on such old car as this one (2001).
- Officer Kasabyan expressed outrage about witnessing the unfair hardship of the scholar and advocate for environmental justice being left with no help for three years in the area, after being stranded with malfunctioning old car-replacement, following car accident...
- 7.6.25 Monday AM my mechanic responded saying he was overbooked with cars in his lot after 4th of July long weekend and has no room to keep mine. I was in panic of loosing the car to impound according to threats. I've asked for city employee to help advocate for removal of squirrels to wilderness, but he refused. I've asked subcontracting workers to contact supervisor Christian to help with humane removal of pests, but they refused pretending as if they do not understand my request (deliberately? words "phone number of supervisor" sound very similar in Spanish even if they don't speak English at all)
- Park maintenance staff member Dannie Delsi came to open the gate and bathroom, but refused to merely speak with me, of to mention he did not offer any ASSISTANCE to disabled scholar with her collapsed by rodent car. (In fact this was a part of the ongoing pattern. Instead of help with anything during several years spent during daytime in this park, being busy with writing the book, he and his supervisor Drew Belter NEVER offered ANY help, despite seeing me in disabled parking spot every day. Instead of help, however, they tried their best to make my presence there as intolerable as they could, in variety of at times torturous ways. And that included the acts of causing suffering by opening the park, but not opening the bathroom. It

was hard for me to grasp the reason for such nasty attitude, he never revealed openly. Except, the gardeners crew under their supervision did reveal it on behalf of their boss and supervisor of the park services, since they didn't like to be witnessed while doing nothing for hours: And after being advised by Dannie, they began to misuse leaf blower against me, as the assault weapon, by suddenly creating dust attacks, while knowing of my respiratory illness from my many complaints. Among other acts of incivility and unlawful violations of ADA, Dannie suddenly brought sent free toilet covers to replace the scented ones that he installed deliberately (buying them personally! Other crew member told me city didn't have any scented toilet covers, thanks to awareness of danger). When Dannie was on his way back to his car, he suddenly began making video of avoiding to talk to me and pretending he was "threatened by me" - deliberately trying to make false impression (videotaped). This pattern of his odd behavior wasn't coincidental:

• It began the day after I wrote to police asking for help with being targeted by the officer who made proactive efforts to criminalize my disability, as well as to explain the reasons why their database had some unknown to me mailbox in LA, instead of my home address listed on my driver license, that was posted on the bogus(!) ticket, given by biased police officer. I was very disturbed by learning about this, since I could not understand who had been involved with the issue of the federal offence of this mail fraud in my case and why police had such bizzare info re me. But, my written email was left with no reply of any kind, despite the fact that shortly after homeless assistance liaison from police Of Esperanza showed up in person and spoke with me briefly about my list of pressings needs for assistance, but left suddenly to some "urgent call"... He seemed to be friendly and appearing to be willing to help, but at the same time, he never too into consideration the data I shared with him on the danger of fragrance. (And he may have retaliated to my resemblance of his addiction to cologne...) The reason had never been explained by him for his lack of response to my inquiry as promised - with actions, as well as to other pressing matters that paralysed my life and needed immediate help. I left him several messages with my contact info, but got no response of any kind, I matter what...).

And only during the described here hostage situation, I became cognizant of the previously hidden from me influence from "the actors behind the scenes", who were promoting the hostile lack of helpful attitude among local sheriffs, that originated and was similar to the senseless hostility of the other city employees, involved into proactive crime of false criminalization of my disability - instead of help, logical for their position of power to solve issues with documentation.⁶

⁶ For example, I was given the irrelevant to disability ticket for not being capable of stopping exactly at the line of the stop sign, despite the fact, that I explained to the officer, that due to my disability including acute respiratory problem (I was wearing mask!). I was unable to stop right at the line, due to gardener using leaf blower right there. And that health threat forced me to stop a bit ahead of the line, in order to proceed safely through otherwise empty intersection on the quiet street. Despite tearful plea to accommodate my disability, police officer denied my disability needs and harassed me with the irrelevant punitive sanction, suggesting that I object it in court. He remained deaf also to my statement, explaining that going to the court for me in person is impossible, due to intolerance of fragrance in any buildings... He added one more extra arrived to restoring normality of my life, instead of doing the contrary, due to his duty of first responder that he failed to prioritize by denying disability accommodations...)

• Shortly after speaking with officer Esperanza re above mail fraud issues and getting no mere reply, I didn't know where to turn with such problem. Later on I asked for help, addressing to Jimmy, who first promised to help, but did nothing in response to our discussion including after receiving a copy of my ticket... Several months later he showed up suddenly and said that such issues are addressed by social workers and disappeared for several more months(!) again. Then, after learning of my radio interviews re my book, he was finally motivated to engage. And he most suddenly showed up (an hour late) after similarly sudden appearance of Brianna Newitt (in April 2025) promising to assist me with all troubling my life things. I spent long time describing above and other pressing issues that paralyzed my life, and she promised she would help and even suggested a few strategies on a few problems. but she didn't do a single thing despite the list of similarly pressing issues that literally stalled my life(!).

One of the most pressing issues on the list of needing pressing assistance that I've asked members of several public service agencies was - to assist me with the true outrage of my lost to impound 5 y o car TOYOTA PRIUS, that was shipped to me from another state by the friend , since this car was used by previous owner, who knew to avoid fragrant and other toxic products. And thus, it had no residue of intolerable for me chemicals on the seat, carpet etc. Individuals with acute MCS are often unable to use new cars with no residue for paper owners, due to intolerance of offgassing of the new materials in the cabin, especially toxic after manufacturing. It is very hard to find such car since most people are unaware of the danger of commonly spread toxicants...⁷

⁷ But since I could only estimate my tolerance of this car, upon its arrival it turned out to need more off-gassing time before I could use it without being in pain from still bothersome impacts even during 30 minutes drive to registration (although the car was 5 y o.). But I didn't have the network of friends in this new, unknown area, in order to ask for help... And, through the involvement of the county officials and imprudent locals, I ended up loosing this priceless car to impound, since the local agencies (including city park(!) service staff) refused to help with very simple assistance of finding a small spot to keep it for the time of additional offgassing. In fact, one of the methods to retaliate to this was the bogus law suit against me by another local public service agency - the federal park administration for Santa Monica Mountains Trust. After a number of months of intense assault with infliction of emotional distress, the case was dropped with no charges against me, due to false accusations, although involving blunt human and constitutional rights violations. The court hearing on bogus suit was moved to in-person attendance (during the hearing in online format, due to my known MCS disability to attend court hearings in person). As the result, it was held behind closed doors in violation of the human and constitutional rights to speak at the court and to examine the evidence of accusers that the judge refused to adjudicate for with subpoena based on my appeal to the court for restoring due diligence process, while making mockery on justice. Several months of my life were consumed by this terrible stress, leading to acute heartache. Such car could be hardly found on the market, while buying another car was also impossible due to intolerable offgassing of all new materials in the cabin - plastics, foams, carpet, rubber, etc all very dangerous for everyone, but normalized by irrelevant for health manufacturing standards... Since another person helped me buy this car in another state, I was unable to test it personally for tolerance. And when the car arrived, my hope to move my belongings and drive towards hometown collapsed, when I opened the door and smelled the scent of yet to be offgassed rubber that I could not tolerate without additional offgassing. I needed to keep the car for a while with opened doors in some safe place, but I could not find anyone in the area, where I didn't have a network of people to help me with that. And the staff of the city park refused to assist me with the rather simple task of finding a small place for car parking... ... The car was impounded and remains in unknown to me location, while my pleas for help to police had been remaining with no response of any kind...

- 7.6.25 Monday afternoon- Jimmy and his associate William showed up suddenly after three months of no contact, being some food. (Didn't say who sent them. He had not been in touch since April when I met Brianna. Back then, He didn't fulfil his promise to arrange for Dr appointment In April and didn't provide written statement re denying his personal involvement into manufacturing of the false referral signed with his name(!) to a remotely located agency **StepUp-Daniel's Place** for management of psychiatric drugs (irrelevant to my illness), while verbally denying, that he signed the referral. His supervisor Tiffany did NOT respond to several repeatedly sent email inquiries for investigation, revealing involvement into fraud.) The team of liars was evidently unfit for interaction. (I had no food for several days in a row...). But I had no better choice...
- On the other hand, I was very frustrated with Brianna's unapologetic lack of any help on issues, discussed on and on for almost three months. It included no response and week overdue email to city council member Haylynn Conrad re arranging for a meeting that I asked her to set up PRIOR TO THESE SHOCKING EVENTS WITH HAVIJG TO ENDURE HOSTILITY. I hoped HC would be resonant to my needs for help due to my less common problems that needed out of the box solutions, including reaching out for community assistance.
- 7.6.25 Monday night I returned back from long, arduous and very painful walk to get food but without food, due to seeing security car, and fearing for the unlawful but persistent threats re loss of my car to impound. And had no real food for yet anther day. Security called police again and they harassed me, AS IF this was "my fault", and gave me 72 hour notice re impounding of my car. Although I've explained problem with mechanic's delay. (But the city staff, Including park management's Dannie and Drew) did NOT offer any HELPFUL resolution of the problem but increased threats and intimidation. Being stuck in the fire lane was held against me, AS IF this was my fault (not squirrel's and as if "they forgot their public service duties to assist disabled ppl"
- 7.7.25 Tuesday AM my mechanic said he was still in overflow from long weekend and can't take my car.
- Finally, I got copy of email from Brianna to City council Haylynn Conrad, but I shrugged since it had no specifics re my diagnosis and related medical necessity due to MCS. And it didn't merely mention the car ruined and needing assistance. She didn't merely mention about receipt of the medical records with my documented MCS diagnosis and my related needs for accessible bathroom.
- Jimmy from People's Concern came (no wheelchair and no food) and said that he set up appointment with Dr King on Thursday
- Jimmy refused to advocate for pest abatement, giving me email of Luis Flores to deal with it on my own, but reception on the park is terrible, preventing effective communication on emergency(!) Luis Flores left my email re this with no response of ANY kind dismissed and disregarded despite major threat to my car from additional damage(!). I also tried to call and speak with Luis Flores, but reception in the park didn't permit, and calls get dropped. Luis didn't respond next time I called, and disrespectfully avoided any follow up DESPITE THE URGENCY OF SITUATION. (High likelihood that he was prejudiced against me by hostile employees of the park

who harassed me continuously while I was trying to finish my book on the park (likely due to fear of being caught for corruption)

- Due to being a hostage in the hands of hostile and manipulative thugs with the misleading smile masks hiding true nature, I was very worried. And I was unable to focus on anything, due to having to guard car from returning squirrels... But I needed to prepare to participate in online symposium next morning, while I don't have extra pack of charging batteries and no good reception in the park. I've asked for wheelchair to get to the beachfront for internet, due to very bad pain in angles, legs, feet. But empty promises from Jimmy never got fulfilled for the reasons unknown to me... until three weeks after the crisis. And upon receipt of it via mail, he found no place to keep it for the future possible crisis similar to this violation of their duty to serve emergency needs
- Arduous and long walk to get food took several hours due to having to sit for rest
 where it was possible, but not near park during uphill walk through residence especially painful and exhausting. Sleeping was made difficult due to fear of illegal
 but repeated threats of being towed was exhausting due to deliberate infliction of
 emotional distress, as police came waking me up.. However my car was not an
 obstacle since the arena was not in use anyways.
- 7.8.25 Wednesday am I appealed via email to city council Haylynn Conrad on my own, sending her the copy of my letter to Brianna with reflection of my outrage re its ineffectiveness, due to no specifics about either my car collapse and my medically necessary MCS needs for accommodations. Due to bad connection, sadly the attachments didn't send (as I grasped only later). But Brianna responded saying, that she was reprimanded (?!) for sending even this letter, with no explanation "why?" by her psychopathic supervisors (who created culture of moral atrocity). City council Conrad refused unapologetically to meet with me, adamantly denying her duties to attend the life threatening situation created by out of control city cronies, implying that my letter was "meaningless" to her, as if she could not understand the urgency of the human catastrophe unraveling under the blind eye...
- 7.8.25 Wednesday am Park maintenance Dannie Delsi came to open bathrooms and suddenly retaliated with false & absurd(!) accusations of "tempering" with something (unclear what first, later understood the lunatic blamed me on doing the impossible he claimed I "could break metal parts with weak female hands and with no tools... that he likely broke himself. He had been acting consistently to make odd impression of "fearing me", AS IF he was

⁸ On August 20, 2025 Haylynn Conrad came to the park where I had a chance to try to get her attention, but she was adamant about refusing to attend the subject, citing the city employees giving her the false impression of handling situation "properly". But when she heard of caught by me evidence of several conspiring city staff members involved into concocting medical fraud with discrepancies of time stamps, she agreed to write my phone number, in order to speak with me. Her generally dismissive and disrespectful attitude didn't leave an impression of any tangible hope, but I'd be glad to make update on this with the contrary information on the positive developments for this issue. And she had never bothered to make the time to learn how to help me and to reduce serious liability for the community resulting from the notorious hate crimes of city employees. He called for his "buddy and partner in crime of unstoppable retaliatory harassment" Drew Andrew Belter, who also eagerly started yelling at me with baseless accusations, to criminalize my disability (other instances also took place in the past see more details below). When I asked him the question "How could it be possible for a woman with no tools to brake off a metal loop from the metal case?", he left with no response my call for his logic that he didn't care to use INTENTIONALLY. But he wouldn't admit, that his crony Dannie was saying lunacy and continued to accuse falsely and together with him. (Likely he is the one who played active role in planting bias among other city employees, taking advantage of their trust.)


