- **8.21.2025 Thursday** In the morning I was suddenly approached by officers Epinoza and Vigil, who announced a shocking fact: Park employees made false complaints re "harassment" against me, demanding for him to arrest me and take me to psychiatric ward - FALSELY and based on the FRAUDULENT DIAGNOSIS that they were personally motivated to concoct in collaboration with their cronies(!) Meanwhile after "hard" work of "tiring and exhausting 20 min" everyone deserves to take rest for hours, since whether they work or do not doesn't matter anyway...

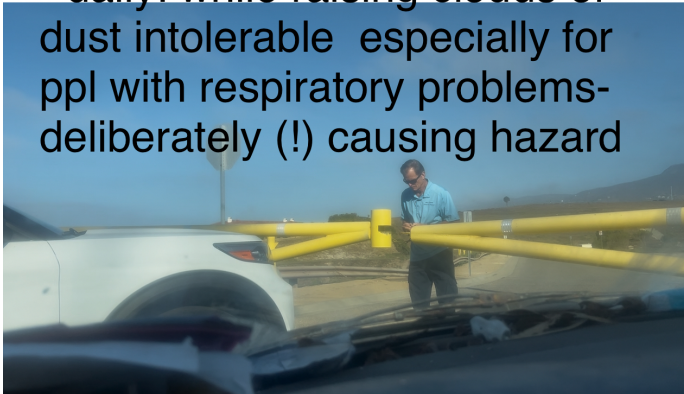
8.24.2025 Monday After expression of the concern by several police officers on Thursday 8.21.2025, I assumed that someone within police would begin to handle the problems of deliberately created paralysis in all parts of my life - in addition to intolerable suffering from illness while with no housing for isolation from chemicals(!) And I had to repeat that accommodation for MCS disability is often impossible in such settings and needs different approaches. This subject was discussed again and again since 2022, but nothing had been done to change the problem in a reasonable manner. However, police was trying to make contacts to with Luus Flores to remove tickets resulting from being targeted by parking enforcement, in order to allow for the car registration. But no, this was NOT of the concern of Jimmy and William since they were told to get the response that could be misrepresented to the convenience of COVER UP for all involved for three years and failed in reasoning, and practicing together shocking cruelty individuals, led by bureaucrats with no concern employed under the name "People's Concern".

- daily! while raising clouds of dust intolerable especially for ppl with respiratory problems- deliberately (!) causing hazard



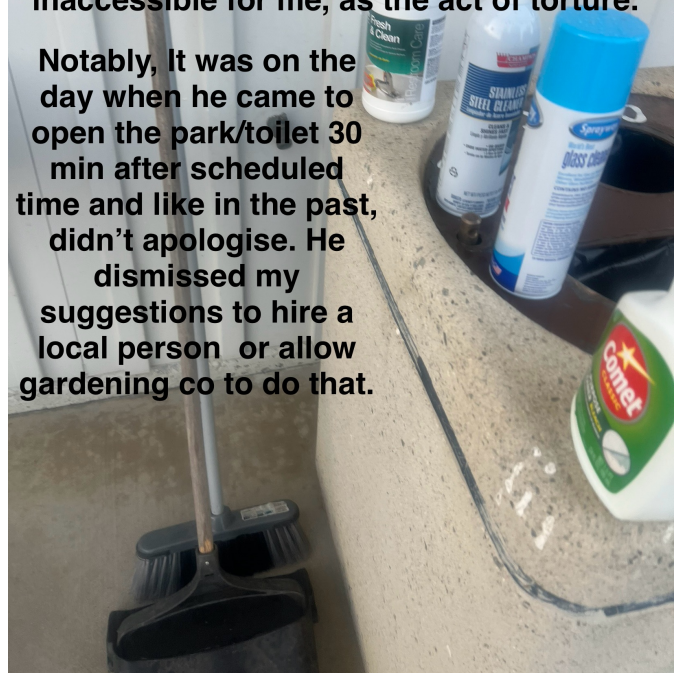
