[The above collage of records is the restatement of recs entry of committed fraud on 7.10.2025, presented here for comparison of SUMMARY of the visit by nurse Cady on 8.1.2025, aiming to delete the evidence of the crime, upon my open demonstration of discrepancies in time stamps. But, contrary to LETHAL danger to patient, despite being capable of making alterations to the files by trying to delete part of the crime's evidence, Ms Cady deliberately and maliciously avoided the entry of the replacement of fraud with the true MCS diagnosis - at least NOW. Thus, even after finally(!) making effort to upload into the system the recs with detailed documentation of my ACUTE MCS illness (from my Dr Prescott-Sullivan, Expert in immuno-compromised conditions), her actions perpetuated her deliberate LIES for initial misrepresentations of demanding for urgent help illness, by abusing her professional credentials and misusing for retaliatory purposes professional terms for inciting violence against the witness of her lacking fitness to medical duty (wearing fragrance, breaching confidentiality). The slurs of cruel ridicule, aiming to disparage credibility of mine and my Doctor, continue (unapologetically!) to describe my symptoms AS IF they "resulted from delusion", "mental dysfunction" - EVIDENTLY UNFITTING TO BE UPLOADED BY HER DOCS on my MCS]

Today (8.8.25) I checked email and suddenly learned: I've missed Brianna's email from 8.1.25 (vs regular texting, as she didn't alert me to check extra urgent nature of fraud related info). She responded ONLY upon recognition of being caught as a part of the scheme - upon receipt of my collage of compiled and compared written evidence (among other type) of the committed fraud, resulting from my medical appointment, that she facilitated(!). And the TIME STAMPS, evident of fraud being entered into the database PRIOR !! to actual appointment, make this crime self-explanatory and needing no more effort to be proven. (Although additional investigation will be helpful for uprooting all of the tentacles of the involved ring operation.)

Note: Brianna's unapologetic remarks (before taking off to the luxury of vacation, while leaving her client with no guardianship from unreported by her, observed crime of committed medical fraud... She only casually (and unapologetically !) mentioned "Little wonky" system "malfunction, despite the terrifying threat remaining for the patient subjected to lethal endangerment, that stayed unchanged after the sinister entries on 8.1.2025.

NOTE: The added note by Cady shows NO PROBLEM for adding posts, while she cruelly failed med duty to make any explanation for irrelevance of initially entered by her fraud - in shocking discrepancy with the true diagnosis(!)

The below recs show that 1) Ms Cady had a chance to alter her electronic entries. 2) But instead of restoring the truth based on expert opinion re my diagnosis, she DID NOT. 3) Cady used info from my alert about being caught with medical fraud for the futile effort to mislead more and further the readers of critical for patient's health med recs - **while deliberately attempting to remove the evidence of already captured medical fraud of hers**. 4) The distortion of my symptoms of severe MCS with painful acute responses to minor exposures of chemicals **remains ridiculed and it deliberately misdirects readers into the actions of reckless disregard of clearly known highly damaging and potentially lethal outcomes**. 5) Brianna also continued

to **downplay the significance of the shocking criminal misconduct of her crony**, working together for mutual cover up of their agencies, due to hopeless corruption and dangerous decay of medical ethics. *Both of them get paid from such fraud claims through their wicked program, while no alternatives seem to exist for crisis that is other than mental disfunction*

And instead of addressing shocking outrage, Cady's response continues to be evident of notorious disregard of devastating for patient (me) retaliatory incitement of health and life endangering actions, contrary to NOW KNOWN TO HER URGENT NEED FOR MEANINGFUL HELP - ACCORDING TO THE TRUE DIAGNOSIS(!) The acknowledgment of possession should have immediately translated into the actions to employ at least NOW scanned recs related to my MCS diagnosis for at least some relief of accrued troubles at least at this time, after being dangerously delayed - caused by several affiliated with each other agencies for homeless crisis assistance, that instead of relief, had caused tremendous troubles for me with unprecedented cruelty. This brevity of the note by Nurse Cady on 8.1.25 is shocking, and it sadly "opens the can of worms" and confirms malice of her earlier cruel lies about her with deliberate intent to harm a vulnerable patient. (It remains unclear under **what MD license(!)** she had been operating on this capacity and how much influence for this comes from that entity, remaining "behind the scenes" at the moment...). It is very telling of her **incoherent cognition re her medical duties of READING AND MAKING SUMMARY** of the finally uploaded recs with documented MCS diagnosis (overdue since 2022 due to her colleagues' similar malpractice). The blood chilling revelation comes re the lack of proper reference to **the LINK of MCS being combined with evidence of its lethal threat, based on the history of ACUTE MI (!) (= heart attack) - STILL cruelly left unmentioned in DIAGNOSIS in CLINICAL NOTES(!)**

WHY did smiling and charming looking predator Cady skip the word "ACUTE" in this medical term for the heart attack CRUELLY AND DELIBERATELY(!), while downplaying urgency, by misstating current symptoms - by lying about "NO ANGINA"? The answer is obvious and chilling - intentional effort harm(!).

The fact that she did NOT upload these files on the day of her medical appointment 7.10.25 is also very evident of the premeditated by cronies nature of their conspiring scheme. Additionally, her wording for excusiology for such notorious delay of critical use of my recs is unapologetic and is versed, as her "additional" act to her FAILED duty to address the urgencies of my documented illness - LEFT DELIBERATELY UNATTENDED by her with no relevant accommodations at the time of urgent need, in order to concoct medical fraud, tailored to fit the needs of her cronies with criminal minds.

In email Brianna stated, that she finally(!) provided physical copies of my med recs with documented by expert MD diagnosis of MCS to Ms Cady - 3 weeks late(!) for LIFE THREATENING crisis solution. Notably: It didn't contain any regret re hijacking my life, nor her apology, AS IF she could not understand that she would be easily dealing with fatality 💀 as the result: **I would be dead by now, if my car would be impossible to fix**, as suspected during weeklong hostage situation (that her actions perpetrated), and if I had to rely on such recklessness in handling life threatening disability.) (Replacement of this car is highly challenging, since ppl with ACUTE MCS are not able to use most NEW cars due to offgassing of new plastics, foams, carpets etc. (harmful

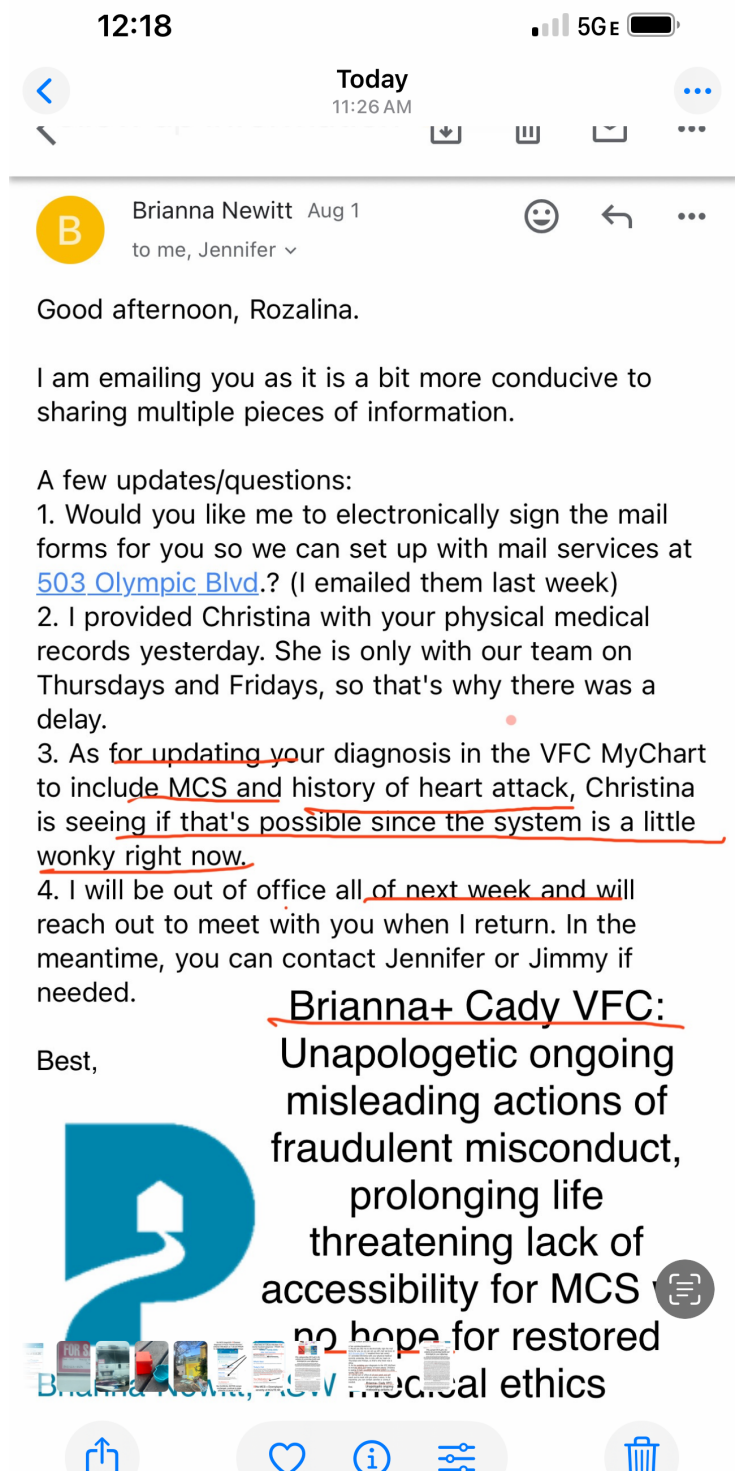
for ALL!), but finding used car with no scent is very rare, since most of population have no info of the danger of fragrance for ALL!). Brianna's lack of at least polite concern shows likely aims of the ongoing fowl game by all involved cronies.

Brianna ignored my many calls for help with NO slightest concerns re remaining deadly threat for several weeks(!) after hostage situation (and prior since April...). And this response from Brianna came finally after my taking hourlong (!) personal effort for verbal explanation (7.25.25) of all detected by me evident aspects of the involved conspiring scam, along with her personal prof failure to report serious 🖱️ breach of confidentiality !! of medical practice during my 7.10.25 med appointment with the aim to prevent BAD RISK Dr OF FATALITY: The URGENT MED WARNING had to be issued, based on verification of my existing MCS diagnosis, documented by expert MD in the past. Instead, just the contrary took place with no hope for anything better - the green light to devastate me was given by deliberate avoidance and gross misstatements of my MCS, based by demands for that from City employees(!)

Brianna's duty was to report the outrage of earlier refusal of medical help in 2022(!). And more of my time was wasted senselessly, since her involvement, due to profound learning disability of both Brianna and Ms Cady OR/AND due to their malice!):

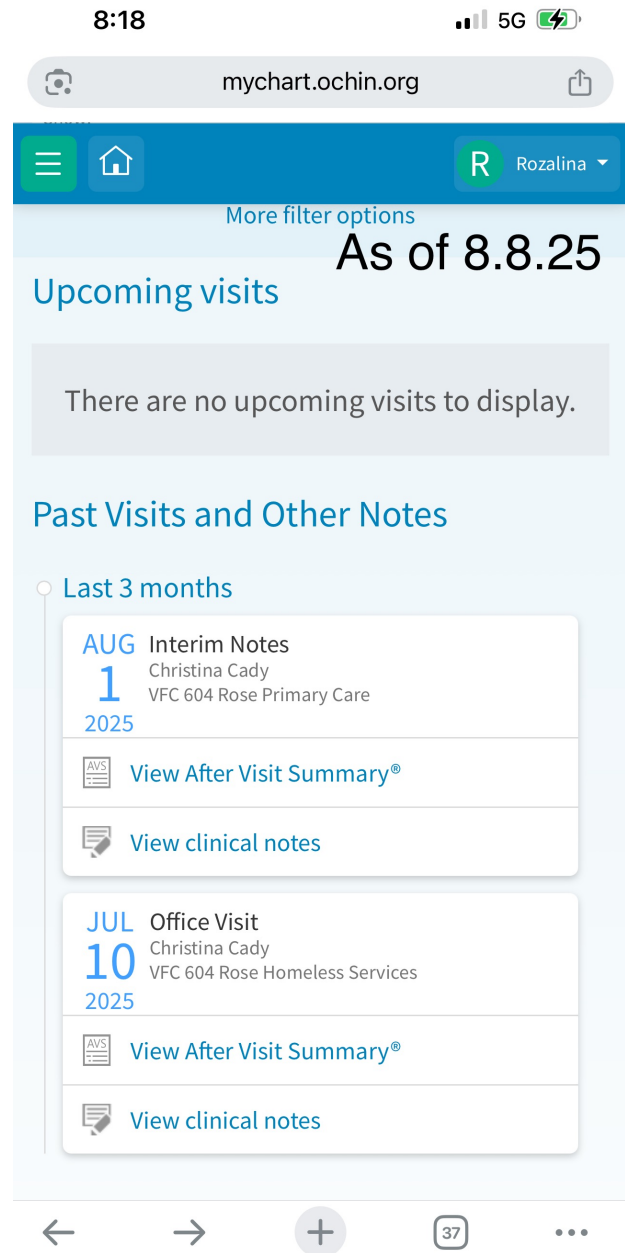
The 8.1.25 CHANGES to the initial 7.10.25 misrepresentation of my illness of MCS(!) were made to deepen deception with "diagnosis correction"... Even physical possession of med history of MCS did NOT help:

As online records state (checked 8.8.25) that, although Ms Cady did delete fraudulent diagnosis of my NONEXISTENT "mental dysfunction" - with time stamp of 8:30 am, revealing that what was entered as premeditated fraud(!) before seeing me at 10:30 am - REMAINS UNCHANGED IN CLINICAL NOTES. But she deleted fraud only in ONE(!) section and still deliberately failed to write my TRUE diagnosis of MCS instead - the



key for determining medically necessary (!) steps for my accessibility accommodations even in situations of interactions with any FIRST RESPONDERS. NO, she still did NOT delete the same (although detailed with BLUNT LIES) restatement of fraudulent info in her CLINICAL NOTES !!! along with NO ADDED reference to my expert MD(!) for additional info(!) - if needed for emergency reference. There is also the statement re inapplicable misuse of the law enforcement - to criminalize my MCS disability and to cause 💀 fatality risks for those who would meet me for the first time with no prior experience of observing profound suffering from pain and other terrible symptoms to toxicity. This RETALIATORY incitement of hostility is to provide excusiology for both failure to accommodate my real medical necessities(!) in the past, while leaving no hope for the future !!! - despite awareness of prolonged unspeakable hardships and deadly 💀 health threats to my life, also limiting my ability to propel my global causes. Such warped definition of REMORSE FOR THE HARM CAUSED to date is evident of impermissibly dangerous misfit to working in healthcare !!!

Due to admired during appointment by nurse Cady lack of ANY of her personal aptitude on MCS, her most effective focus should have been on using documented diagnosis of MCS AS A GUIDE along with providing **visible symptoms of MCS (she left out in triage as "unnecessary" for fraud**, including citations of my narrative re chest pressure and heartache upon being forced to be exposed to HER OWN fragrance - **being resentful of admitting her lack of fitness to practice medical duties**. Needless to say, she should have provided the SUMMARY of cited recs from my medical recs from MCS expert Dr Prescott - MAKING IT SIMPLE GRASP AND TO UNDERSTAND for her colleagues at People's Concern AND CITY ADMINISTRATION, ALONG WITH CLEAR MEDICAL NECESSITIES FOR MCS ACCESSIBILITY ACCOMMODATIONS, in order to finally begin to ACT ON CORRECTING MULTIPLE PROBLEMS, caused by similar failure in 2022 - by the same actors and partners in crime (!). But that would mean that her initially entered fraud would need to be DELETED and replaced with correct description of my medical necessities for MCS. Sadly, this relevant to the problem action had been notoriously left outside of the scope of operations of the involved agencies - intended for solving crisis, but easily getting

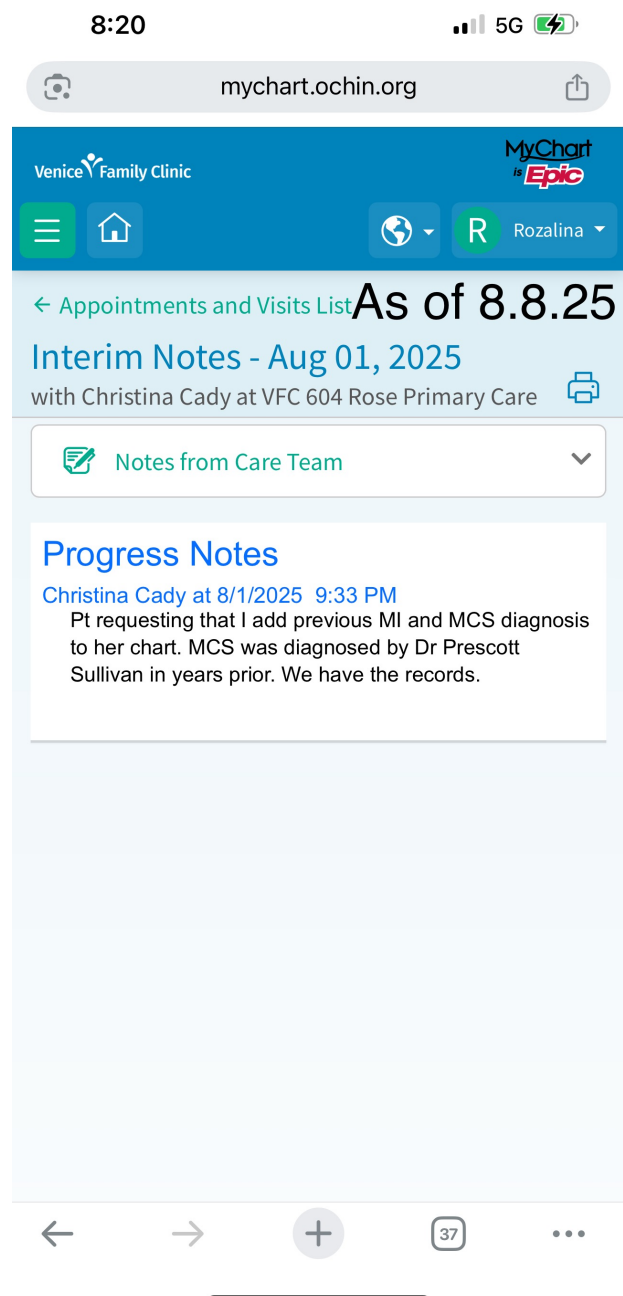


away from the core purpose In hopeless

Simple comparison of *various parts in various sections* of entered by nurse Cady gibberish (along with dire discrepancy with the recoding of actual proceedings) demonstrate shocking SELF INCRIMINATING disconnect with **NOW downloaded files on my MCS diagnosis from expert MD. But such overdue action would destroy the initial conspiracy scam that had begun with the irrelevant entry at 8:30am on 7.10 - 2 hours prior seeing the patient for the first time!):** The hopeless prevalence of such SELF CONFLICT and nonsensical misstatements of retaliatory attack on my character and intelligence WERE LEFT deliberately and with no concern for DEVASTATING IMPACTS(!) being evident of menacing cruelty - while abiding by the agreement during breach of confidentiality by city employees. This current version of unchanged fraud verbiage provides them with the support of the past and invitation, invoking future outrageous abuse, by intentionally keeping mischaracterization and cruel ridicule of my very dangerous, limiting and very painful illness, instead of stating clear warning to the first responders to avoid any unnecessary contacts due to the lack of ban in fragrance use among this and other in medical professions.

This evidence of conspiring games is on the other hand, helpful to understand **the anatomy of normality and serious threat to the society of this public health hazard, while revealing the logistics of the crime:**

The left undeleted part with accusations of me re “torn and soiled clothes” continue to shed the light on the fact, that she joined her cronies from People’s Concern, who had deliberately avoided the duty to provide clothes (Brianna’s People’s Concern team since April 2025) - among many other pressing issues, listed in writing and discussed multitude of times that still demand for urgent resolution - **all caused by the initial 2022 refusal of obtaining my med diagnosis for MCS(!).**

And since then, quite for a while she had been trying to find solution for extensive repairs for the car she had to drive 2001 Ford Taurus, after she lost her more functional Toyota Prius in car accident in Texas, where she traveled in hopes for finding cure and writer's retreat, in order to respond to invitation to provide extended coverage of declared by her cascade of discoveries with global impact. But she barely came out alive from the area with terrible pollution of air and water, that had measurable effect on the easily observe mental dysfunction among residents, resulting in variety of terrible impacts - from toxic mindset of senseless hostility among many to endangering lives poor road design...

After existing from the freeway, She ended up initially by the coast in vicinity of Santa Monica, where she was approached by employees of homeless assistance agency "People's Concern". After initial cordial welcome and offer of help, the case manager **Richard** suddenly and bluntly told traveling by the van team of medics led by Dr. King (from Venice family clinic VFM) to refuse assistance to Ms Gutman with her documented by expert MD DIAGNOSIS OF MCS. Dr King followed instructions, despite her begging to get her medical records about medical diagnosis of MCS from her provolone medical doctor, in order to navigate easier through this less known to medical professionals illness. Ms Rozalina was stunned by the fact, that Richard was blunt about the policy of his agency to avoid handling life threatening issues of this environmental illness, since it required solutions outside of the box, AS IF he could not grasp the duty for accommodation for this severe disability. She remained in complete disbelief and continued to come time after time to locations, where doctors came on regular basis and offered medical help to homeless populations, but NOT to her(!)... Instead, her efforts were dismissed with rude and cruel ridicule and deliberate(!) mischaracterization, portraying her to volunteer community members as "delusional", while abstaining from their duty for the logical action of obtaining her medical records with **documented MCS diagnosis by the expert medical doctor, despite tearful begging for help...** Despite trying to find resonance to intolerable suffering for a number of months, the senseless prejudice against Environmental illness dominated the minds of representatives of these agencies for handling crisis solutions. But the only way they offered to

help was under the shocking condition of fraudulent distortion of the real medical illness of high severity with irrelevant diagnosis of “mental dysfunction”, that would entail handful mistreatment of the problem as the result... And in addition to practicing blunt bias, they spread rumors and lies, trying to discredit the truth of their routine(!) malpractice, in evident in their documents policy. And that terrible false reputation was to prevent the Good Samaritans among the community from the sense of trust and openness to engaging with the suffering victim of illness, refusing to help with hopeless situation of being a hostage to cruelty in the position of medical care and crisis assistance for the most vulnerable populations among the society... Besides coming in person with desperate pleas for help, she wrote to one of the team members Jimmy Gallardo, who told her of her desire to help her, while proving the links to cited in her presentation sources of info on research re the danger of fragrance and the links of lacking capacity of detection of hazardous products to the rapidly rising rates of suffering from environmental illnesses - no matter whether people had the allergic reaction to chemical toxins, or not... But no reasonable answer followed again and again.

Meanwhile, when the time for her presentation at ISME Research Commission, part of the World Conference for International Society for Music Education came up in July 2022, she had no shelter, and no most basic facilities for being minimally productive in the complex academic pursuits. And yet, nevertheless, despite all odds and while overcoming pain and elemental challenges of inaccessible (due to fragrant cleaning aids) bathrooms, she did not quit, but pursued the task with global impacts of great urgency, initiated by Bach and his own strive for overcoming the suffering from human incivilities. In defiance of unlawful threats of bogus tickets from the biased rangers, she found a quiet corner in the local park, escaped from rape threat by another homeless man with criminal background... and found charging devices and managed to be operational and present on line in the time for her presentations... Her presentation's abstract stated in the title that she was searching for collaboration with colleagues. And in the private session of the board representative she explained how urgent and significant the global implications of her findings for all musicians and their audiences, along with her desperate **disability-related** need for collaboration to manifest lost to oblivion unique and still urgent for humanity lessons of Bach... ... (More details on this subject will be covered in the upcoming volumes.)

After many times of getting refusals for help with relevant to her MCS diagnosis, she stopped wasting her hopes for help from these official and appearing to be well equipped for help agencies with paid staff, vans and eager community support from volunteers... Many victims of MCS end their lives with suicide, due to the same hopelessness of institutionalized human rights violations that resulted from the complete disconnect of people with the emotional reality of the rising danger of anthropogenic, man-caused/made toxicity, leading to higher and higher rates of

environmental illnesses left unlabeled as such by medical industry... Sensory Complicity to toxicity due to maladaptive habituation caused by conformity pressure led to DEACTIVATED PAIN ALARMS TO TOXICITY from anthropogenic chemical hazards, allowed to become the fabric of our life(!) with often lacking alternatives... But, despite the despair, Rozalina Gutman managed to maintain far more difficult choice - of being alive and present in this society, dominated by normalized detachment from emotions and feelings, in order to deliver discovered by her precious musical message from Bach to unsuspecting of his true intentions millions of students of his scores, and with sobering but vital to learn lessons. She tried to remain faithful to the pledge given by her during another trying situation of being thirty minutes away from death from the forced toxic exposure, that took place on November 6, 2019 - the date in 1717 of Bach's false imprisonment. But since a lot of related distortions of Bach's legacy needed to be featured, the content demanded for the format of accessible on line ebook. And she finally manifested it! 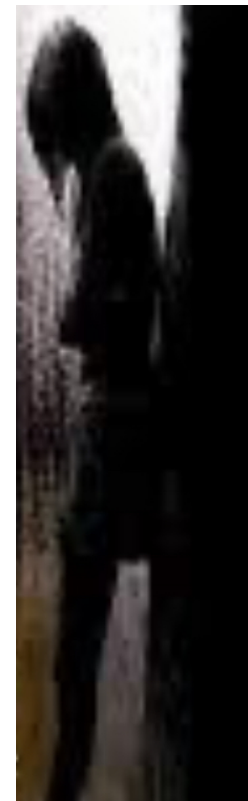
In the fall of 2024 Ms Rozalina Gutman started experiencing the impacts of deliberate targeting by police. She was given the false ticket, criminalizing her disability, when she explained to the cruel officer, that (while driving in a mask) she could not make the stop at the stop line, due to the gardener blowing leaves right there, instead having to stop for safety observation earlier... But this was just the opening for another nightmare: His ticket contained the address that she didn't know of and didn't initiate its use on her own(!) But when she tried to make sense of the fraud in the police system, **Her written report of federal crime of meddling with her mail was left with no response of any kind (!) by Malibu police.**

Furthermore, when she had to contact police for help for restraining vandalism to her car by the local teens, using racial slurs or derogatory meaning, she had to hear the rude refusal of the relevant response from Captain Carr. Then, she did get attention when she wrote the request for help, including the link to the tub for info provided for the media coverage for her new ebook. But no help followed anyway... And, while she began experiencing some more of respect to her opinion, she also became the subject of elevated to the next level retaliation from the police. She still received no response for investigation re the reasons why police had some POBox that was contrary to her listed on her license home address. Instead, she was bullied by police, unlawfully

threatening with false tickets. And once she **caught on camera nasty act of parking enforcement rep giving her false ticket, accompanied with verbiage of trying to excuse it with citing unlawful order to harass her, deliberately (!).**

And the same shift to new level of hostility instantly took place among employees of the park management, who began acting, AS IF Ms Gutman was “threatening them”, making bogus videos of trying to avoid speaking with her for no reason, but own wickedness, including installing scented toilet covers, not opening of bathrooms on time, or for the entire day, misusing leaf blower to harass her and subject her to potentially deadly for her threat, etc. However, due to trying to maintain her focus on the content of her scholarship, she had to avoid making most complaints, hoping for the end of hostilities and incivilities, while fearing for more retaliation, common and widespread cronies coverup and corruption, common among municipalities...

He was cruel in his misuse of authority insisting on the unlawful nature of such demands at the property with shared use by multipurpose shopping center. He demonstrated his odd understanding of advocacy by banning Ms Gutman from coming there for getting food(!) and using WiFi - contrary allowed for her use and invited by store manager, in consideration of her hardships...



However the injustice of refusing to disprove false accusations by filing her report for harassment followed the unlawful act of incrimination of her disability, but it was only a prelude to the deliberate and sophisticated character assassination. The day after she received a call from some homeless agency with the offer of “management of psychotropic drugs”, that she had no reason to use ever in her life. In response to the question re how they got her number, she heard rather surprising answer: *The referral was signed by Jimmy from People’s Concern*. Several days after he showed up and firmly denied any involvement with the issuance of referrals re Ms Gutman. But he refused to make a written statement with at least a text message. His supervisor **Tiffany Stewart** never responded to the repeatedly sent to her email inquiry re this act of character assassination by misuse of psychiatric terms.

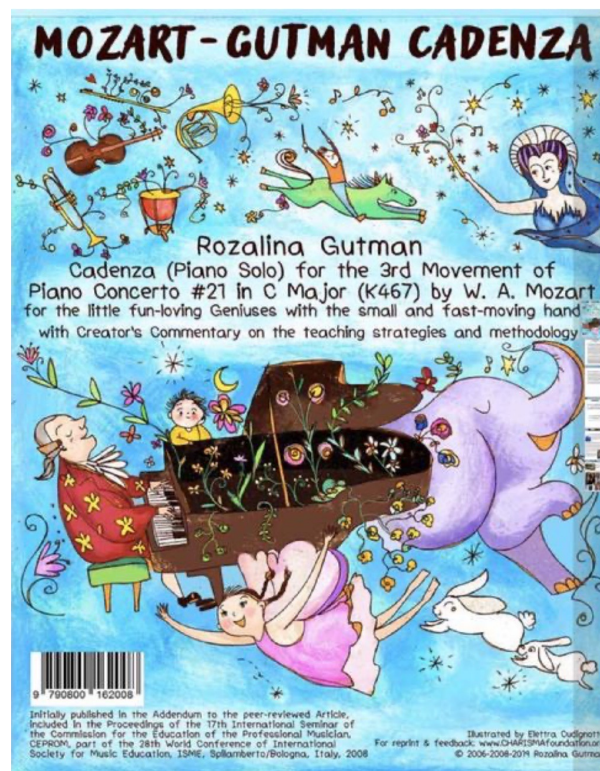
Jimmy promised to take care of my tickets, but nothing came out of it... After receiving the link re. Her radio interview speaking re. being cited by Rober Kennedy (see above link 🙌), Jimmy showed up again. And in the end of April he referred assistance to another case worker - Brianna Newitt. As the result of having to convey many of these and other issues, Ms Gutman spent endless amounts of hours, hoping that the promise for help would be fulfilled. But the above details and evident illustration demonstrate, that the problems were only

exacerbated instead, and culminated in retaliatory refusal to include citations to her MCS diagnosis into her fraudulent diagnosis of “mental dysfunction” giving permission to absolve required by law accommodations for her medically necessary health demands (even after Brianna agreed to get possession of it finally!).

▲ Declare the initiative for establishing the state of NO BUSINESS AS USUAL for the global collaboration of medical research facilities in the face of rapidly increasing numbers of the victims of various environmental illnesses, unlabelled in the past, by emphasizing their PREVENTABLE nature along with long and short term strategies for their prevention in partnership of political leadership of federal, state and local governance

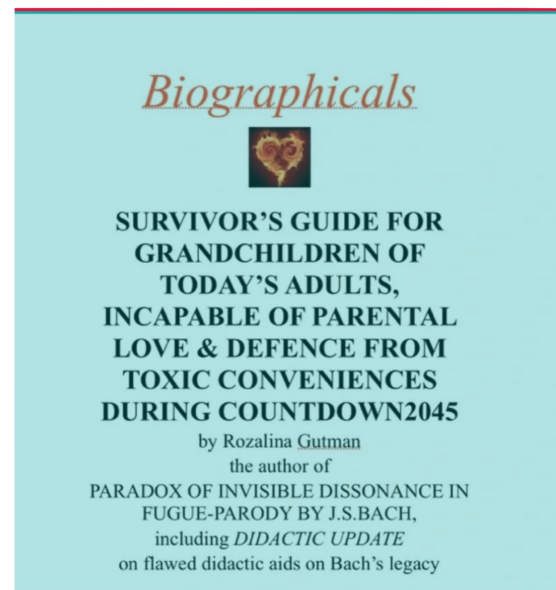

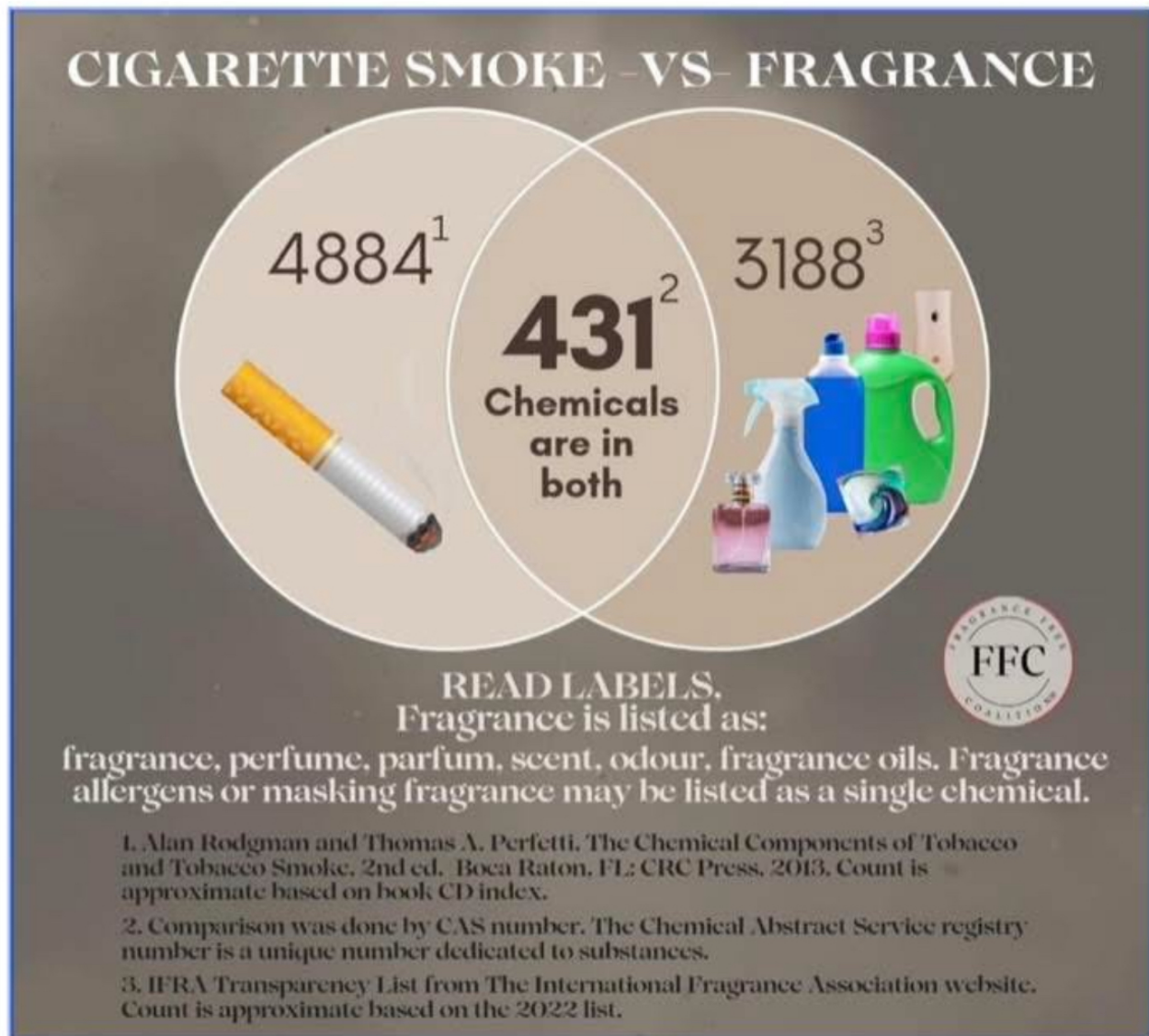
