## Open Records Request

To whom it may concern:

My name is Christopher Barnett, I am the President of Transparency for Oklahoman's, LLC. We are an Oklahoma Watchdog group, requesting information in the interest of the public. We investigate Government Corruption, waste, liars, thieves and everything else that takes place in our local Government.

I hereby submit my open records request to the Tulsa County Sheriff's Office on behalf of Transparency for Oklahoman's, LLC.

Under the Oklahoma Open Records Act, I hereby request

1. Please conduct a server wide search of the Tulsa County Sheriff's Office for any mention of Christopher Barnett, Chris Barnett, Trey Barnett, George Barnett, Chris Mangum or Christopher Mangum with a time period starting in January 01, 2014 to current date.
2. Please provide all request made to the Tulsa County Sheriff's Office by any Tulsa County Judges for additional security in their court room in relation to Christopher Barnett or George Barnett AKA Trey Barnett.
3. Please provide any request made to the Tulsa County Sheriff's Office by Judge Musseman specifically referring to a court hearing that took place on 10-17-2018. Please provide copies of any e-mails, written communications, any notes or otherwise and please tell us how many deputies were in the court room for case number No. CJ-2016-139.
4. Is it the official policy of the Tulsa County Sheriff's Office to use additional deputies to intimidate citizens who file legal actions in court even though there is nothing that warrants additional deputies or does the Tulsa County Sheriff's office routinely send 5 to 10 deputies to each hearing despite no need for it?
5. What was the cost to tax payers for the additional deputies that were present on 10-17-2018 during the hearing of CJ-2016-139 and what was the reason for the Deputies presence.

6. In regards to question #5, who requested the additional deputies and how were they requested? Please provide all details, including written, oral or electronic.
7. In regards to question #5 please provide the names of all Tulsa County Sherriff's Deputies that were present for 10-17-2018 hearing CJ-2016-139, the amount they are paid, how long they have been with the Tulsa County Sheriff's Office.
8. Please provide copies of any investigations or any files or complaints you have on file relating to Christopher Barnett aka Christopher Mangum for the time period of 01/01/2014 to current.
9. On January 04, 2018 the Attorney Generals Office abused their power and the Tulsa County Sheriff's Office illegally detained me under instruction from the Oklahoma Attorney Generals Office. Please provide all details, including any reports, text messages, emails, faxes or any communications from the Oklahoma Attorney Generals Office regarding this matter. Please provide me with the names of all deputies present for that hearing, case number No. CV-2017-832. Please provide the names of all deputies involved, the amount they are paid, any text messages or emails to any of the deputies involved in this matter and how long they have been with the Tulsa County Sheriff's Office. Please also provide me with a copy of their Tulsa County Sheriff e-mails for the time period of 10/01/2017 to current. This includes all emails. I am not seeking exempt information.
10. Please conduct a server wide search of all TCSO emails and servers for the racial slur "Nigger" for the time period start 01/01/2017 to current. Please provide all emails with a positive result.

I am requesting this information in the interest of the public. No search fee shall apply under Oklahoma Law.

Please provide the documents in electronic format where possible.
