Re: Open Records Request

My name is Christopher Barnett, I am the President of Transparency for Oklahoman's. We are a public interest watch dog group, investigating Government waste, corruption, and wrong doing in Government.

The information being requested is sought in the interest of the public and will be published on our website, www.transparencyforoklahomans.com. Per the Oklahoma Open Records Act, no search fee may be assessed for this request. We are happy to pay for any paper copies where electronic copies are not available.

I hereby request all emails sent or received by the Mayor of Henryetta with a start period of 01/01/2018 to current.

I hereby request all emails sent or received by the Police Chief of Henretta with a State period of 01/01/2018.

I request a copy of the budget for 2018 for the City of Henryetta.

If the Mayor or Police Chief have been issued City Credit Cards, please provide the last 14 months of Statements.

Please provide me with the city of Henryetta's contract or agreement with the Law Firm Hall Estill and exactly how much The City of Henryetta has paid to The Law Firm of Hall Estill with a start date of 01/01/2010 to current. Please provide copies of all canceled checks. You may black out the account numbers. Please provide a copy of all detailed billing from Hall Estill.

It is my understanding that Hall Estill negotiated a settlement on behalf of The City of Henryetta. Please provide the amount of the settlement and a copy of the settlement agreement. The City of Henryetta cannot keep this information confidential as it is tax dollars and public record, regardless of what any agreement states.

Please provide me with a copy of all e-mails sent or received from the email address cityclerk@cityofhenryetta.org for the time period of December 19, 2018 to December 27, 2018.

Please provide Transparency for Oklahoman's with all facebook messages received for The City of Henryetta's Facebook page, as well as the person who is in charge of the City of Henryetta's official facebook page. Please provide copies of anyone The City of Henryetta has blocked from using its facebook page or copies of any deleted messages.

Please do a server wide search on The City of Henryetta's computers for the search term "Transparency for Oklahomans" and "Christopher Barnett" or "Chris Barnett" for the period starting December 19, 2018 to current. Please provide all positive results in electronic format if possible.

Additionally, please do a server wide search on The City of Henryetta's servers for the search term "Nigger", "Homosexual", "illegals", "Liberals", "Guns", "Transgender". Please provide a copy of all positive results in electronic format if possible.

Please provide me with all emails sent or received to any employee at The City of Henryetta ending in @hallestill.com with a start date of 01/01/2014 to current.

I received a letter in the mail from the Henryetta City Attorney John M. Insabella stating I had to fill out The City of Henryetta's form to receive records. Please take notice that this is not a requirement of the Oklahoma Open Records Act. See International Union of Police Associations v. City of Lawton: "We first observe the ORA contains no provision dictating the manner in which to make a request for inspection of a record under the ORA." 2009 OK CIV APP 85, Paragraph 14. Additionally see AG opinion 06-35 says, "No commission or other state agency is authorized to adopt rules or policies that limit public access to meetings or records more than is provided in the Open Records and Open Meeting Act."

The City of Henryetta has adopted an illegal policy and the form in itself is illegal and discourages any ordinary citizen who does not know much about the open records act from requesting records as The City of Henryetta appears to be using fees to discourage citizen request. It does not tell the requestor that a search fee may not be assessed if the request is in the interest of the public or is requested by a

tax payer seeking to ensure that those entrusted with public affairs are doing their jobs faithfully and honestly. Please read the open records act. It is easily found online at www.oscn.net and you can also obtain a copy from The City Attorney as well as the Attorney General of Oklahoma free of charge. TFO will also provide this to The City of Henryetta at no cost upon request.

The City of Henryetta cannot adopt rules that go against Oklahoma State Law and that is what the form provided does. I urge The City of Henryetta to come into full compliance with the Oklahoma Open Records Act. I will not be filling out the form provided as it is illegal and my request contains all the information you need in it that your form would require. Additionally, a signature for open record request is not required. Oklahoma Law does allow for cities to charge for actual paper copies, however The City of Henryetta cannot charge for electronic records and this option is not available on your form. The Form looks like it has been used since the late 80's.

If The City of Henryetta does not comply with TFO's request in a timely manner, the request will be considered denied and TFO will file suit against The City of Henryetta, seek and obtain an injunction and a restraining order to stop the illegal policies implemented in regards to open records request and the form being used.

TFO will be working to obtain 500 signatures to empanel a Grand Jury to investigate the corruption taking place in Henryetta. How does a city of 5500 people spend \$9.5 million dollars to build a defective water plant?

Transparency for Oklahoman's request a copy of all information in regards to the \$9.5 million dollar water plant built, as well as a full accounting of all expenses, all emails, faxes, paper letters that pertain to the water plant as well as voicemails relating to the water plant that was built.

In addition to the letter received from John M. Insabella, he states that the City of Henryetta has not received any open record request from me. This is a lie and I've attached a copy of my request sent to The City of Henryetta via email and I also sent it via fax. Who isn't doing their job at The City of Henryetta?

Transparency for Oklahoman's also request a copy of all voicemails left for John M. Insabella that were left for him on his voicemail that pertain to The City of Henryetta Business. I also request a copy of all e-mails of John. M. Insabella sent or received from the date of December 19, 2018 to current regarding any City of Henryetta business conducted.
