

## State Championship Bracket Assignment Guidelines

*To be nominated you must meet the following criteria...*

1. WIAA, USA Lacrosse and WILOA Member in good standing (**has paid all dues**)
2. Complete USA Lacrosse Online Officials Training including passing NFHS Test
3. Must have complete uniform (Timer, Long/Short Sleeve Shirt, Black Jacket, etc.)

### Qualifications – Requirements

#### Regional Semifinals – 4 Games

- a. 5 Officials from Madison Area
- b. 5 Officials from Milwaukee Area
- c. 2 Officials from Bay Valley

#### Qualifications

- a. Crew Chief - Must have at least prior Quarter Final Experience
- b. U/FJ - Must have prior State Playoff Experience
- c. Must have completed USAL NFHS Test on time with a minimum score of 90 (all officials)
- d. Laredo 3 Official, or at least 5 games (including playoffs) using 3-man-mechanics experience
- e. Must be available at least 1 hour prior to game time
- f. Must have worked at least 6 Varsity Games in the regular season

NOTE - Assignor may ask for help as needed from other areas

## **Regional Finals - 8 Games**

- a. Primarily Assigned by Regional Assignors
- b. No more than 2 games for BVLA

### **Qualifications**

- a. Must have completed USAL Test on time with a minimum score of 85
- b. Laredo 3 Official, or at least 3 games (including playoffs) using 3-man-mechanics
- c. Must be available to be onsite 45 minutes prior to game time
- d. Must have worked at least 6 Varsity Games in the regular season

NOTE - Crew Chief – If possible assignor should ask for help from other areas to have some form of split crews

## **Sectional Finals – 4 Games**

- a. President / BOD Assigns
- b. 5 Officials from Madison, 5 Officials from Milwaukee, 2 Officials from BVLA
- c. State Championship Crew should be in this 12 and work together if possible

### **Qualifications**

- a. Crew Chief –Laredo 3, or have worked at least 2 years of State playoff quarterfinals or better.
- b. U/FJ - Must have prior State Playoff Experience
- c. Must have completed USL Test on time with a minimum score of 90
- d. Laredo 3 Official, or at least 5 games (including playoffs) using 3-man-mechanics experience
- e. Must be available at least 1 hour prior to game time
- f. Must have worked at least 6 Varsity Games in the regular season

## **State Semifinals – 2 Games**

- a. 3 Officials from Milwaukee
- b. 2 Officials from Madison
- c. 1 Officials from Bay Valley
- d. State Championship Officials Should be avoided – or 1 official from crew on each game
- e. Crew Chief for State Championship should not work

### **Qualifications**

- a. Crew Chief – Have worked at least 2 years of State playoff quarterfinals or better.
- b. Must have completed USL Test on time with a minimum score of 90
- c. Laredo 3 Official, or at least 5 games (including play offs) using 3-man-mechanics
- d. MUST be available at least 1 hour prior to game time
- e. Must have worked at least 8 Varsity Games in the regular season

## **1. State Championship Game**

- a. 2 Officials from Madison, 1 Official from Milwaukee
- b. Madison/Milwaukee - Crew Chief
- c. BVLA – CBO/Alternate
- d. 3 On Field Officials– Should have worked at least 1 State Championship Playoff
- e. Game and 1 Invitational Tournament Game Together, if possible

### **Qualifications**

- a. Crew Chief – worked at least 3 years of State playoffs – with prior State Semifinal Experience or better.
- b. Laredo 3 Official, or at least 5 games (including playoffs) using 3-man-mechanics  
Must have completed USAL Test on time with a minimum score of 90
- c. MUST be available at least 90 Minutes Prior to game time
- d. Active NILOA Official or Must have worked at least 8 Varsity Games in the regular season
