- Spoke with Treva Louive from Tanner Real Estate. Property at 22669 Railroad St. that burned is on the market for \$14,900-. Ms. Louive is getting bids for cleanup. Took it off our demo list. Neighbor called for update. I gave info.
- Fire Chief, Mike Springer wants us to know that any house in the township that the fire department can use for training would be of assistance to them. Not burning-just cutting roofs, breaching doors, etc.
- Prepared updated list of nuisance properties for Special Public Meeting with trustees on 05-14-2024. Trustees discussed at length and made decisions on which properties to prioritize. I followed through with trustees' directives with appropriate letters/cleanup quotes, etc. Edited spread sheets to reflect changes.
- Requested and received Fire Inspector's Report on the following properties recently declared to be a nuisance utilizing ORC 505.86 by trustees:
   22920 Lexington Rd. and 19601 North Benton West Rd. Chief Springer recommended demo for both.

- Requested lien searches from Title One in Alliance on above named properties along with 4 parcels declared to be a nuisance under 505.87. (303 N. Mahoning and the 3 parcels on Stanley owned by Parlontieri.
- Spoke with daughter of deceased property owner of 22920 Lexington Rd.- She states that the property has been tied up in probate court for 3-4 years.
