Declaration of Necessity and approval of Township Road Improvement

Declaration of Necessity

BE IT RESOLVED THAT, the Board of Trustees acting without a Road Petition, for the public convenience and welfare declares it necessary to make a Road Improvement to the following Township Roads:

SEE ATTACHED LIST OF TOWNSHIP ROAD – EXHIBIT “A”

Unanimous Vote of Approval Required

BE IT FURTHER RESOLVED that the Board by unanimous vote approves the construction, reconstruction, resurfacing or improvement of said Township Roads; and

Request for Plans & Specifications from Engineer

BE IT FURTHER RESOLVED that the Board of Trustees direct the Mahoning County Engineer to make such surveys, plans, profiles, cross-sections, estimates and specifications as are required for the improvement and to transmit the same to the Board of Trustees; and

Payment of Costs of Road Improvement

BE IT FURTHER RESOLVED That the cost of the Road Improvement shall be paid from any funds in the Township treasury available for that purpose; and

Advertisement and solicitation for Public Improvement Bid

BE IT FURTHER RESOLVED, That upon the Township's receipt of the Engineer's road improvement plans, specifications and estimates, the Township Fiscal Officer is hereby directed to advertise for bids once, not later than two weeks prior to the date fixed for the letting of contracts, in any newspaper of general circulation within the Township. Said notice shall state that copies of the surveys, plans, profiles, cross-sections, and specifications for such improvement are on file with the board available for inspection and copying and shall further state the date and time which the bids will be received.




