

# AEMT

(Advanced Emergency Medical Technician)

## Initial Certification Policy



**PURPOSE:** To establish requirements necessary for all applicants seeking certification and authorization to be credentialed and practice at the Advanced Emergency Medical Technician level in West Virginia.

**POLICY:** To ensure consistent standards and procedures for certifying as an Advanced Emergency Medical Technician (AEMT) in West Virginia.

**PROCEDURE/REQUIREMENTS:**

- A. Create a valid WVOEMS account utilizing Image Trend.
- B. Create a valid National Registry account.
- C. Possess a current National Registry or National Registry SLO AEMT certification.
- D. Educational Requirements:
  1. Complete an AEMT Education Program through an institution accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) in a manner prescribed under the Accreditation of EMS Programs (CoAEMSP).
  2. Successfully complete and pass all practical skills examinations for the AEMT level of certification as outlined by WVOEMS utilizing approved skills evaluators.
  3. Successfully complete and pass all cognitive examinations with a certifying score for the AEMT level determined by the National Registry cognitive examination.
  4. Successfully complete the WVOEMS approved AEMT Scope of Practice Modules expanding the scope of practice in West Virginia. These hours are additional to the National Registry program but may apply congruently if conducting a joint AEMT/Paramedic Program.
    - WV AEMT Cardiology Component (20 Hours)
    - WV AEMT Pharmacology Component (50 Hours)
    - WV AEMT Clinical Component (124 Hours)
    - WV AEMT Field Component (76 Hours)
  5. Successful completion of ACLS (or equivalent WVOEMS approved course). *Certification card required.*
  6. Successful completion of PHTLS or ITLS Course (or equivalent WVOEMS approved course). *Certification card required.*

7. Successful completion of PEPP or PALS Course (or equivalent WVOEMS approved course). *Certification card required.*
8. Successfully complete Hazmat Awareness training meeting OSHA 1910.120 or higher standards.
9. Successfully complete WVOEMS approved MCI Awareness and Operations Training (6 hours).
10. Successfully complete an approved CPR Training course meeting WV §64 CSR 48-6.7.a.4 at the professional/healthcare provider level.
11. Successfully complete the current WVOEMS Protocol course for the appropriate level of certification being sought.

**E.** Apply for certification by completing an application in your Image Trend account.

**F.** Submit the appropriate fees as required in WV §64 CSR 48-6.8 and 48-6.9.

**G.** Be 18 years of age or greater.

**H.** Disclose any limitation or exclusion by any EMS Agency, EMS Medical Director, or any other healthcare professions certification or licensing authority in any state, territory or the U.S. Military Services.

**I.** Apply for and be cleared by the State and National background checks for WVOEMS as required in WV §16-4C-8.1.1.

**J.** Proof of education shall be verified through your Image Trend account and shall be subject to audit at any time during the certification process or during an active investigation.

**K.** **Important Notice:** An EMR/EMT/AEMT/Paramedic certified by WVOEMS must be continually certified by the National Registry of Emergency Medical Technicians (NREMT) during the duration of your WVOEMS certification. Failure to retain uninterrupted National Registry Certification will result in the immediate suspension of your WVOEMS certification and your right to practice in West Virginia.

**L.** Meet other requirements established by the Commissioner.

This policy replaces all policies for AEMT initial certification prior to April 1, 2025.
