



#### THE BADASS GRANDMAS MOVEMENT

Reflections from a BadAss By Dina Butcher



It seems only appropriate, having the honor of being BadAss Grandma #1, that I explain the origins of and controversary around the name of our movement. In 2018, I was part of a group working to pass Measure #1, a constitutional amendment to establish an ethics commission and more transparency on campaign financial reporting. My grandson's friend saw a brochure used in the campaign and asked, "Is that your grandma on that brochure?" When my grandson acknowledged it was indeed me, his friend said "Wow, she's badass."

In campaigning all over the state as members of North Dakotans for Integrity we proudly wore our shirts and hoodies emblazoned with BADASS Grandmas for Democracy. Our detractors often criticized our name as "undignified" and "vulgar." After one of those criticisms, I noted that there are two kinds of people in every community: 1) Those who get involved and get things done, aka badasses; and 2) Those who criticize and undermine what

others are doing... tightasses. Case settled! It was around that time that in order to make ourselves more acceptable to our critics we began wearing lots of pearls with our badass shirts and sweatshirts.

When the measure passed by a goodly margin in November of 2018, we to requested a trademark for our movement under the name BadAss Grandmas.

We did not want to become yet another IRSapproved, not- for-profit organization seeking time, talent and treasure from the good folks (bad asses) already working in their communities to preserve our democratic way of life.

So, we innocently applied to then Secretary of State, Al Jaeger, and we were **denied**! Fortunately, we had a wise and competent lawyer, Greg Stites, who many of you may know as Nancy Guy's husband, representing North Dakotans for Public Integrity. His attached letter explains *for all time* why badass is not "vulgar or offensive to good taste or decency." We were honored to read this letter at his memorial service in 2022. RIP, Greg!

So, here, should anyone ask, is the reason we are trademarked with the state of North Dakota as BadAss Grandmas:

Dear Secretary Jaeger:

I have been retained to represent BadAss Grandmas regarding its recent filing for a trademark.

**BadAss Grandmas for Democracy** 

BadAss Grandmas filed a request for a trademark pursuant to NDCC Chapter 47-22. Your office has refused to register its mark stating that the "Secretary of State may refuse to file a document with a proposed business name that may carry connotations that are offensive to good taste and decency, including a name with words or phrases that are vulgar, or that may be offensive to the general public or to a group of people." I assume your office believes that "BadAss" is the offending term and not "Grandmas."

While your office's basis for refusing to register the mark appears legally inconsistent with any of the statutory language in NDCC §47-22-02 that purports to permit non-registration on certain grounds, I am assuming your office believes that a "BadAss Grandmas" mark would be "immoral .... or scandalous." If necessary after review of this letter, please confirm that NDCC §47-22-02(1) was the basis for your office's refusal to register the mark.

A "BadAss Grandmas" mark does not consist of or comprise immoral or scandalous matter. Further, even if your office's stated reasons for nonregistration were legally permitted, which they are not, a "BadAss Grandmas" mark is not offensive to good taste and decency, nor is it vulgar or offensive to the general public.

The Merriam-Webster Dictionary defines "badass" as "of formidable strength or skill". The Cambridge Dictionary defines "badass" as "someone or something that you admire or find impressive," as in "this car is pure badass" or "you look badass."

Neither dictionary classifies "badass" as being remotely immoral or scandalous in nature. The term "badass" is commonly used and accepted in society and has become part of many registered business names approved throughout the United States. In fact, a close review of the websites of many other Secretary of State Offices reveals that "badass" and "bad ass" has been approved as part of a business name and trademark on many occasions. And many, if not all, of the States have similar statutes to North Dakota for non-registering of business names and trademarks.

I could list many other States that have registered "badass" or "bad ass." In fact, every other State I checked in allowed "badass" or "bad ass" to be registered on the basis that the term is not immoral or scandalous in nature.

By way of background, I wish to bring to your attention the recent United States Supreme Court case of Iancu, Under Secretary of Commerce for Intellectual Property and Director, Patent and Trademark Office v. Brunetti, No. 18–302, 588 U.S. \_\_\_\_, decided on June 24, 2019 ("Brunetti"). The Court held that the government cannot make judgements on what is moral. Brunetti was thus allowed to obtain a Federal trademark for a clothing line displaying the word "FUCT."

In Brunetti, the Court struck down the Lanham Act's prohibition on registration of "immoral [] or scandalous" trademarks holding it a violation of the First Amendment. Because NDCC §47-22-02 uses the exact language from the Lanham Act for refusal to register marks, it is clear that the North Dakota Secretary of State no longer has the authority to refuse registration of immoral and scandalous marks.

It is for all these reasons that I respectfully request that your office rescind its refusal to register the mark of "BadAss Grandmas."

#### **Citizenship Ceremony in Minnesota**


Thursday, July 18, 2024 - 9:15 AM to 3:30 PM Union Depot 214 4th Street - East Saint Paul
