B. Confidentiality Policy

All life coaching and program-related communications, records, and contacts with others will be held in strict confidence. Information may be released, in accordance with the laws of the state of Michigan, and/or the policies of Higher Heights Coaching, as follows:

- 1. If I/we sign a written release of information indicating informed consent to such release, and then only to those I so designate; and/or
- 2. If I/we express serious intent of personal harm or another person, and/or
- **3.** If there is evidence or reasonable suspicion of abuse against a minor child, an elder person 65 years or older, or a dependent adult, and/or
- **4.** If there is evidence demonstrating a gross distortion of reality or the ability to function in normal daily routines, and/or
- **5.** If a subpoena or other court order is received directing the disclosure of information.

It is our policy to assert either "privileged communication status" in the event of **5.** above or maintain the right to consult with clients, if possible, barring an emergency, before any mandated or requested disclosure in the event of **2.**, **3.**, or **4.** above. Any release of confidential information other than as the result of a direct subpoena by a judge or court of law will be processed in consideration of the best interests of the client.
