You received this SMM/Prospectus Supplement because you are eligible to participate in the BSSP. The changes described in this SMM/Prospectus Supplement relating to a certain investment option may or may not affect your investment portfolio under the BSSP, depending on your past, current, and future contributions and investment elections. All active and former employees who are eligible to participate in the BSSP are provided with this SMM/Prospectus Supplement, irrespective of their current investment elections or the allocation of funds within their investment portfolio, and should review the information provided herein, as well as in the BSSP SPD, before making any future investment decisions.

You should review this SMM/Prospectus Supplement and your BSSP SPD in its entirety so that you can understand the details of the BSSP, as applicable. HIGHLIGHTS

This SMM/Prospectus Supplement describes significant changes to the ["BellSouth Savings and Security Plan"](#) SPD since the last restatement of the SPD in July 2022.

These changes include the removal of the Balanced Fund at close of business on Oct. 31, 2022, and information on how your money will be invested after that date. You have the right to change your existing election before the change becomes effective. See the ["Investment Options"](#) section for more information.

INVESTMENT OPTIONS

Effective as of market close on Oct. 31, 2022, the Balanced Fund investment option will cease to be available under the BellSouth Savings and Security Plan (BSSP).

As a result of these changes:

- Any existing moneys invested in the Balanced Fund at close of business on Oct. 31, 2022, will be transferred to the applicable LifePath Fund based on your date of birth; and
- Any future contributions that you have elected to invest in the Balanced Fund after Oct. 31, 2022, will be invested in the applicable LifePath Fund based on your date of birth.

Remember: You may change your existing investment allocations and/or your investment elections for future contributions at any time. You can also rebalance your account by executing an exchange or rebalance. See the ["Changing Your Investments"](#) section of your BSSP SPD for additional information on these type of account transactions.

In connection with this change, effective as of market close on Oct. 31, 2022, the ["Investment Options"](#) section of the BSSP SPD is revised to delete the Balanced Fund from the list of available investment options, and to delete all other references to the fund from the BSSP SPD.
