The Writer agrees that he/she will not be entitled to any compensation or other such consideration as a result of any use by the Producer, its successors, assigns and affiliated and related entities, of any such similar or identical submissions developed independently of the Writer’s submission and/or Material.
  
- 5) If the Producer determines in its sole discretion that the Material does not meet its criteria, the Writer agrees that the Producer is under no obligation to produce any motion picture, project, or portion thereof, based on such Material.
  
- 6) The Writer agrees that the Producer is under no obligation to return submitted materials to the Writer and the Writer agrees to release the Producer from any liability for loss or other damage to the copy(ies) submitted.
  
- 7) Either party to this Agreement may assign or license its rights hereunder, but such assignment or license shall not relieve such party(ies) of its obligations. This Agreement shall inure to the benefit of the parties hereto, their heirs, successors, representatives, assignees and licensees – and any such heir, successor, representative, assignee or licensee shall be deemed a third party beneficiary under this Agreement, if and where applicable.
