Setting the Goals

Since the election, we have been presented with a new team of ministers, shuffling of Deputy ministers and now waiting on Legislature Committees. At the dissolution of the legislature on May 1, 2023, the committees were as follows:

- Alberta Heritage Savings Trust Fund
- Alberta's Economic Future
- Families and Communities
- Legislative Offices
- Members' Services
- Private Bills
- Privileges and Elections, Standing Orders and Printing
- Public Accounts
- Resource Stewardship

These committees are going in depth on policies and bills, prior for every law and program to be voted on at the legislature. Our role as lobbyists, is to keep an eye on these committees and to prepare presentations for the different committees in favour of our client's. This is one of the part of a lobbying activity that is quite cash-intensive as it requires to hire experts, interview professionals and prepare multimedia content to "campaign" to the committee members.

In the Alberta Free Inc. model, this expensive venture translates in the need to get Stakeholder clients. Without these clients, our projects are not able to be presented with the same intensity than the projects of the large corporations and globalists who have almost unlimited funds to promote their client's cases.

- **Alberta Based Servers:** We want to set up physical servers located on Alberta Territory to host websites, mail, IP phone services, Cloud service, to create an Albertan Extranet to protect us from Bill 11 and Bill 18 aimed at controlling the Internet...
- **Alberta Hydrogen Distribution Network:** An Alberta Hydrogen Network will generate investment from truck manufacturers who will set shop in Alberta, to construct Class 8 Fuel Cell Hydrogen electric trucks...
