Instructions: ALL skaters under 18 must have a parent or guardian join with them.

All applications are subject to the review and approval of the JVFSC Board of Directors. After Board approval, membership information is submitted to the US Figure Skating Headquarters in Colorado Springs, CO, and a USFSA number is assigned to each member. All applications received after June 30th will incur a \$10 late processing fee.

Membership Categories

Adult Skater: Home club for skater age eighteen (18) and over. Has all club privileges.

Introductory Member: First time US Figure Skating Members. If skater is under the age of eighteen (18) years, a parent or legal guardian **MUST** join also. If the family has more than one skater under age eighteen, you may add additional Family Members. Skaters under the age of eighteen have all club privileges except voting or holding office. Parents/guardians have all club privileges.

Family Member: Home Club for one skater under the age of eighteen years and parents or legal guardians. If family has more than one skater under the age of eighteen, may add Additional Family Members. Skaters under age eighteen have all club privileges except voting or holding office. Parents/guardians have all club privileges.

Collegiate Member: Four-Year full membership at a reduced rate for college student skaters.

Professional Member: Skating professionals over age eighteen years who designate Jordan Valley FSC as their Home Club have all club privileges except that only one Professional Member shall be allowed to serve on the board of directors at any time.

Patron Member: Non-skaters age eighteen (18) and over. Has all club privileges except that of skating.

Associate Club Member: Members who hold Home Club membership in a US Figure Skating Club other than JVFSC shall have all club privileges except voting and holding office.
