**ACKNOWLEDGMENT OF RISKS**: I understand and acknowledge that the activities I am about to engage in bear certain known risks and unanticipated risks which could result in injury, death, illness, or disease, physical or mental, or damage to myself, to my property, or to other third parties.

RELEASE AND WAIVER OF LIABILITY: I, for myself, my heirs, next of kin, assigns, and personal representatives, do hereby release, waive, discharge, and covenant not to sue Invite Retreats, its directors, officers, employees, volunteers, agents, and other participants (collectively, the "Releasees") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me, or to any property belonging to me, while participating in such activity, while in, on, or upon the premises where the activities are being conducted.

**INDEMNIFICATION**: I agree to indemnify, defend, and hold harmless the Releasees from and against any and all losses, liabilities, claims, obligations, costs, damages, and/or expenses whatsoever paid, incurred, and/or suffered by the Releasees, including any attorney's fees and any and all costs of litigation that the Releasees may incur as the result of the death or injury to person or damage to property, or violation of any applicable laws and regulations.

INTERNATIONAL TRAVELS: I acknowledge and comprehend, the liability for any incidents or accidents that may occur during an international trip shall lie solely with the individual traveler. Invite Retreats and our affiliates shall not be responsible or liable for any loss, damage, injury, or death resulting from the traveler's or decisions. It is the sole responsibility of the traveler to ensure their personal safety, including obtaining appropriate travel documents, following local laws and customs, and purchasing adequate travel insurance. Invite Retreats reserves the right to cancel or modify the itinerary at any time and shall not be held liable for any resulting inconvenience or expenses incurred by the traveler.

**MEDICAL TREATMENT**: I understand that the Releasees may not have medical personnel available at the location of the activities. I grant the Releasees permission to authorize emergency medical treatment, if necessary.
