6. Presentation

a. 2022 Audit Review – Randy Meder, VMD and Associates covered how the NMDC and LDFA work together. General funds are from the NMDC and LDFA are recognized as special funds (restricted). R Meder review the Management Letter, I-69 Audit Report 2022, and I-69 SAS 114 2022. The spend down for 2022 can be viewed on page 11 & 12 on the Audit. The year end 2022 is \$69,607 and \$45,950 restricted funds. R Meder covered what they are auditing. The Management letter states their opinion is a clean audit for 2022. They are giving a standard audit comment, no additional comments to communicate to management. Meder commented on the 2 issues stated in the I-69 Management Letter. Meeting minutes referred to Dewitt & Lansing wanting to join I-69 Trade Corridor, nothing followed through with this directive in the minutes of NMDC. Governance needs internal controls put in place to address this in the future. M/M Booth, S/J Horvath moved to accept the 2022 Audit as presented. All ayes passed.
