PUPPY SWEEPSTAKES: The Puppy Sweepstakes is open to all Irish Setter Dogs & Bitches who on the day of the show will be over 6 months of age and under 18 months of age. All dogs entered in the Puppy Sweepstakes must be entered in the Regular Classes at this show. Indicate "Puppy Sweepstakes" in the space for Additional Classes (include age division). **Puppy Sweepstakes** will be as follows in both sexes: 6 months & under 9 months; 9 months & under 12 months; 12 months & under 15 months; 15 months & under 18 months.

VETERAN SWEEPSTAKES: The Veteran Sweepstakes is open to all Irish Setter Dogs and Bitches who on the day of the show will be at least 7 years of age. Neutered dogs and spayed bitches may be entered in Veteran Sweepstakes. Winners of the Veteran Sweepstakes Classes will compete for Best in Veteran Sweepstakes and Best of Opposite in Sex to Best in Veteran Sweepstakes. Veteran Sweepstakes entrants do not need to be entered in another class at the show. Entries shall be made on the same entry form as for Regular Classes. Indicate "Veteran Sweepstakes" and the appropriate age and sex in the space designated "Additional Classes." **Veteran Sweepstakes Classes** will be as follows in both sexes: 7 years and under 9 years; 9 years and under 11 years; 11 years and older.

SAT OBEDIENCE TRIAL CLASSES (Irish Setters Only)

Females in season are not permitted to compete. If a female is withdrawn from competition because it came into season and the event secretary is notified no later than one half hour prior to the start of the first class in the trial, the club is required to refund the entry fee. The club may retain a processing fee and must publish this information in the premium...." In accordance with this regulation, the club will retain \$10.00 of the entry fee and refund the remainder to the exhibitor.

SUNDAY JUNIOR SHOWMANSHIP CLASSES

NOTE: Effective January 1, 1989, AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club. (919) 854-0195.

NOVICE CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: This shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class in a licensed or member show, with competition present. The winner of a Novice Class shall automatically become eligible, upon notice to the Open Class ring steward, to enter and compete in the Open Class at the same show provided the win is the third (3rd) first place award with competition and further providing there are one or more Junior Handlers competing in the Open Class.

MASTER CLASS: For boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the ten (10) first place wins in an Open Class with Competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 thru October 31 of the following year. All juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

At an independent breed specialty when there is no competition beyond Best of Breed, a dog or bitch 7 years or older that has been neutered or spayed may compete in the Veteran classes.

Versatility-Hunter Dog and Versatility-Hunter Bitch: Shall be limited to class for dogs and class for bitches that have attained a Versatility Certificate, or Versatility Excellent, Junior Hunter, Senior Hunter, or Master Hunter Title.

Best of Breed Competition

There will be a special competition for best bred by exhibitor in Irish Harvest Specialties after the show. This will be for all the winners of the bred by classes of all three days.

Judged by breeder judge, Christine Boutwell Perry, MD

Winner shall receive a rosette & a commemorative plaque

donated by the Ramblin' Red Irish Setter Family

in memory of BIS Am. Can. Ch. Ramblin' Red Fortune Teller aka Gypsy.

DIRECTIONS TO SHOW

I-84 East to Exit 67. Turn left at the light at the end of the exit ramp onto Route 31 north. Go to 2nd set of lights. Turn right onto Route 30 (Hartford Turnpike). Tolland Agricultural Center grounds are app. 0.25 mile on the right directly past the Rockville Bank. **I-84 West to Exit 67.** Turn right at the end of the exit ramp onto Route 31 north. At the next set of lights turn right onto Route 30 (Hartford Turnpike). Tolland Agricultural Center grounds are app. 0.25 mile on the right directly past the M&T Bank.

AKC National Owner-Handled Series (NOHS)

AKC National Owner-Handler Series is a non-titling competition created in direct response to Owner-Handlers' desire to compete against other Owner-Handlers. Owner-Handlers will still enter and compete in the regular classes to win Best of Breed. Then, just before the regular class judging is complete, the recognition of Owner-Handler Best of Breed will be awarded.

Determining Exhibitor Eligibility: The first step in judging the AKC National Owner-Handled Series is determining exhibitor eligibility. Follow these tips to properly make the eligibility determination:

Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form.

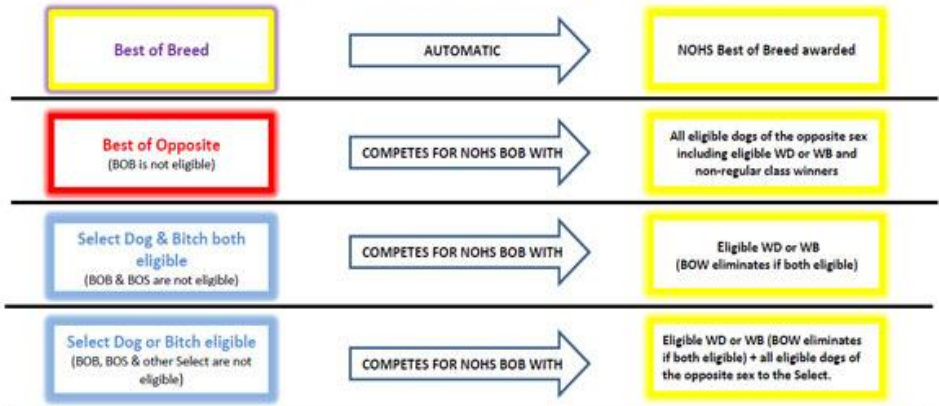
- * The handler must be an owner of record according to the AKC's records as of the date of the show.
- * Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog.
- * Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.
- * Dogs must be handled by an owner-handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC National Owner-Handled Series competition.
- * The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

Designating NOHS Best of Breed



Once the judge has awarded BOB/BOV, BOW, BOS and Selects

- Steward should compare the eligible entries against the awards
- Advise the judge of the awarded dogs indicated as eligible to compete (*) in the AKC National Owner-Handled Series (NOHS)
- Determine by the flow chart which entries remain in the ring for the designation of NOHS Best of Breed



If none of the above awards (BOB, BOS, Select Dog, or Select Bitch) are indicated as eligible, judge is to award NOHS Best of Breed from any eligible dog competing for Best of Breed, including WD and WB. BOW will eliminate the Winners of the opposite sex automatically.

Dogs must be entered in the NOHS Competition to be eligible for NOHS Best of Breed. (Indicated by an "**") Only those dogs indicated by an asterisk (*) and eligible to compete for NOHS BOB (entered in BOB, move-ups, 1st place non-regular, WD & WB) are eligible for the NOHS award. Eligible Select DOES NOT automatically eliminate eligible same sex Winners.

after which time entries cannot be accepted, cancelled, or substituted as provided for in Chapter 11, Section 6 of the Dog Show Rules. Telephoned and telegraphed entries are not accepted. All changes, additions or corrections must be received in writing or Email prior to closing.

ENTRY ERRORS, REFUNDS: Entries not on official AKC Entry Forms and photocopies of entry forms without the Agreement and Rules on the reverse side of the official AKC entry form are not acceptable. Entries will not be accepted without fees or signatures. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. No refund for duplicate entries; we will make every effort to find all duplicate entries but, if an entry has been processed, no refund will be made. Entry Fee will not be refunded in the event that a dog is absent, disqualified, excused by a Veterinarian or Judge, or barred from competition by the Show Committee. If, because of riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry will be made. Returned checks do not constitute a valid entry fee. The Show Secretary will add a **\$30.00** collection fee to each returned check.

ACKNOWLEDGEMENT: Acknowledgment of entries and a Judging Program will be made as soon as practical after entries have been closed; should such acknowledgment not be received within a reasonable time, notify the Show Secretary at 401-739-5968 or email SJShowSec@aol.com Consult Judging Program for time of judging.
