- Appointment with Dr. Williamitis to see if you meet at least one of the qualifying conditions
- Fill out the Patient Information sheet, so the staff at the office can enter your information into the registry

YOU NEED THE FOLLOWING THINGS FOR THE APPLICATION PROCESS

Photo ID (approved passport photo, if done on line they may use your Florida Driver's License Photo

Proof of Florida Residency

Method of payment (75.00) if done online pay by card, if done by mail pay by check

ELECTRONIC APPLICATION

Retrieve your login in from the e-mail that was sent from Florida Health Dept. (You may need to check your spam mail) the e-mail was sent to the address you gave the office, on the information sheet. **IF YOU CAN'T FIND THE E-MAIL PLEASE CALL 1-800-808-9580**. This number can help you
