I understand and agree that I am solely responsible for any harm or injuries that occur while my Pet(s) is/are attending Dog Walking/Boarding/Home visits. I certify that all information given to Sabrina's Dog Walk - Pet Service is correct and up to date and that I will inform the business if any changes occur.

PHOTO AND VIDEO RELEASE - We love to post pictures and videos on Facebook, our website, and/or in ads when the opportunity arises. Owner allows Sabrina's Dog Walk - Pet Service to take pictures and videos of their Pet(s) while in the care of the business and allows those images and videos along with the Pet(s) name(s) to be used for any form of media, marketing, advertising, illustration or other promotional materials without any form of compensation. Owner also releases all rights they may possess to these materials.

RELEASE OF LIABILITY - Owner understands and agrees that during normal play, Pet(s) may sustain injuries. Play is monitored by Sabrina's Dog Walk - Pet Service to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner understands and agrees that the business will not be liable for any illness, injury, death, and/or escape of the Pet(s), given that reasonable care and precautions were provided and

followed. Owner hereby releases Sabrina's Dog Walk - Pet Service of liability of any kind arising from or as a result of Owners Pet(s) attending the business.

PERSONAL PROPERTY - Owner understands and agreed that Owner is solely responsible for any harm, including other Pets, employees or invitees of Sabrina's Dog Walk - Pet Service, or to equipment and/or other property of the business caused by Owner's Pet(s). Additionally, Owner agrees that Sabrina's Dog Walk- Pet Service will not be responsible or liable for any lost or damaged personal property belonging to either Owner or Owner's Pet(s).

FOOD & MEDICATION - When boarding overnight, Owner agrees that it is Owner's responsibility to leave adequate instructions as well as the correct kind, and right dosage of medications for their Pet(s) for the business while Pet(s) is/are cared for by Sabrina's Dog Walk - Pet Service.

ADDITIONAL INFORMATION

- All Pets must have current vaccinations per their veterinarians' recommendations.
- Sabrina's Dog Walk - Pet Service can administer oral and topical medications only. Clear instructions for medication administration must be provided.
- We cannot guarantee that toys, blankets, or beds will be kept in the same condition as brought in.
- We can only accept house/potty trained dogs who do not mark. Please be considerate as services are provided in our home.
- I reserve the right to refuse services to any Client or Pet at any time for any reason. All Pet(s) must be non-aggressive; this includes general aggression and aggressive behavior towards animals and people, as well as aggression/protectiveness over toys, food, snacks, or treats. Owner verifies that Pet(s) has/have not harmed or shown aggressive or threatening behavior towards any person or animal, past and present.

PRICING

Dog Care: (each price listed counts for one dog)

\$15 20-minute Walk

\$45 Pet sitting without Overnight Stay - Your Dog stays at your home and will receive walks, love, and the care it needs here, rather than boarding at our house. This also means that your dog will be alone at night, Sabrina's Dog Walk - Pet Service will not stay overnight.

Pet sitting times end at the last agreed day at noon unless otherwise stated.

\$50 Boarding - Your Dog is staying the night at our home; they must get along with other dogs and cats and must be child friendly.

Sabrina's Dog Walk – Pet Service

Nightly rates are based on a 24-hour period from drop-off to pick-up.

The following extended care rates will apply for each Pet on the booking if the agreed time of the final day is reached and your Dog has not been picked up. If the pick-up time is later than two (2) hours of the agreed time, additional charges will occur. This ensures fair compensation for the additional time in our care.

- 2 – 7 hours + \$20
- 8+ hours + full nightly rate

Pick up and drop off window is no earlier than 7:30AM and no later than 8:30PM.

Cats and Other Pets:

\$15 House visits per Pet (price varies given the amount of work and number of animals).

Additional Charges:

These charges are rare and case by case and will always be disclosed to Owner if anything comes up.

All prices are case by case and subject to change, if need be, the business will always notify Clients of any changes or tweaks they need to make.

Payment is due at time of pick up or after service is fulfilled, unless otherwise agreed.
