## Announcements

Supervisor Spinzia announced that the Town of Ulster Supervisor, James Quigley, has proposed that Ulster and Rhinebeck work together with NYS Bridge Authority to enact a comprehensive solution to mitigate Kingston-Rhinecliff Bridge suicide attempts. Specifically, they want the Bridge Authority to earmark money for a capital plan, possibly to install either netting below the bridge or higher fencing along the walkway railing to reduce the growing number of suicides.

## Resolutions

The Town Board (TB) addressed 18 resolutions, passing all 18 unanimously. Below is a summary of the major resolutions addressed and passed. Other resolutions addressed by the board may be viewed on the town's website as noted in the opening paragraph.

**RESOLUTION 2025-194** – Rhinecliff Parking Plan.

Supervisor Spinzia announced that a public hearing on the proposed local parking law for the hamlet of Rhinecliff will be held at the September 29, 2025 TB meeting. **RESOLUTION 2025-195** – Resolution Introducing Proposed Local Law to Repeal Town Code Chapter 125, Article V, Section 125-61 *Et Seq.* Entitled "Short-Term Rentals" and Enact a New Town Code Chapter 125, Article XV, Sections 125-154, Entitled "Short-Term Rentals."

**RESOLUTION 2025-197** - Introducing Local Law No. \_\_\_\_ of 2025, A Local Law Amending and Strengthening Certain Enforcement Provisions of the Chapter 125 of the Town Code.

In recent years, the Town of Rhinebeck has experienced a disturbing volume of instances of property owners performing work on their properties without having secured the necessary building permits. There have also been instances where work on homes, businesses and properties is being conducted that do not match the plans approved by the Planning Board or the Zoning Board of Appeals (ZBA).

The Town Board desires to strengthen the enforcement provisions of the Zoning Law. This local law would provide amendments to a variety of provisions of the Zoning Law that strengthen the Town's ability to enforce its Zoning Law. This law also adds amendments to other provisions of the Zoning Law that will encourage applicants, seeking land use permits and approvals from the Town and its various boards and officials, to comply voluntarily with the Zoning Law and the procedures that have been established by the Town. A public hearing on this issue will take place at the September 29<sup>th</sup> TB meeting.

**RESOLUTION 2025-198** – Approve Jennifer Mund as Sole Town Assessor.

The TB approved a resolution reappointing Jennifer Mund as the sole assessor for the Town.

## **New Business**

Frank Mazzarella presented his plan for adding additional parking spaces at the rear of the all-purpose field at the Thompson Mazzarella Park. There was some discussion on this plan with Councilperson Kleitsch expressing his concern for the new proposal (See Resolution 2025-154, June 9<sup>th</sup> TB meeting for the original plan) due to its impact on the pastoral qualities of the park. Supervisor Spinzia and Councilpersons Walker and Scherr supported the proposed additional spaces. The TB came to the agreement to reduce the 68 existing parking spaces on the west side of the all-purpose field to 52 spaces. The proposed lot adjacent to the rear of the all-purpose field will add 42 parking spaces.
