Candidates responded to five questions in writing between June 14-23, 2022

What are the MOST important factors that drive your decision-making?

John Flynn (see page 2 for responses to the other four questions)

From a legal perspective I must rely on the rule of Law and the Constitution. I believe the Constitution should be respected and never legislated from the bench. I believe in the American judicial system and want to always serve our community with that in mind. I will make rulings based on the evidence that is put before me in accordance with the rules of evidence and the laws of the State of Florida. I have spent the last two decades protecting and defending the Constitution, which is the foundation of our legal system.

I understand the responsibility I will carry as a judge and that the decisions made shall produce equitable outcomes. My place as a judge will be to apply the law as it is and not to change or make new ones. I have the courage to do what the law requires as long as I am upholding the law. My practice experience gives me a well-rounded approach to making judicial decisions; decisions that will be based on the rules of law while setting aside personal beliefs. I will strive to serve the public with compassion while looking out for public safety.

The most important factors that drive my decision making is to first assess the issue, analyze and interpret the ambiguity to create clarity. I often ask myself the question, "Am I adhering to the rule of law?" I am an advocate for justice, fairness, and integrity. These factors, along with being mindful of particular social situations and the cultural differences drive my decision making.

In a judicial capacity my decisions are driven by the law and the constitution. A judge should be required to consistently follow the laws as they are written, as such I believe that should be the primary factor in a judge's decision making. On a personal level, my decision making is based on my faith in God. I believe in striving to make the best choices possible and to humbly accept responsibility for a poor decision, and work to make a better choice on the next one. I strive to make decisions with integrity, to do the right thing, even when no one is looking.

The most important factors that drive my decision making are my principles, preparation, and education. The principles of integrity, honesty, empathy, justice and fairness guide me daily in my personal and professional life. These are values I was taught from the time I was a young child, by my family, my church, and my teachers, and these are values that I am instilling into my own children.

I think it is very important to always be prepared. In my personal life, this may be in the context of planning my route to an event ahead of time so that I arrive early, or researching my children's schools before enrolling them. In my professional life, it means I always walk into the courtroom having thoroughly researched what statutes or case law apply to my case, having considered the other side's evidence and point of view, and having all of my arguments ready. As a judge, it means that no matter whether I am placed in criminal court, civil court, small claims court, etc., I will ensure I am well-prepared to handle all matters before me. I highly value education and believe there is always more to learn. Continuing education goes hand-in-hand with being prepared. The way I stay prepared and what helps drive my decision-making process is my education. As an attorney (and as a judge), I must stay current on changes in the law, whether legislative or through higher court decisions. It is important to me to continually read and research so that I know I am following the law faithfully.

What is your background, family situation, and community involvement?

I grew up in Georgia with a wonderful family that I am proud of. They taught me faith in God and the importance of education. What is your background, family situation, and community involvement?

I am the third of seven children, the son of a teacher and a college professor, and maintain a good relationship with my parents and siblings. My first job was as a paper boy at 13, and I consistently worked a variety of different jobs throughout my teens. I played varsity football and Recreational slow pitch softball and basketball during my high school years. I worked full time while earning my undergraduate degree from Boise State University. I worked in sales and management positions with some major corporations before attending law school. I went to Law School at Florida Coastal School of Law in Jacksonville. I earned my degree while working as allowed and raising three children. I have been married to my wife for over twenty years and have five wonderful children who have all attended or currently attend Polk County Schools. I am actively involved with my church, and previously have been involved with the Boy Scouts both as a leader and as a merit badge counselor. What is your background, family situation, and community involvement?

I am a fourth generation Polk County native and lifelong resident of this community. I graduated in 2004, cum laude, with a Bachelor's of Science in Business Administration. I taught English education at Lake Wales High School from 2004-2007.
