Serving as Engineering Service Division Manager, Bill was selected to be the Director of Utilities for the City of Sacramento. Managed the development services, regulatory compliance and engineering sections of the division and was responsible for budgeting, funding and delivery of services for that division. While manager Bill participated in the annual analysis of the full cost of services, integrating the cost allocated from the city's cost allocation plan and working both with in-house staff and consulting staff in the update of user fee calculations. During this time Bill represented his division on the Directors Executive Team working closely with the Director and other Division Managers to develop and implement many Department initiatives

REGULATORY COMPLIANCE SECTION SUPERVISOR - 2002-2012

Managed all aspects of regulatory compliance for the Department of Utilities including National Pollutant Discharge Elimination System (NPDES) and Waste Discharge Requirement (WDR) permit compliance for all water, wastewater and storm drainage activities. This included developing internal and external user fees to cover impact costs. During this time Bill served on the board of the California Stormwater Quality Association (CASQA) including two years as the chairman of that board. Also, during this time, Bill managed the Storm Drainage Capital Improvement Program including oversight of fee development and project delivery.
