# PRIVACY POLICY

This notice provides the privacy policy regarding the nature, purpose, use, and sharing of any Personally Identifiable Information (PII) collected via this website, 88mango.com.

Our privacy policy explains our information practices when you provide PII to us, whether collected online or offline, or when you visit us online to browse, obtain information, or conduct a transaction. PII may include: your name, email, mailing and/or phone numbers, or other information that identifies you personally. We do not require you to register or provide personal information to visit our website.



The PII you provide on a [88mango.com](https://www.88mango.com) website will be used only for its intended purpose. We aim to protect your information consistent with the principles of any relevant State and Federal legal statutes that protect your right(s) to privacy as a legal resident of the United States of America.

## Personal Identifying Information (PII)

As a general rule, 88mango media does not collect PII about you when you visit our website, unless you choose to provide such information to us. Submitting PII through our website, and any officially affiliated and managed accounts on social, business, marketing, and professional platforms, is voluntary. By doing so, you are giving 88mango media, and all relevant personnel, your permission to use the information for the stated and/or marketed purpose. However, not providing certain information may result in 88mango media's inability to provide you with the highest quality of service(s) you wish to contract/purchase.

If you choose to provide us with PII on the 88mango website and/or through our other online accounts on commercially available social, business, and professional platforms, through such methods as completing a web/contact form, or sending us an email, or other forms of communication and information disclosure and delivery, we will use that information to help us provide you the information or service you have requested, or to respond to your message. The information we may receive from you varies based on what you do

when visiting our site, or any officially affiliated/managed accounts on any relevant platforms.

Generally, the information requested by 88mango media will be used to respond to your inquiry, or to provide you with the service you request. When this information is requested, the reasons for collecting it are available via our website's relevant resources section.



# Automatically Gathered Information

We collect and temporarily store certain information about your visit for use in site management and security purposes only. We collect and analyze this information because it is information readily available via 88mango media's purchase of necessary and operationally relevant services from the Host site & Domain Seller, known as the GoDaddy company. The information readily available, via the features marketed and purchased from and through the GoDaddy Company, is consistently monitored for operational development & growth. The features their web and domain hosting services provide, help us to better design the website to suit your interests in our company and services. We may also automatically collect information about the web content you view in the event of a known security or virus threat. This information includes: - Please refer to the following respective platform's privacy & record collection disclosed policies: the GoDaddy Company, Instagram - Meta Company -, LinkedIn - Microsoft Company -, etc. The respective companies' services are employed by 88mango media to maintain operational integrity, and a professional, online, and commerce presence.

# Email Usage

Many of our programs and websites allow you to send us an email. We will use the information you provide to respond to your inquiry. We will only send you general information via email. You should be reminded that email may not necessarily be secure against interception. Therefore, we suggest that you do not send sensitive personal data (such as your Social Security number, Home Address, etc) to us via email, or any personal data that the 88mango media team and/or relevant professional personnel have not expressly discussed needs to be communicated and/or electronically mailed to our 88mango media official and necessary personnel/business email accounts. If your intended email communication is very sensitive, or includes information such as your bank account, credit card, or signed check, you should instead send it by U.S. secured mail services that require a signature upon delivery. Another alternative may be submission of data through a secure web page, if available.

Electronic messages that are not records that are needed for operational integrity, full and/or partial compensation resolution(s) and/or discussed are deleted when no longer needed.

Categories of information the 88mango media collects on its website and official accounts across various online/social/professional/marketing platforms are further described below.



## Websites and Applications from Third-Parties

The 88mango media company uses social media websites and other kinds of third-party websites, desktop & mobile applications. The 88mango media team, uses social media websites, desktop, and mobile applications to interact with patrons, potential patrons, supporters, and the general audience that may experience our media assets via their respective, willful and consensual engagement in the same commercially available platforms. Social media websites, desktop, and mobile applications use available web measurement and customization technologies to measure the number of visitors to our website, and any official & managed accounts across a variety of social & business marketing platforms. Various data sections from the varied software and technologies we employ help our attempt(s) in making our websites and services

more useful to visitors. In such cases, the third-party application(s) and/or websites, and/or relevant data collection software may request an email address, username, password, and geographic location (e.g., State, region, or ZIP code) for account registration purposes. 88mango media does not use third-party websites to solicit and collect PII from individuals. Any PII passively collected (i.e., not solicited) by the third-party website will not be transmitted or stored by the 88mango media; no PII will be knowingly and willfully disclosed, sold or transferred to any other entity outside the 88mango media official and necessary personnel, unless required for law enforcement purposes, or by relevant legal statute.

## Security

The 88mango media company takes the security of all PII seriously. We employ precautionary measures to establish and maintain security, confidential information, and integrity of the information we may collect at our site(s). These measures include operational procedure with regards to accessing information or control of information that was designed to limit access to the information toward the extent necessary to accomplish our professional and qualitative objectives. We also employ various security technology to protect information guarded within our systems. We test our security procedures to ensure their practical efficacy.

We employ the following steps to secure information we may collect:

- Require steps in operational procedures that make sure only relevant and necessary personnel have access to any project critical information to complete performing their official duties.
- Train personnel on consistent privacy and security policy requirements.
- Secure areas where we retain paper copy of information collected online and/or relevant mobile applications and online platforms.
- Perform regular backups of only necessary and operationally relevant information collected to ensure against loss and/or potential damage.
- Use relevant safeguards employed by the platforms used for general service operation, promotion, online presence, commerce, and professional positioning. These platforms include but are not limited to, GoDaddy - Webhosting, Domain hosting and purchase, & web design and publishing; Instagram - via the Meta company; LinkedIn - via the Microsoft company, the Google company, etc. We depend on the integrity and upkeep of their security guards, per their respective established and communicated forms of maintaining critical operational services for 88mango media, and the safety measures they may employ to maintain their commercial relevancy and operational need. The respective companies whose, paid and unpaid, services are contracted and/or used by 88mango media, have and use their respective manners of options in access and control for all their customers, such as

88mango media, and like other customers, our company 88mango media, depends on their measures taken and respectively, it is assumed, internally reviewed, to best identify and prevent unauthorized access or control by those that may attempt to “hack” into, or cause harm to, the information contained in our systems and their respective systems.

We hold our contractors and other third-party providers to the same high standards that we aim to maintain to ensure the security, confidentiality, and integrity of personal information they may have access to in the course of their work and/or services provided for the operational use and professional maintenance of the 88mango media company.

## Collected Information for Data and Customizing Experience(s) - (Cookies - Subscriptions)

Newsletter subscriptions and/or subscription(s) of any kind officially communicated as affiliated and managed by 88mango media are entirely voluntary. If any user/account would like to unsubscribe from our subscriptions, simply email our official company email and request removal from the newsletter and/or any relevant subscription service/media shared and managed by 88mango media.

A cookie is a small file that a website transfers to your computer to allow it to remember specific information about your session while

you are connected. Your computer will only share the information in the cookie with the website that provided it, and no other website can request it. There are two types of cookies:

- **Session:** These cookies last as long as your web browser stays open. Once you close the browser, the cookie is deleted.
