******ALL BILLING, INVOCIES, AND COLECTIONS OF REVENUE FROM SHIPPERS, BROKERS AND/OR FACTORING COMPANIES ARE THE SOLE RESPONSIBILITY OF THE CARRIER/TRUCKING COMPANY, UNLESS JUSDONTSTOP LOGISTICS LLC AND CARRIER/TRUCKING COMPANY HAVE ARRANGED AND AGREED UPON ADDITIONAL SERVICES PROVIDED TO THE CARRIER/TRUCKING COMPANY BY THE JUSDONTSTOP LOGISTICS LLC.**

******If revenue for a shipment or shipments is uncollectible, Shamell Spivey with JUSDONTSTOP LOGISTICS LLC will be held harmless, and no penalty or deduction of fees will be made.**

The carrier/Trucking Company agreed to maintain all proper licenses and permits (UCR, IFTA, IRP, etc.) to conduct business as a motor carrier in the area of intended operation, either intrastate or interstate. Additionally, the carrier/Trucking company agreed to maintain general liability (\$1 million) and cargo insurance (\$100,000) at the amounts set forth by the home state of the carrier/trucking company. **Shamell Spivey with Jusdontstop logistics LLC** will be held harmless in the event of all claims.

The **FEE** for Dispatching Services will be: **Dispatch 10%** per load

As Loads/fright/cargo are picked up, delivered, and Carrier/Trucking Company is paid FIRST, an amount equal to the above stated percentage/pricing scheme will be payable to **Shamell Spivey with Jusdontstop logistics LLC weekly**. Either party has the right to end this agreement without cause at any time with **seven (7) days' notices by written request**. By signing below, I fully understand the terms of this agreement.

It is also agreed and understood by both parties that, as a result of remit payment to **Shamell Spivey with Jusdontstop logistics LLC** as per this Agreement, all activity on behalf of name carrier/trucking company will cease and request for payment will be placed in collection. It is also agreed that if **Shamell Spivey with Jusdontstop logistics LLC** must use collection procedures/agents, name carrier will bear all collection costs, including reasonable attorney fees.

No amendments can be added, nor any item deleted from the agreement unless in writing and agreed to by both parties, signified by notarized copy to each party.
