

# Charleston River Port 10K Race



## 2021 CHARLESTON RIVER PORT 10K WAIVER

I acknowledge that this event is a potentially hazardous activity. I hereby assume full and complete responsibility for any illness, injury, or accident which may occur during or after my participation in this event or while on the premises of this event.

Because COVID-19 is extremely contagious and is spread mainly through close person-to-person contact, Charleston River Port 10K has put in place preventative measures to reduce the spread of COVID-19. I acknowledge that I must wear a mask and practice social distancing protocols during the entirety of this Charleston River Port 10K event, even if I have received the COVID-19 vaccination. I also acknowledge that Charleston River Port 10K cannot guarantee that its participants, volunteers, partners, staff, or others in attendance will not become infected with COVID-19.

In light of the ongoing spread of COVID-19, individuals who fall within any of the categories below should not attend Charleston River Port 10K events and/or other face-to-face fundraising activities. By attending the Charleston River Port 10K Race on October 16, 2021, I certify that:

1. I will not attend if I have experienced any symptoms associated with COVID-19 within fourteen (14) days prior to the event, such as fever, cough, and shortness of breath, among others.
2. I will not knowingly travel at any point in the fourteen (14) days leading up to the Race to a community that has experienced or is experiencing sustained spread of COVID-19.
3. I will not attend if I am aware of exposure to any confirmed or suspected case of COVID-19 within fourteen (14) days of the event.
4. I will not attend the event if I have been diagnosed with an active case of COVID-19, or if I am currently waiting for COVID-19 test results.

I agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and to contact Charleston River Port 10K at [office@mvmteams.com](mailto:office@mvmteams.com) if I experience symptoms of COVID-19 within 14 days after participating or volunteering with Charleston River Port 10K. I hereby release and hold harmless and covenant not to file suit against Charleston River Port 10K, the MVM Teams, Meridies Venture Media, the City of North Charleston, any sponsors and their agents and employees, and all other persons or entities associated with this event from any loss, liability, or claims I may have arising out of my participation in the Race and associated activities (e.g. Mobile Discovery Unit, etc.), including personal illness, injury, or damage suffered by me or others, whether same be caused by falls, contact with participants, conditions of the walk route, negligence of the releasees, or otherwise. This release specifically includes a release of any claims against Charleston River Port 10K that I or someone else contracted COVID-19 while attending the Race or any other claims related to COVID-19.
