# WEDDING HAIR SERVICES AGREEMENT

## Salt Air Beauty & Hair Care

## 1. SERVICES & RESERVATION

Salt Air Beauty & Hair Care agrees to provide professional, on-location bridal hairstyling services on the date and at the location listed above.

A finalized service count must be confirmed no later than **20 days prior to the wedding date**. Any additions after this time are subject to artist availability and are not guaranteed.

On-location bookings require:

- **Retainer Per Artist:** \$50
- **Travel Fee:** \$100

A valid credit card must be kept securely on file.

Retainers and travel fees are **non-refundable** and are required to reserve your wedding date unless otherwise agreed upon with Salt Air Beauty.

Service pricing is subject to change until both the signed Agreement and required retainer have been received.

## 2. PAYMENT TERMS

The remaining balance for all contracted services is due **7 days prior to the wedding date**.

Pay-in-full options are available at booking.

If final payment is not received by the due date, Salt Air Beauty & Hair Care reserves the right to charge the card on file.

No services will be performed without payment in full.

Cash upon arrival: If this option was presented to you, a lump sum must be provided before services are rendered.

## 3. CANCELLATION POLICY

Cancellations must be submitted no less than **14 days prior to the event** via email or written text communication to your assigned stylist or coordinator.

Confirmation of receipt is required.

If cancellation occurs within 14 days of the wedding date, **50% of the total contracted service amount** will be charged to the card on file.

Retainers and travel fees remain non-refundable under all circumstances.

---

## 4. STYLE CHANGE POLICY

To ensure a seamless and elevated experience, inspiration photos and style preferences must be discussed in advance or during the scheduled trial (if applicable).

Once a style has been completed, significant changes or complete restyling requests may be subject to:

- Additional time fees
- Additional service charges
- Timeline adjustments

Salt Air Beauty & Hair Care reserves the right to decline major style changes if they jeopardize the event timeline or impact other contracted services.

---

## 5. ADDITIONAL PERSONS / SERVICE CHANGES

Only the individuals confirmed in the final headcount will be serviced.

Requests to add additional bridal party members on the wedding day are not guaranteed and may incur:

- Additional service fees
- Additional artist fees
- Extended timeline charges

If accommodations cannot be made, services may be declined at the discretion of Salt Air Beauty & Hair Care.

## 6. CLIENT PREPARATION & TIMELINE

All members of the bridal party must arrive with:

- Clean, fully dry hair
- Free of heavy product buildup
- Free of excessive oil

If a stylist is required to wait **15 minutes or more** due to a client not being prepared at their scheduled time, waiting fees may be charged to the card on file.

Delays caused by clients may result in simplified styling to preserve the overall schedule.

Salt Air Beauty & Hair Care is not responsible for delays caused by vendors, photographers, venue access issues, or members of the bridal party.

---

## 7. PHOTOGRAPHY & MARKETING RELEASE

The Client grants Salt Air Beauty & Hair Care permission to photograph and/or record images of completed hairstyles for portfolio, website, social media, advertising, and marketing purposes.

Professional photographs captured by wedding photographers may also be used, when available.

No personal identifying information will be shared.

## **8. FORCE MAJEURE**

If Salt Air Beauty & Hair Care must cancel services due to circumstances beyond reasonable control (including but not limited to severe weather, hurricanes, natural disasters, emergencies, illness, or unsafe travel conditions), all amounts paid for services will be refunded.

Salt Air Beauty & Hair Care shall not be held liable for events outside of reasonable control.

## **9. AGREEMENT & AUTHORIZATION**

By signing below, the Bride confirms that she has read, understands, and agrees to all terms outlined in this Agreement. The Bride authorizes Salt Air Beauty & Hair Care to charge the card on file in accordance with the terms of this contract.
