# Matters arising.

- 1092 **Infrastructure to roads**. Newport City Council have served an enforcement order to cut back the trees (28 days) between Lower Lakes and the old caravan site. The drains have also been reported
- 1093 **Website** Councillor RP reminded the chair that A Preece needs payment for the web site. Chair WF said that they cannot pay by direct debit. £75.00 for the website renewal and between £120-£130 for domain.
- 1094 **Chairs in Goldcliff Church** Mr & Mrs Ward are going to bring 18 chairs for Goldcliff School room. The chairs should be at the school room for the December meeting.
- 1095 **NRW** Councillor BC mentioned that there is planning for an Infants/Primary School at Cotts Hill as well as 269 houses, which looks to be approved by Ward Councillor MK. Councillor WF is also going to try and get a NCC representative to attend a meeting to discuss drainage, and he will also email MK.

Unclear, but if charity status lost, we still have zero rating to fall back on.
