1210 - The British Heart foundation has supplied us with a Defibrillator, and training can apparently be carried out online

1211 - Village Hall field Trust – Ongoing. Trusteeship to be chased to allow the Council to oversee the Fields Trust in conjunction with Whitson Hall. Re-issued Cheque from J Williams received by the Trustees. Ongoing

1212 – Poor Ground. The wording for the Contract to be revised to ensure a Break in yearly rental is included To be facilitated EF

1213 – Training, new and existing Councillors. Ongoing, 3 modules already completed with more to be carried out

1214 – Website Further work undertaken to separate out documents we are required to have on the website and new page included with links to NCC etc, but we need to further understand what we are legal requirements and expedite as necessary. Discussion on other information that would be helpful, suggestions included use of schoolrooms and the background of councillors (in summary).

1215 - Financial Rateable value updated but as the Schoolroom and Whitson Hall get Charitable Status there is only a nominal charge for the Schoolroom,
