

## Working With Purpose – 2026 Group Supervision Calendar

***Supervision is where reflection becomes growth — a safe space to stay grounded, ethical, and thriving in your practice throughout 2026.***

All group supervision sessions run for **2 hours and are capped at 6 participants**, in line with PACFA, ACA and the incoming National Standards guidelines. If you have any questions or would like to discuss which group might suit you best, please don't hesitate to reach out.

**Each session is \$88 (\$80 + \$8 GST).** Invoices are issued after each session for easy upload to your membership portal. I am also happy to electronically sign PACFA/ACA supervision logs when needed.

Sessions are held online via Zoom and scheduled in **Brisbane time (AEST)**.

Groups are offered in both open and closed formats:

**Closed groups** — the same members each month, fostering deeper trust, continuity, and connection.

**Open groups** — attend when it suits you; perfect for flexibility and exposure to diverse perspectives.

**Pop-up sessions\*** — more casual, with space for check-ins, sharing, networking, and topical discussions.
