# WALKS TO RESUME

In their meeting on May 1, the Alabama Emmaus Board of Directors made the decision to resume Walks with #494 the second week of August. In order to do this, there were some stipulations. For the four Walks scheduled in 2021, all Pilgrims to be invited will be asked if fully vaccinated or with plans to be by the date of the Walk. If medically unable to be fully vaccinated, these applicants will be scheduled in 2022. All Team Members for the four Walks scheduled in 2021 will be asked to be fully vaccinated or have plans to be by the date of the Walk. Those who are medically unable to be vaccinated but willing to accept the risk, may serve. As noted in the April issue of the Apostle, the Camp is allowing Emmaus to use all of Hutto as usual. At this time, a maximum of 21 Pilgrims will be assigned to a Walk. This will allow for current 3' social distancing. The Board will have a meeting via Zoom on June 10 to reevaluate these decisions. All guidelines are being revised to reflect these changes.

A group of workers from the Franklin/ Haleyville/Marion County Cluster Grouping, as well as some from Cullman/Blount County worked on May 8. The work still left to do will be based on what they were able to accomplish. As noted in earlier issues, the Camp is likely to assign Hutto to the **Emmaus Community for** reclaiming. The Agape Room and the Banner Room are part of that building, but are for Emmaus use only. A group from the Board has already begun the work in these rooms but there is still much more to do. Due to a leak while the building was closed, many items will have to be replaced. So if you are not able to go to Camp when the date is set, or if the jobs to be done are out of your skill set, think about making a donation toward replacing some of the supplies usually need for a Walk. Or, consider making a new banner since several of them had to be discarded due to the leak. There are so many ways to help!

## **SPONSORSHIP 101**

As explained in the article on the front page, any Pilgrim scheduled for any of the four 2021 Walks will need to have been fully vaccinated by the date of their Walk. You will be contacted by Angel Rait, the Community Coordinator, who will explain this and ask you to learn this from your Pilgrim. If your Pilgrim is not medically able to take the vaccination, he or she will be rescheduled for a 2022 Walk. It will be helpful if you let your Pilgrim know that every effort is being made to

make the weekend safe and to meet all government and CDC guidelines. All the Team will be required to be fully vaccinated as well. For these Walks there will be a maximum of 21 Pilgrims assigned in order to meet the current 3' distancing guidelines. Be sure to check here and our website, as well as the Community website, for updates as conditions are apt to change between now and the Walk dates.
