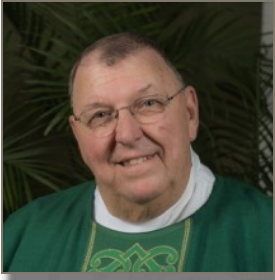

January – The Month of a New Year and Many Challenges

January is an interesting and challenging month. In the first part of January we continue to rejoice and celebrate Christ's coming to Bethlehem and in our hearts.

We have the wonderful feasts of Mary, Mother of God, where we honor Mary's highest title. We follow the Magi to the crib as they bring gifts of gold, frankincense and myrrh on Epiphany. And, we reach the culmination of this season with the Baptism of Our Lord by St. John the Baptist. With a touch of sadness, we take down our decorations and enter the liturgical period known as Ordinary Time where we will devote ourselves to the mystery of Jesus, our Messiah, in its entirety as he walks the earth in the ordinary of his life. The name Ordinary Times come from the Latin word "ordo", which means numbered. So, we have number weeks in Ordinary time numbering to 34.

The new year offers us a time of growth and an opportunity to allow the dignity of Sunday, the Original Feast Day, to shine out in our lives in a new a more vibrant manner. And, besides the previously mentioned feasts, the month also includes: St. Basil the Great and St. Gregory Nazianzen (January 2), Holy Name of Jesus (January 3), St. Elizabeth Ann Seton (January 4), St. John Neumann (January 5), St. Raymond of Penafort (January 7), St. Anthony, abbot (January 17), St. Agnes (January 21), St. Vincent of Saragossa (January 23), St. Francis de Sales (January 24), the Conversion of St. Paul (January 25), Sts. Timothy and Titus (January 26), St. Thomas Aquinas (January 28) and St. John Bosco (January 31).

The feasts of St. Andre Bessette (January 6), Sts. Fabian and Sebastian (January 20) and St. Angela Merici (January 27) are superseded by the Sunday liturgy.

While the opening days of January may be cold and bleak, the domestic church still glows warm with the peace and joy of Christmas. We dedicate the New Year to Mary on the January 1st Solemnity honoring her as Mother of God; and on January 6th, the Solemnity of Epiphany, we rejoice with her, as her Son is adored by the three Wise Men.

In this liturgical season, the Church eagerly follows Our Lord as he gathered his apostles and announced his mission. At Cana's wedding feast (The Second Luminous Mystery) Jesus performed his first public miracle at the request of his Mother, and his disciples saw his glory and believed in him.

We, his present-day disciples, pray for a like-faith as we contemplate the eternal wedding feast of the Lamb and the unique role of the Blessed Mother in the plan of salvation. January is the month of a new and exciting year where we make our resolutions for growth in our lives. Let us prayerfully consider those resolutions that will move us to be more like the image and likeness of Christ and his Blessed Mother. And, should we feel ourselves falter in our resolution, let us prayerfully ask for help in our time of wavering. In these times let us remember the words of our Blessed Mother and wholeheartedly obey her words of counsel: "Do whatever he tells you."

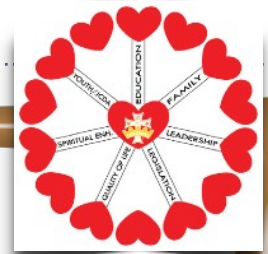

Originally, we were 'assigned' or relegated to two upstairs rooms in the PLC, however,

through the grace of God the Social Hall was vacant and we moved in there with 'permission' and the promise of being completely done and out of there by 5 p.m. With a little prep time before 3 p.m., we were completely done by 4:20 p.m., and enjoyed a little social chatter before heading home.

Delivery of the Manna Bags and sandwiches again was a true blessing to them and it was awesome seeing the joy on the faces of the clients who helped with the unload process. Dr. Bob who is the Executive Director and Paul who we think is a volunteer but always at the door, were thrilled to see Priscilla and me and our cargo load! Every third weekend, Catholic Daughters Court #2731 with the partnership of Congregation Jewish Community North ARE making a difference in the lives of 1960 Hope Center clients.

A bit of exciting news, 1960 Hope Center was successful in purchasing a two-story building on Peakwood just in from Red Oak if you are familiar with the area. They will not move into the facility until later in 2019 but they will have more laundry facilities for their clients as well as more showers! Right now they have one of each—pretty hard when they are serving up to 50 clients a day. Another great part of this story is that the new facility is around the corner and down the block from their present location just off of Cali.





We will prepare manna bags and sandwiches in January and the third Thursday is January 17th, so stay tuned for a food donation and volunteer to help email the second week in January. It does sound early in the month, but it relates to the third weekend of the month.

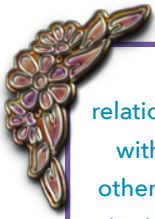

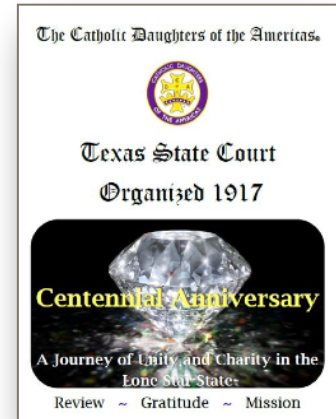

Pledge to Pray for Life

On January 18th, in unity with the March for Life and our Catholic Daughters of the America Sisters, I pledge to pray for an end to abortion and those who have been hurt by abortion.

Many Americans who are participating in the Affordable Care Act do not know if their health care plan covers elective abortion. The current law requires health insurance companies with plans that cover elective abortions to collect a separate payment for the abortion coverage. This is almost never done.



Please see information from the NCHLA:

To help fix this problem, the **Department of Health and Human Services has proposed a new rule** that would require insurance companies to **send their customers a separate monthly bill** for the part of their health premium that covers abortion. **That way, everyone with a plan that covers elective abortion knows just where their money goes.**

Many of you may be wondering, why can't we just change the law to prohibit use of taxpayer dollars to pay for health plans that cover abortion? That is still the goal, but in the meantime, until Congress takes that action, this "Separate Payments" rule will **allow consumers to see more clearly when they are paying for elective abortions** and to seek a plan that does not cover it. It may also motivate companies to offer more plans WITHOUT abortion coverage. For more background information on the Separate Payments Rule and why it is necessary, please [click here](#).

The U.S. Conference of Catholic Bishops has written [formal comments](#) applauding the government, and we invite you to add yours as well. Pro-abortion groups will write in as many negative comments about the rule as they can. All the more reason to raise your voice in support of it!

FAQS on the "Separate Payments Rule"

How can government plans from the Affordable Care Act cover abortion? Isn't taxpayer funding for abortion already against the law?

When the Affordable Care Act (ACA) became law in 2010, one major piece of the Hyde amendment (i.e., the law that prevents taxpayer funding of abortion) was missing from it. The ACA omitted the prohibition on use of federal funds to pay for **health plans** that cover elective abortions. Instead, the ACA required health insurance companies with plans that cover elective abortions to collect a separate payment (at least \$1 per month) from each enrollee for coverage of those abortions. And the insurance company must deposit these separate elective abortion payments into a separate account that only includes those payments, and that is used exclusively to pay for elective abortions.

So the rule is already part of the law. Why didn't it work the first time?

The separate payment provision is simply being ignored by many health insurers, according to a 2014 [Government Accountability Office Report](#). This may be because when the ACA was first put into effect, the Obama Administration failed to enforce that part of the law. As a result, many pro-life Americans seeking health insurance under the ACA are likely unaware that their plan covers abortions and that they are paying an additional premium to pay for them.

In order to fix this problem, the Department of Health and Human Services has proposed new regulations directing issuers of health insurance plans to follow this provision of the law. The regulations require issuers to send a separate monthly bill to the consumer for the portion of the premium that covers abortion.

In other words, the new rule will remind health insurers about the law, and give them reason to believe the government will make them comply with it this time.

Why don't we just change the law to prevent use of government money to pay for plans that cover abortion?

Ultimately, we are continuing to work to get the ACA amended to prohibit use of federal funds to pay for health plans that cover abortion. But it is **Congress**, not the Administration, who must take that action.

Until they do, adoption of this "Separate Payments" rule will allow consumers to see more clearly when they are paying for elective abortions and to seek a plan that does not cover it. It may also motivate companies to offer more plans WITHOUT abortion coverage.

Comments on the proposed rule are being accepted by the Administration through January 8, 2019, so [please write them as soon as you can](#) - before the holidays get away from you.
