ACKNOWLEDGEMENT FORM

I acknowledge that I have read the **NEW HOME ARCHITECTURAL REVIEW APPLICATION OR THE HOME IMPROVEMENT/MODIFICATION ARCHITECTURAL CONTROL APPLICATION AND THE MINIMUM CONSTRUCTION STANDARDS DOCUMENT**. These documents provide a detailed explanation of our standards and requirements for New Home Construction or for a Home Improvement/Modification change.

1. Owner hereby acknowledges they have read the New Home Architectural Review Application or the Home Improvement/Modification Architectural Control Application and the Minimum Construction Standards document and hereby agrees to comply with all terms and conditions contained therein and obtain all applicable surveys and approved inspections as specified therein.
2. **Upon all new home completion but prior to OCCUPANCY, an approved final survey, approved final inspection and Architectural Control Committee (ACC) approval is required or legal action will be taken at Owners expense for non-compliance.**
3. Any change to the approved original design and original application requires an additional review and approved by the Architectural Control Committee (ACC).
4. Failure to comply with the required inspections will result in legal action being brought to require compliance.
5. Please review the Architectural Review Application and Minimum Construction Standards with your Builder/Contractor.
6. PALM CREST ARCHITECTURAL FINES

Property Owner (PO) and Builder/Contractor (B/C) must initial each fine category regardless if a particular fine is not applicable to your construction project.

Start of construction prior to ACC approval - \$750 PO initial B/C initial
Change in approved Construction without approval - \$750 PO initial B/C initial

Dirty work site, builder trash, Saturday site not cleaned - \$100	___ PO initial	___ B/C initial
No Port-A-Can - \$50/day	___ PO initial	___ B/C initial
No Trash bin/Container (Dumpster) - \$50/day	___ PO initial	___ B/C initial
Trash bin full and trash over flowing – \$50/day	___ PO initial	___ B/C initial
No Construction fence - \$50/day	___ PO initial	___ B/C initial
Construction fence down - \$50/day	___ PO initial	___ B/C initial
Failure to provide “forms” survey - \$100	___ PO initial	___ B/C initial
Failure to provide “final” survey - \$100	___ PO initial	___ B/C initial
