But networking is key to the work we do and can help you gain unexpected allies that can help you get those wins!


#### Why is networking so important?

- **Strength in Numbers:** Building a strong network allows you to rally support for your cause. When an issue comes to a vote, having a network of informed allies can make a significant difference. They can be contacted for outreach efforts or to put pressure on decision-makers.
- **Information Sharing:** A strong network acts as an information exchange. Sharing updates on legislator leanings, potential roadblocks, and even grassroots efforts allows everyone to be on the same page and adapt strategies accordingly.
- Expertise Exchange: No one lobbyist or advocate can be an expert on everything. Networking allows you to tap into the knowledge and experience of others in your field. Need help with legal intricacies? Connect with a lawyer in your network. Need numbers to convince a waffling legislator? There might be a data whiz you can collaborate with.

#### **Beyond the Basics:**

- **Go Beyond Your Comfort Zone:** Don't just network with people who agree with you. Building relationships with those on the opposing side can foster understanding and potentially lead to compromises or unexpected alliances.
- Quality over Quantity: It's better to have a few strong, reliable connections than a large network of casual acquaintances. Focus on building genuine relationships based on mutual respect and trust.
- **Be a Giver, Not Just a Taker:** Networking is a two-way street. Be willing to offer your time, expertise, and connections to others in your network.
