### **2021 Preschool Scholarship Application**

Aloha Scholarship Applicant,

Mahalo for your interest in an educational award with the Hualalai 'Ohana Foundation.

The Hualalai 'Ohana Foundation provides prekindergarten scholarships to eligible children of Hualalai Community employees, which include Hualalai Investors, LLC, Four Seasons Hualalai and Hualalai Resort contractor employees.

#### **2021** Application Policies:

For 2021, the Foundation has included the following preschools (all Hawaii Island locations are eligible). Children must be three years old at time of application to be eligible for the preschool scholarship.

# Other licensed preschools will be considered by the Education Committee if a written request is submitted by Friday, March 20, 2020. Request forms are available online at www.Hualalaiohanafoundation.org at our Programs page.

The Foundation conducts limited review of a certain number of preschools to determine whether they meet the basic criteria established by the Foundation for awarding scholarships to eligible children of the Hualalai Community attending the preschools. The review by the Foundation is not a comprehensive assessment or evaluation of the quality of a preschool or its suitability for attendance by any children of the Hualalai Community. By listing certain eligible preschools in the application package, the Foundation is not recommending or endorsing any of these preschools. The parents are expected to select the appropriate preschool for their children based on their own independent evaluation.

Award amounts are determined by these criteria after all applications are received:

- Financial Need based upon income, size of household and individual circumstances
- Tuition Cost based on tuition cost for entire schoolyear

If your child has received awards in past years, please apply again this year, as you may still be eligible. There is no limit to the number of awards per family within the scholarship category.

### Application deadline for return of the completed application (attached) and all supporting materials is, Friday, May 28, 2020, for school year Fall 2021/Spring 2022

There is no deadline for schools that allow year-round enrollment. Applications received after the May 28th deadline will be reviewed and amounts awarded based on available funds at that time. We recommend submission by the May 28th deadline to ensure maximum award.

Award notifications will be distributed the end of June.

### Preschool Award Guidelines and Eligibility

- 1. Student must be the legal child of an employee (Hualalai Resort, Four Seasons Hualalai or vendor of Hualalai Resort). Employees who are not parents of children they are applying for must provide documentation of legal guardianship. <u>If the child does not reside with the employee, financial information for the custodial parent will be required.</u>
- 2. The Hualalai community employee\* must be employed within the resort at least one year as of the deadline, May 28, 2021, or date application received for year-round schools.

### *Employee's resignation from a position within the Hualalai community during the* 2021-2022 school year will affect the status of the child's financial award.

- 3. Families earning a <u>combined annual gross income</u>\*\* of \$195,000 or more are not eligible.
  - Annual gross income is defined as the total of all forms of gross income, prior to deductions, including pre-tax adjustments or deductions, contributions to retirement accounts or cafeteria plans, i.e., Social Security wages per W-2 form, and also includes any self-employment or rental property income
  - All employees under the \$195,000 threshold are eligible to apply; however, in addition to income qualifications, all other aspects affecting each applicant's financial need will be considered before an award is granted
- 4. To be eligible for the Preschool scholarship award, the applicant:
  - Must be enrolled or applying for enrollment in an accredited educational institution or program. Enrollment confirmation or tuition statement will be required.
  - Parents/Guardians must submit a personal letter outlining the student's educational goals and/or special needs, and a description of financial need to be eligible. The applicant will be responsible for any tuition expenses not covered by this award.
  - Must submit copies of <u>both</u> the 2020 W-2 forms and the completed and signed 2020 1040/1040EZ IRS Tax Return, instead of just one or the other. If either parent has additional forms of income, copies of associated schedules are required, such as; Self-Employment (Sched. C), Investment (Sched. D), Rental Income (Sched. E) and/or Farming (Sched. F).

#### Award Payments

Scholarship awards are paid only for tuition costs and official student fees. <u>This award does not</u> cover after-school care, extra-curricular activities, housing, supplies, or transportation costs.

If you receive an award, you must provide an invoice, tuition statement or receipt with proof of payment directly to the foundation. The tuition information provided in your application packet to the foundation is not acceptable for payment of your award.

Award payments are made once per academic year, at the start of school. Awards are pro-rated monthly through the 2021-2022 school year. *If the employee ends employment within the Hualalai Community, any unused pro-rated funds will be returned to the Foundation.* 

### DEFINITIONS

\**Hualalai Community Employee* includes employees of Hualalai Investors, LLC or Four Seasons Hualalai; and any Hualalai Resort contractor, which means an employee or independent contractor of another company who provides services to the resort, hotel or resident homeowner for a minimum of 20 hours per week for over one year.

*Hualalai Resort contractors must provide two (2) verification letters of eligibility – from your employer, hotel or resort verification or homeowner – with their application.* 

\*\**Annual gross income* is a total of all forms of gross income, prior to deductions, including pre-tax adjustments or deductions, contributions to retirement accounts or cafeteria plans, i.e., Social Security wages per W-2 form, and also includes any self-employment or rental property income
