

#### **Mission Statement**

The House of Prodigy is a ballroom house for the LGBTQ+ community. Our mission is to "produce legendary talent" by providing a fun, safe, and encouraging atmosphere; while teaching the skills to develop strong character, positive attitudes, and responsibility, as well as instilling positive goals, dreams, and values outside of the ballroom scene. We are committed to cultivating a vibrant community by connecting talented individuals with the skills, information, and resources they need to be successful.

#### History

The Innovative House of Prodigy is an international ballroom house based in Philadelphia, PA. We compete in an underground LGBTQ+ subculture known as the Ballroom Scene. Overall Father Mann (formerly Ebony) dreamed of creating a ballroom house with like minds merging their talents and strengths to build a powerhouse in a community filled with well-established houses. On August 24, 2002, his vision crystallized as The Innovative House of Prodigy. Together with five

other co-founders, Mann debuted The Innovative House of Prodigy at the Iconic House of Revlon Ball in New York City, coming in 2nd place for the house with the most trophies. The founding members are all former members of the Iconic House of Ebony, which makes the Iconic House of Ebony the mother house of the Innovative House of Prodigy.

**Fun Fact:** The House of Manolo-Blahnik is the sister house to the Iconic House of Prodigy due to Icon Founder Jay Blahnik starting the house under Mann's leadership while they were in the Iconic House of Ebony.

**Fun Fact:** The Houses of Balmain, Herrera, Alpha & Omega, and Supreme Moncler are daughter houses of the Iconic House of Prodigy. These houses are founded by Rodney ex-Prodigy-Balmain, Marco ex-Prodigy-007, Caesar ex-Prodigy-Alpha Omega, and Jacen ex-Prodigy-007. They all started their houses under Mann's leadership in the Iconic House of Prodigy.

**Fun Fact:** The Iconic House of Prodigy has had 4 Overall Fathers, starting with Icon Hall of Famer Mann Prodigy, followed by Icon Hall of Famer Rodney Balmain, followed by Icon King Father Kenyon, and now the current Overall Father Legendary Fatty Prodigy.

**Fun Fact:** The Iconic House of Prodigy has had 5 Overall Mothers, starting with Icon Hall of Famer Meeka ex-Prodigy-Alpha & Omega, followed by Icon Hall of Famer Mahagony ex-Prodigy-Chanel, followed by Legendary Mercedes ex-Prodigy-Alpha & Omega, followed by Icon Hall of Famer Alexis ex-Prodigy-007, followed by Icon Hall of Famer Jacen ex-Prodigy-007, and then Icon Hall of Famer Alexis ex-Prodigy-007.

**Fun Fact:** At times, we throw the color black in the house colors because we are an African American-founded organization.

**Fun Fact:** The Iconic House of Prodigy is the first house to have a Prodigy vs. Prodigy Ball with trophies.

#### **Accomplishments:**

Through the years, the House of Prodigy has used its unity and power as significant leverage to continuously develop legendary talent. The House of Prodigy stands at the forefront as one of the Ballroom scene's most elite houses, winning multiple House of the Year awards in Philadelphia, NYC, and the Midwest. Since the House of Prodigy's founding, the house has become a top contender in Realness and Performance while having a solid presence in Runway, Face, and Sex Siren. In 2021, The House of Prodigy appeared in the second season of the HBO Max original reality competition series "Legendary."

The Iconic House of Prodigy has recruited, groomed, and unleashed some of the most extraordinary talents in every region of the ballroom scene, and worldwide! Following the

direction of the founding leaders and members, The Iconic House of Prodigy has continues to exceed far beyond expectations. This house stands firm, and will carry the rich legacy of our tradition for decades to come. The Iconic House of Prodigy believes every member is an asset and has profound respect and appreciation for all its present and former members.

# HOUSE OF PRODIGY BOARD MEMBERS <u>Titles & Responsibilities</u>

#### **Founding Parents**

Founding parents oversee the operation of the entire house, and these individuals are also responsible for ensuring that we have a table at mandatory balls. If there is only one active Founding Parent, they will take on the entire responsibility of the role.

#### Founding Father Icon Hall of Famer Mann Prodigy

#### **Overall Parents**

These individuals are responsible for governing the entire house. They make and finalize all house decisions. They have the right to draft members into the house (recruiting a new member in the house without the permission of another party). These individuals are responsible for assisting in deciding candidates' entry into the house, and they also have the final judgment. These individuals are responsible for leading, ensuring effective house operations, and proper fulfillment of all duties. These individuals guide, coach, motivate and advise members professionally and personally when needed. They have the right to overrule any decision made by anyone in the house.

#### **Overall Father Icon Fatty Prodigy**

#### **Overall Godparents**

These individuals are responsible for deciding candidates' entry into the house. These individuals are responsible for leading and ensuring that the entire house is running properly and everyone performs their duties correctly. They also have the right to overrule anyone's decisions in the whole house except the Overall Father & Overall Mother. These individuals also have the right to draft new members into the house. These individuals guide, coach, motivate and advise members professionally and personally when needed. They are directly responsible for all regional parents and will contact all overseeing house parents.

#### Overall Godfather Icon Hall of Famer Dywon Prodigy

#### **Overall Overseer**

The overseer oversees the entire operation of the house. This individual will work closely with the overall parents and board to maintain house quality and standards. The overseer has the right to overrule any decision made by anyone in the house. These individuals also have the right to draft new members into the house. These individuals guide, coach, motivate and advise members professionally and personally when needed. This person is the immediate mediator among members with issues in the house and will render unbiased, fair judgments in all situations.

#### **Overall Overseer Legend Ronnie Prodigy**

#### **Overall Executive Board Members**

#### Lord

This individual is responsible for deciding a candidate's entry into the house and overlooking the board. The lord decides if a board member is not performing their job efficiently. This individual must report findings to the overall parents. After reporting the results of negligence, the lord has the right to remove or suspend the leader in question from the board. This individual can rule against any board member's decision if needed. The overall parents will finalize the decision.

#### King & Queen

These individuals are responsible for deciding a candidate's entry into the house. These individuals are directly accountable for chapter parents. These individuals will advise chapter leaders and report any findings of negligence to the Overall Parents. They are also responsible for finalizing dress codes at mandatory and focus balls.

King – Legend Hank Prodigy Queen – Legend Trez Prodigy

#### **Emperor & Empress**

These individuals are responsible for deciding a candidate's entry into the house and informing any member of their dismissal from the house. They are responsible for interviewing all new candidates before presenting them to the board. They pick the candidate that best fits the house, except for a draft. They also inform the candidate of the board's decision on the application.

#### **Prince & Princess**

These individuals are responsible for a candidate's entry into the house. These individuals are responsible for ensuring that all members correctly represent their category. These individuals also ensure that everyone knows their respective categories at mandatory balls. These individuals are accountable for planning family fun events during mandatory ball weekends.

Prince – Legend Nick Blu Prodigy Princess – Aaliyah Prodigy

#### **Duke & Duchess**

These individuals are responsible for a candidate's entry into the house. These individuals are responsible for communicating with all chapter parents and godparents. These individuals are responsible for maintaining the entire house roster. These individuals are responsible for maintaining a positive culture in the house group. These individuals provide communication and unity amongst the whole House of Prodigy!

Duke – Smurf Prodigy Duchess – Reign Prodigy

#### **Regional Parents**

These individuals are responsible for governing their assigned coast. These individuals are responsible for communicating goals, ideas, and strategies to enforce the progress of their respective coasts. These individuals are liable to lead, coach, and guide, all Chapter Parents and God Parents for success. These individuals enforce all house rules, regulations, and guidelines. These individuals are accountable for handling discrepancies within their respective coasts only. These individuals are responsible for any new candidate's entry into the house; they also have the power to put in a motion to remove a Chapter Parent and God Parent from their respective roles if signs of negligence are detected. This motion goes to the Overall God Parents; then the Overall Parents will approve, or deny, this motion. The Executive Board must validate all reasons for removals with an investigation. These individuals have the right to submit a possible draft but must get approval from Overall Parents. In the absence of Chapter Parents, the Regional Parent is the acting Chapter Parent.

Father - East Coast – Legend Man Man Prodigy Mother - East Coast – Legend Victoria Prodigy

#### Overseer of a Region

These individuals oversee the daily operations of all leaders within their respective areas. They are to report any negligence to the Overall Overseer, and together they will devise a solution for

any issue. This individual has the right to draft within their respective region only. However, they must partner with the Overall Parents for approval.

#### **Chapter Parents**

These individuals are only responsible for leading the chapter of their respective cities/countries. These individuals are liable to guide, coach, motivate, and advise members professionally and personally. They are responsible for holding at least one practice per month, one chapter meeting per month, and one social activity per month. They can overrule any decisions in that city/country only. They must report directly to the Overall King and Overall Queen on all happenings in their chapter. They are responsible for recruiting in their chapter but must get the board or overall parent's final approval before the recruit becomes an official member. These individuals must maintain an active roster.

#### **Chapter Prince & Princess**

These individuals are only responsible for aiding with the chapter of their respective chapters. They are responsible for planning at least one practice per month, one chapter meeting per month, and one social activity per month, in conjunction with the chapter parent. They are responsible for reminding the chapter of monthly dues. They are responsible for dress codes for balls in their respective regions.

#### **International Overseer**

The overseer oversees the entire operation of all international chapters of the house. This individual will work closely with the overall parents, international parents, and board, to maintain house quality and standards. The overseer has the right to veto any decision made by anyone in any of the European chapters. These individuals also have the right to draft new members into the house. These individuals guide, coach, motivate and advise members professionally, and personally, when needed. This person is the immediate mediator among international members who have issues with their international parents, and will render unbiased, fair judgments in all situations.

#### International Overseer - NA

#### **International Regional Parents**

These individuals are responsible for governing their assigned region. These individuals are responsible for communicating goals, ideas, and strategies to enforce the progress of their respective region. These individuals are liable to lead, coach, and guide, all Chapter Parents and God Parents for success. These individuals enforce all house rules, regulations, and guidelines. These individuals are accountable for handling discrepancies within their respective region only. These individuals are responsible for any new candidate's entry into the house; they also have the power to put in a motion to remove a Chapter Parent and God Parent from their respective roles if signs of negligence are detected. This motion goes to the Overall God Parents; then the Overall Parents will approve, or deny, this motion. The Executive Board must validate all reasons for removals with an investigation. These individuals have the right to draft new members in the house. In the absence of Chapter Parents, the Regional Parent is the acting Chapter Parent.

Europe – Neasy

#### **International Chapter Parents**

These individuals are responsible for leading the chapter of their respectable country/city. These individuals are responsible to guide, coach, motivate, and advise members professionally and personally. They are responsible for holding at least one practice a month and two chapter meetings per month. They can overrule any decisions in their country/city only. They must report directly to the international regional parents on all happenings in their chapter. The international dismissal process is the same as in the United States. The current international parents must vote to decide if a member should be dismissed from the house. The majority rules in that case and Leaders must discuss all communication collectively. The final decision must be reported to the international overseer and overall parents.

#### International Parents - NA

#### **Treasurer/Secretary**

These individuals are responsible for keeping notes at meetings, preparing meeting agendas, and recording every Prodigy ball win. These individuals are responsible for recording the payment of house dues, and producing a monthly report of the house dues. They are also responsible for maintaining the house roster.

### Official Rules and Regulations of The House of Prodigy

- 1. No member is allowed to walk any category without the consent of the Executive Board. All Members must present all props, productions, and effects to **The King and Queen of the house before walking the category.**
- 2. All members must walk the category they were admitted into the house for, and members cannot walk any other category without the consent of the Executive Board. If any member breaks this rule, judgment on their house status will be **determined by the Executive Board**.
- 3. If any leader notices that a member's effect is not presentable, that member will not be allowed to walk. If a member sees the same issue, it should be brought to a leader's attention. If instructed not to walk and proceed to walk, **you will suffer disciplinary action by the Executive Board**.

#### 4. Social Media Behavior

Please be mindful of your behavior on all social media. Social media posts also directly reflect the Iconic House of Prodigy. If your social media activity creates issues for the house, you may be **DISMISSED** from the house (**Depending on the situation**). You may not always agree with what

other members post on social media, but please be respectful on public forums outside the house group. **Examples:** Inappropriate Behavior on BIGO; arguing with another Prodigy on social media; etc.

- 5. If you are involved in a heated situation with another member and you can no longer handle it, contact your chapter leader/parent. If not, reach out to the **Overall Godparents** to solve this situation.
- 6. Prodigy's are allowed to date within the house only if it does not conflict with Prodigy Business. Leaders are not allowed to date, or engage in any form of sexual activity, i.e. flirting, sexting, touching, etc, with a regular member. If either of these situations occur, **the member(s)** in violation will be dismissed.
- 7. Prodigies are expected to promote unity in the house and the community. Members are expected to assist other members, whether on a personal, ballroom, or friendship level when needed. We function as one! This notion means that we chant for, and help, one another prepare, no matter the personal situation. We are one family, and we will respect each other.
- 8. The House of Prodigy is not a big fan of drugs. If you use drugs, please ensure that you are using them wisely. Make sure that the house will not suffer the consequences of your drug use. Use "hard" drugs privately, not during a ball. Alcohol, know your limit! We are not responsible for your drinking behavior, which will become our problem if it affects our house image. Being with friends/family can be a great time but be aware of your surroundings. Violence, (hard) drugs and misuse of alcohol are intolerable in this house and will be dealt with accordingly. If you see or feel that you or a house member is struggling with substance abuse and need help, we are here to help you, not judge you.
- 9. **Image is everything.** As a Prodigy, you must look, smell, and behave like a Prodigy. This means that your "Personal Appearance" will speak for the house.

Clean Haircut, Clean Beard Cut, Clean Clothes, Clean Teeth, Make-up on point, Hair Fixed, No Bad Body Odor. At the ball, we want you to look good, smell good, and everything else that will make you look like, and feel like, a true Prodigy!

10. The house will select a house dress code for specific balls. The dress codes will be chosen by the leaders, or sometimes members of the house, and finalized by the **Overall King & Queen.** 

If you have problems with the house dress code because of financials or personal reasons, **Talk to** your chapter leader as soon as possible for <u>POSSIBLE</u> assistance.

11. All members must stay at the table during a ball. We understand that balls are also a great social gathering, but we are there to compete and support our walking members. **STAY AT THE TABLE!** Anyone caught away from the table during the ball will suffer consequences from the Executive Board. Don't leave the table unsupervised. Leaving the table unsupervised causes uninvited people to sit at our table and profit from your dues. Staying at the table will also avoid any personal belongings being stolen. If you see an uninvited person at our table, please escort him/her/them from our space or have a leader do it if you don't feel comfortable!

Don't forget we show exclusiveness, so everybody cannot sit with us!

1st Offense = Warning 2nd Offense = Final Warning 3rd Offense = Dismissal

12. The House of Prodigy has many houses chants, and we will execute these chants loudly and in unison. Leadership will inform the house of the chants the house will use before a ball to ensure we will sound like a cohesive family.

Please remember that house chants are subject to change, add, or retire at any given time. All members must show strong support when a member is walking.

- 13. No one is allowed to discuss house business with anyone from another house, and if it is confirmed that a member has done so, their membership will be **REVOKED with NO QUESTIONS ASKED**.
- 14. All members should not be more than 15 minutes late to a house meeting without a valid explanation. However, if any member is going to be more than 15 minutes late or absent, with a valid reason, that member should contact their leader. If you are more than 15 minutes late, you will not be allowed into the meeting or practice, and this absence will be counted against your membership status in the house. House meetings are not scheduled around members; these meetings are carefully planned according to all members' schedules. If you need to be excused from a meeting, notify your chapter leaders or board members.

#### Sanctions

1st Offense = Verbal Warning 2nd Offense = Final Warning 3rd Offense = Dismissal

- 15. Any member absent from three (3) meetings in a calendar year will be dismissed from the house, and the Administrative Board will determine their reinstatement.
- 16. If any executive board member, or parent, misses two (2) meetings/conference calls in a calendar year without a valid reason, **The Overall King and Queen will remove them from the Executive Board, or position, and review their membership within the house**.

#### **Sanctions**

#### 1st offense = Warning 2nd Offense = Removal from the position

- 17. Members are expected to respect and acknowledge all Executive Board members, Regional leaders, and chapter leaders for their positions. Leaders and Executive Board members are expected to respect members respectfully (Leaders are not allowed to abuse their positions).
- 18. All Prodigys must walk (5) Major Balls (including House MANDATORY BALLS) per year to maintain active status as a Prodigy. Legends must walk (3) Major Balls per year. Icon's & O.G. Prodigy's may walk at their own discretion. Prodigy Weekend is MANDATORY.

#### Sanctions for missing a Mandatory Ball / Prodigy Weekend:

#### 1st Offense – Warning 2nd Offense – Dimissal

20. If a member of the Iconic House of Prodigy experiences an issue that makes them unable to participate in ballroom, that member may apply for INACTIVE STATUS. Final Inactive status will be decided by the Overall Parents, in conjunction with that member's chapter leader(s). A member must have been a Prodigy for at least one (1) year before becoming eligible for inactive status. The period of inactive status is a MINIMUM of 3 months. Inactive members must continue to pay house dues. Inactive members cannot walk balls, attend balls, nor attend meetings. Inactive members will be removed from all house related groups.

#### 21. **DUES**

House dues for active walking members are \$295.00 per year, and any gross negligence will cause a late charge of an additional \$10.00 per month.

House dues for support members are \$625.00 per year, and any gross negligence will cause a late charge of an additional \$10.00 per month.

Dues will be used for house supplies, meetings, and tables at mandatory balls. The additional support members dues fees will help to support members who need support at mandatory house balls.

There are several ways to pay dues:

#### Example 1

#### **Walking Members**

Pay \$20 per month plus \$75.00 due by July 31 for (Prodigy Weekend)

#### **Support Members**

Pay \$50 per month plus \$75.00 due by July 31 for (Prodigy Weekend)

#### Example 2

#### **Walking Members**

You can pay \$250 for the entire year by February 1. You can pay \$525 for the entire year by February 1.

You will be dismissed from the house for six months if you miss three consecutive dues payments. You will be required to pay your past-due balance plus fees upon reinstatement. Board members that miss three consecutive payments will first be removed from their position. If further negligence continues (4th Missed Payment), the Board member will be dismissed from the house for nine months.

22. If a member feels unhappy being a Prodigy, they should discuss this issue before deciding to leave the house with an Executive Board member.

#### 23. Admission Process:

- 1) Introduce the candidate to chapter leadership
- 2) Apply online and send a \$30 application fee to the Founding Father
- 3) The Overall Emperor & Empress will review the application and interview the candidate
- 4) If approved, the Executive Board will vote on conditional membership
- 5) If approved, the candidate must walk 2 Major balls as a 007 to review performance
- 6) The Executive Board will vote on the candidate's final admission to the house, on an Executive Board conference call.

- 7) If approved, The Overall Emperor & Empress will introduce the new member to their regional leader(s) to ensure that the candidate is aware of the official house business.
- 8) The Executive Board will officially welcome the new member to the house at Prodigy Weekend or one of 3 induction meetings throughout the year.
- 24. No Prodigy can host a ball without the approval of the Overall Parents, and the Overall Parents must approve all balls before any event planning and posting of the flyer. **Anyone who hosts a ball without the consent of the Overall Parents will be dismissed from the house**.

Members of the house will find any important news announcements regarding upcoming balls, dress codes, and house news (information) in our House of Prodigy Discord group. This group is to keep you up to date about the Iconic House of Prodigy. All new members will be admitted to the our House of Prodigy Discord group once their 90-day probation period is complete.

If you have any questions regarding the ballroom scene or house, feel free to post them in the House of Prodigy Discord group.

#### Official Rules & Regulations of The Founding Administrative Advisor Board

The Founding Administrative Advisor Board governs the entire board. They must finalize any significant decisions, including approving of opening new chapters, approving new chapter parents, approving house ball, approving changes to Prodigy Weekend, approving changes to the

house logo, approving ballroom statuses presented to any member of the house with the partnership of overall parents, and approving changes to any Prodigy literature.

Founding leaders are to be included in the reentry process for any former member that wishes to renew membership. The founding father will make the decision and present the verdict to the Overall Parents. The Founding Administrative Advisor Board can also protest a candidate's entry into the house.

All house information is to be reported to The Founding Administrative Advisor Board by Overall Parents, Overall Godparents, Overall Overseer, and Overall Secretary; this does not include nonimportant issues.

The Founding Administrative Advisor Board is also responsible for addressing any negligence or abuse of any board leadership roles.

The Founding Administrative Advisor Board has the right to remove any executive board member, or board member, with a valid reason, only if an issue with the party involved continuously occurs. The founding father will deliver all removals and explanations.

The Founding Administrative Advisor Board has the right to draft any candidate into the house without the approval of the Executive Board; however, the Founding Father will have to approve the draft. Afterward, Founding Administrative Advisor Board will notify the overall parents of their consent.

The Founding Administrative Advisor Board will have monthly meetings to touch base with the overall parents and executive board for any house updates and reports.

The Founding Administrative Advisor Board is here to support the Executive Board on any decision and assist in the house's daily functions. If the house is progressing positively and there are no problems, then The Founding Administrative Advisor Board holds no advisor duties! Explicitly, if there are no problems or concerns and no Founding Administrative Advisor Board addressing the overall parents and the Executive Board.

A Founding Administrative Advisor Board leader's responsibility is to give advice only when needed. Additionally, they must ensure that the overall board respectfully represents their leadership role correctly and that the integrity of the Iconic House of Prodigy's founding values is respected.

The Founding Father Mann Prodigy put the Founding Administrative Advisor Board in place to support him with making significant unbiased house decisions.

The Founding Administrative Advisor Board leader has a category title, such as runway, performance, and realness. That leader has the final say in deciding a candidate's admission to the house. The Executive Board is responsible for convincing The Founding Administrative Advisor Board leader that the candidate is a good fit!

If a Founding Administrative Advisor Board leader disapproves of a decision made by the Executive Board, the decision will be voted on by The Founding Administrative Advisor Board. However, if three Founding Administrative Advisor Board leaders disagree on a decision made by the Executive Board, the decision is null and void, meaning the action cannot happen. This notion only pertains to an Executive Board decision.

Dues will be collected once a year from The Founding Administrative Advisor Board leaders. Dues are collected to support any Founding Administrative Advisor Board gathering and to assist The Founding Administrative Advisor Board leaders fee into a ball, if necessary. The dues would be applied to a leader's admission fee only if the leader in question was never delinquent on a payment. The Founding Administrative Advisor Board leaders are responsible for paying dues every January of each calendar year. The amount is \$120, or \$10 a month, paid directly to the founding father! The Founding Administrative Advisor Board leader's dues do not include Prodigy Weekend dues!

If a Founding Administrative Advisor Board member chooses not to attend Prodigy Weekend, there is no penalty, which will reflect in that member paying their administrative board dues. However, if they decide to attend Prodigy Weekend, that member must pay their Prodigy Weekend dues in addition to The Founding Administrative Advisor Board dues.

When an Executive Board leader encounters an issue with a peer that is not resolved within the Executive Board group, The Founding Administrative Advisor Board steps in to assist and resolve the issue.

Any Executive Board member can come to a Founding Administrative Advisor Board member with any problem, comments, or concerns. Their conversation will remain confidential unless approved to discuss with all parties involved. If a Founding Administrative Advisor Board member leaks any information given by a leader, The Overall Founding Father will dismiss the Founding Administrative Advisor Board leader from their board duties!

If the Overall Parents feel a founding leader is abusing their power, it is to be reported to the Founding Father to be resolved. The founding father will investigate and render a verdict.

When dealing with an issue presented to them, it is not the Founding Administrative Advisor Board leaders' responsibility to handle the problem alone. They are to advise the member in question and then redirect the member to the appropriate Executive Board leader. However, suppose the

issue is beyond repair, and the member in question does not wish to present their case to the board. In that case, the Founding Administrative Advisor Board leader can set forth a motion with the Founding Administrative Advisor Board to conduct a hearing meeting with the member in question, and a decision will proceed.

All issues that are reported to The Founding Administrative Advisor Board leader will be investigated, and a Founding Administrative Advisor Board leader meeting will be held. The Founding Administrative Advisor Board will notify all parties involved, and a vote on a decision will proceed!

All Founding Administrative Advisor Board members must be available when an issue needs to be addressed! If there's a meeting called, Founding Administrative Advisor Board leaders must ensure you are in attendance!

#### **Direct Reports**

Chapter Leaders report directly to the Executive Board. All issues, comments, ideas, and concerns are directed to Executive Board only.

The Executive Board reports directly to the Overall Father and Overall Mother. All issues, comments, ideas, and concerns are directed only to the Overall Father and Overall Mother.

The Overall Father, Overall Mother, and Overall Overseer report directly to the Founding Father. All issues, comments, ideas, and concerns are directed to Founding Father only.

The Founding Administrative Advisor Board reports directly to the Founding Father. All issues, comments, ideas, and concerns are directed to the Founding Father only!

The Overall Father and Overall Mother govern all daily house functions. The Founding Father governs the Overall Father and Overall Mother, and their duties will not be interrupted unless they violate any administrative board terms and conditions!

The House of Prodigy will not tolerate any disrespect for any leader's position. All leaders' words, opinions, and concerns are valid and will be respected. Serving as a leader in the Iconic House of Prodigy is a privilege and being replaced is your option! Please respect and honor all terms and conditions of the founding leaders' rules and regulations. If any leader of this organization disagrees with these terms and conditions, address them with the Founding Father!

In the words of the founder, "We all must answer to someone to have a successful team. It's not about an individual and what they think, want, or feel; It's about the whole team and what we all think, want, or feel. No matter who it is, we all have a part in what Iconic House of Prodigy stands

for! If your part interrupts the path of what I started, your path with Prodigy will be interrupted by me." Icon Founding Father Mann Prodigy
