**Position Title:**     **Past President**

**Term of Office:**    Until they are no longer a Club member

**Reports to:**        Not applicable

**Job Summary:**     A Past President provides guidance to President and members as requested

### **Essential Functions:**

1.     Participates in the nomination process as requested by the Club Secretary
2.     Serves as a greeter of potential members at meetings and other Club functions
3.     Provides guidance as requested by Club officers and Board of Directors

**Position Title:**     **Immediate Past President**

**Term of Office:**    The administrative year following term of office as President

**Reports to:**        President and Board of Directors

**Job Summary:**     The Immediate Past President shall be a member of the Board of Directors and shall represent the Club in welcoming potential members and be a member of the Membership Committee

### **Essential Functions:**

1.     Is a member of the Membership Committee and serves as a greeter of potential new members at meetings and helps them feel welcome
2.     Acts as adviser to the President and assists in matters of the Club as requested
3.     Is a member of the Finance Committee

**Position Title: President**

**Term of Office:** Elected for one year

**Reports to:** Board of Directors

**Job Summary:** The President of the Lake Orion Lions Club shall be the Executive officer. They shall preside at all meetings and shall be the Chairman of the Board of Directors. They shall also cooperate with and be an active member of the District Governor's Advisory Committee of the Zone in which the Club is located

**Essential Functions:**

1. Calls for all regular and special Board of Directors meetings
2. Oversees the organizational structure of the Club. Appoints the standing administrative and activity committees in accordance with the Lions International Club Standard Organizational Plan, and other committees as deemed necessary for the day-to-day operation of the Club and the property, if any, of the same.
3. Acts as ex-officio member of each committee
4. Monitors all committees to ensure that these committee function and members cooperate with the appointed chairperson. Establishes and monitors good communication between the committee and the Board of Directors
5. Calls for regular committee reports at the Board of Directors meetings
6. Calls for financial reports within 60 days of the completion of any fund raising activity or others as deemed necessary
7. Holds fiduciary responsibility within the Club and has check signing privileges
8. Is a member of the Finance Committee
9. Represents the Lake Orion Lions Club at District functions, Kick-Offs, and community events

**Position Title: First Vice President**

**Term of Office:** Elected for one year

**Reports to:** President and Board of Directors

**Job Summary:** The First Vice President assists the President and traditionally will accept nomination for President for the following administrative year

**Essential Functions:**

1. Represents the President at any and all functions when the President is absent
2. Is a member of the Finance Committee
3. Coordinates programs with the Second Vice President for Club dinner meetings
4. Co-Chairs with the Second Vice President the Emergency Services Committee
5. Acts as Chairperson of the Community Services Committee.
6. Serves as Assistant Secretary to learn more about the position.

**Position Title:**     **Second Vice President**

**Term of Office:**   Elected for one year

**Reports to:**        President and Board of Directors

**Job Summary:**     The Second Vice President assists the President and traditionally will accept nomination for First Vice President for the following administrative year

**Essential Functions:**

1.    Is a member of the Finance Committee
2.    Chairs the Retention and Mentoring Committees
3.    Coordinates programs with the First Vice President for Club dinner meetings
4.    Co-Chairs with the First Vice President the Emergency Services Committee
5.    Acts as Chairperson of the Ways & Means Committee.
6.    Serves as Assistant Treasurer to learn more about the position.

**Position Title:**     **Secretary**

**Term of Office:**   Elected for one year

**Reports to:**        President and Board of Directors

**Job Summary:**     The Secretary is responsible for reporting Club membership activities to Lions International and District 11 A 2 as requested. Keeps records of Club meetings and decisions made there. Assists the President as needed

**Essential Functions:**

1.    Receives all monies from the Committee Chairpersons and provides a receipt when requested and passes monies to the Treasurer for recording in the records
2.    Prepares vouchers for payment of Club bills after approval of Board of Directors
3.    Has check signing privileges and is a member of the Finance Committee
4.    Provides Board of Directors meeting agenda after input from Club President
5.    Provides detailed minutes of Board of Directors meetings and decisions made
6.    Provides assistance to Club President as requested and as needed
7.    Ensures that all record keeping is clear, concise, accurate & easy to understand
8.    Acts as primary contact with Lions International
9.    Orders Club supplies as needed

**Position Title:** Treasurer

**Term of Office:** Elected for one year

**Reports to:** President and Board of Directors

**Job Summary:** The Treasurer is responsible for receiving, recording, and distributing all monies from the various Club internal and external fund-raising activities

**Essential Functions:**

1. Receives all monies from the Secretary and deposits same in the Club bank accounts based on the type of function for which fund raising was done
2. Pays out money only on the authority of the Board of Directors
3. Has check signing privileges
4. Provides a detailed monthly report for the Board of Directors of all financial activities
5. Is a Chairperson of the Finance Committee

**Position Title:** Lion Tamer

**Term of Office:** Elected for one year

**Reports to:** President and Board of Directors

**Job Summary:** The Lion Tamer is responsible for the care and protection of all Club property

**Essential Functions:**

1. Has charge of and is responsible for Club property and paraphernalia
2. Sets up Club banner and American flag prior to each Club meeting and ensures the Club bell is at the President's place prior to the start of any meeting
3. Distributes material at the meeting as requested
4. Acts as sergeant-at-arms during meetings

**Position Title:** Tail Twister

**Term of Office:** Elected for one year

**Reports to:** President and Board of Directors

**Job Summary:** The Tail Twister is responsible to promote harmony, good fellowship and enthusiasm in Club meetings through appropriate activities and judicious use of fines for inappropriate behavior

**Essential Functions:**

1. Fines members for inappropriate behavior such as not wearing Club pin/nametag, speaking out of turn, failing to call a member by his proper Lion name, and similar things which in his sole determination merits a fine all within good taste.
2. Ensures that every member is treated fairly and humorously.
3. Accepts a fine on himself when levied by the District Governor or the unanimous vote of the Club members attending the meeting
4. Turns all fine money collected over to the Treasurer before the end of the meeting

**Position Title:** Director (Member of the Board of Directors)

**Term of Office:** Elected for one year

**Reports to:** President and Board of Directors

**Job Summary:** A Director is responsible for setting policy, approving activities and overseeing the operation of the Club. A Director is required to attend Board Meetings, and if they miss two consecutive unexcused meetings, they may be removed for the Board by the President with the approval and by a majority vote of the Board.

**Essential Functions:**

1. Attends and participates in Club meetings (Board & general) and takes an active role in Club activities
2. Authorizes expenditure of Club funds in accordance with Club objectives
3. Acts on and approves new activities and policies before presentation to general members
4. Approves new members after recommendation from Membership Committee
5. Assists President and other Board members as requested.

**Position Title:** Committee Chairperson

**Term of Office:** As appointed/volunteers

**Reports to:** President and Board of Directors

**Job Summary:** A Committee Chairperson is responsible for overseeing and coordinating the activities of the committee and reporting to the Board of Directors

**Essential Functions:**

1. Develops a plan for committee operation and activities
2. Seeks approval from the Board for the activity and the budget for revenues and expenditures for the activity
3. Recruits others to help with the activity
4. Holds committee meetings, records decisions and reports same to Board of Directors
5. Attends all Board meetings before, during and after the activity to keep it informed
6. Collects all monies generated by the activity and gives them to Secretary along with any and all invoices needing payment
7. Prepares and presents final report to Board after conclusion of the activity indicating funds raised, expenditures made, things that went well and things that could be improved upon when the activity is done again
8. Prepares a manual listing the tasks to be done to have a successful activity, the budget needed, recommendations for doing the activity in the future and other possible sources of help
9. Recruits and trains a Club member to be Assistant Committee Chair so someone knows what needs to be done and how to do it in the future

**Position Title:**     **Membership Committee Chairperson**

**Term of Office:**   Elected for one year

**Reports to:**        President and Board of Directors

**Job Summary:**     Membership Chair helps club members in recruiting new members to join the club.

**Essential Functions:**

1.     Provide members with all necessary recruiting materials to be given to interested individuals looking to join the club.
2.     Inform Board of potential new members once they have been to the required meetings and been interviewed by the Membership Committee
3.     Ask for vote of approval for new members.
4.     Coordinate with Secretary to have new badge ordered and set up installation date
5.     Pick up new member badge to have ready for installation
6.     Ensure new member has been properly and formally installed
7.     Provide all new members with proper new member kit, including badge and pin
8.     Assist Secretary with contacting members who have not paid dues
9.     Organize annual new member open house & new member orientation

## Lake Orion Lions Club Policy Manual

### Membership

To become a member of the Lake Orion Lions Club you must be invited by a current club member who is in good standing. The process includes the following items:

Completion of application

Attending two Lake Orion lions Club meetings and / or functions.

Interviewed by the membership committee

Approval of membership by the Lake Orion Lions Club board of directors

Upon approval, there would be a formal installation into the Lake Orion Lions Club

### Participation

As a member of the Lake Orion Lions Club you are encouraged to participate as detailed below:

- Attendance at club meetings to the best of your ability and be willing to make suggestions and recommendations
- Attendance at Club Board Meetings to find out what is going on in the club and where we are donating the money you worked to raise. **ALL MEMBERS ARE INVITED AND ENCOURAGED TO ATTEND**
- Participate in club fund raising events & club community service events

We encourage you to volunteer your assistance based on the things you like doing and have experience at. A list of committees is in the club roster book and you can contact the chairperson of the committee you would like to participate in.

Signup sheets for the various functions are usually distributed at the meetings and noted in the club newsletter.
