



These terms and condi ons ("Terms and Condi ons") govern the rela onship between Vaca ons by Sally LLC d/b/a Vaca ons by Sally ("VBS" and/or "us/our") and you, the purchaser and/or traveler ("Client" and "passenger" and "you/your"). By planning travel with VBS, you agree to be bound by these terms and acknowledge that VBS acts solely as a booking agent for disclosed principal supplier tour operators, cruise lines, hotels, airlines, air charters, bus companies, ground transporta on, boat purveyors or owners, and other independent contractors providing accommoda ons, transporta on, and other services ("Supplier(s)") and is not the source or provider of the travel services. These terms include warran es and disclaimers and exclusions of liability and may restrict your rights and remedies and provide protec on to VBS. 1. USE OF VBS SERVICES, ACCESS AND INFORMATION FOR TRAVEL BOOKINGS You warrant that you are at least 18 years of age and possess the legal authority to enter into this Agreement and to make travel bookings with VBS. You agree to be financially responsible for all of your travel bookings made on behalf of yourself and any member of your traveling party and warrant that all informa on supplied by you on behalf of yourself, members of your household, or others for whom you are authorized to transact business with us is true and accurate. You agree that you will only make legi mate reserva ons or purchases with VBS and its Suppliers, and acknowledge that, without limita on, any specula ve, false, or fraudulent reserva on is prohibited. All bookings are accepted by VBS as agent for the travel Suppliers on your i nerary. Separate Supplier terms and condi ons will apply to your reserva on and purchase of travel-related goods and services that you select, and you understand and agree to abide by the terms and condi ons of purchase imposed by any Supplier that you have selected as a service provider on an inerary you have approved. 2. PAYMENTS AND CANCELLATIONS You shall be completely responsible for all charges, fees, du es, taxes, and assessments arising out of your travel bookings through VBS. By subming a credit card authoriza on form to VBS, you agree to allow VBS to use your payment method to purchase travel products from our Suppliers on your behalf. EXCEPTING IN CASES OF FRAUD, YOU AGREE NOT TO FILE ANY DISPUTE WITH YOUR BANK OR CREDIT CARD COMPANY TO AVOID OR VIOLATE ANY BOOKING TERMS AND CONDITIONS OF VBS OR ITS SUPPLIERS, INCLUDING CANCELLATIONS OR CHANGES OF ITINERARY OR ARRANGEMENTS FOR REASONS BEYOND THE CONTROL OF VBS OR ITS SUPPLIERS. IF YOU ATTEMPT TO CHARGEBACK, REVERSE OR RECOLLECT A PREVIOUSLY AUTHORIZED TRIP PAYMENT, VBS RESERVES THE RIGHT TO COLLECT ALL ADDITIONAL COSTS, FEES AND EXPENSES ASSOCIATED WITH SUCH CHARGEBACK, REVERSAL OR RECOLLECTION, INCLUDING, WITHOUT LIMITATION, ATTORNEY FEES. All payments for travel are due prior to departure according to each Supplier's terms and condi ons of booking. You understand that failure to make final payment or any viola on of a Supplier's condi ons of purchase may result in cancella on of your reserva ons, in your being denied access to any flights, tours, hotels, cruises, or other travel services, or in your forfei ng any monies paid for your reserva ons. In some cases, there is NO REFUND once a booking is made and under deposit. You may not be en tled to a refund if you change or cancel your travel plans a er confirma on of a booking. All cancella on requests must be sent to VBS in wri ng. As a result of cancella on, third-party Supplier's cancella on penal es will apply. Cancella on fees will be charged to the credit card or other payment method you authorized to pay for travel services or deducted from the Supplier's refund. 3. TRAVEL DOCUMENTS, INCLUDING TSA AND DHS ACCEPTABLE IDENTIFICATION REQUIREMENTS It is the responsibility of each Client to obtain and carry a valid passport, visa(s), and all other documents required by applicable government regula ons. When traveling domes cally or interna onally, the U.S.

Transporta on Security Administra on (TSA) and U.S. Department of Homeland Security (DHS) advise that everyone carry acceptable iden fica on in order to board a flight. Acceptable iden fica on can be found at h p://www.tsa.gov/traveler-informa on/ acceptable-ids; examples are DHS-designated enhanced driver's license, Passport, a foreign government passport. The name, date of birth and gender that appears on the iden fica on card must exactly match the same such data that is listed on airline cket(s) and booking records. You acknowledge any failure to strictly comply with these requirements may result in denied boarding or an undue delay at an airport security checkpoint causing Client to miss f light(s), and subsequent scheduled travel bookings on cruises and tours. WHEN YOU RECEIVE ANY AND ALL TRAVEL DOCUMENTS, IT IS YOUR RESPONSIBILITY TO REVIEW AND VERIFY ALL INFORMATION FOR ACCURACY. CONTACT VBS IMMEDIATELY IF CHANGES OR CORRECTIONS ARE REQUIRED. VBS strongly recommends that you take into account that certain countries will not admit a passenger if their passport expires within six (6) months of the an cipated date of return. Non United States ci zens may require addi onal documenta on. Client is responsible to make VBS aware when traveling on a passport from a country other than the United States of America. VBS neither controls nor warrants the issuance of visas or approval of visa waivers related to your travel. Should a visa not be issued, VBS is not responsible for lost payments made toward the contemplated trip. Please note that rules of each country regarding entry and exit change on a daily basis. Children and infants also require travel documents. Minors traveling with one parent, and/or without both parents, may be stopped and not admi ed, unless authen cated and verified consent forms are provided to the authori es; please see h ps://help.cbp.gov/s/ar cle/ Ar cle-3643 for addi onal informa on. 4. INDIVIDUAL ENTRY AND EXIT REQUIREMENTS Each country holds different views of past criminal offenses, whether within or outside of their boundaries. If you have a current or prior criminal offense, contact that country directly for entry and exit requirements. You can visit the US State Department Website for further informa on about these requirements. See, h ps://travel.state.gov/content/travel.html. We do not inquire about an individual's criminal record in the interest of respec ng our Clients' privacy. For example, if traveling to or through Canada, individuals with a Driving While Intoxicated (DWI) record should review current entry requirements. HAZARDOUS MATERIALS Federal law prohibits passengers from bringing hazardous materials on the aircra. (1) Federal law forbids the carriage of hazardous materials aboard aircra in the passenger's luggage or on the passenger's person. A viola on can result in five years' imprisonment and penal es of \$250,000 or more (49 U.S.C. 5124). Hazardous materials include explosives, compressed gases, flammable liquids and solids, oxidizers, poisons, corrosives and radio- ac ve materials. Examples: Paints, lighter fluid, fireworks, tear gases, oxygen bo les, and radiopharmaceu cals. (2) There are special excep ons for small quan es (up to 70 ounces total) of medicinal and toilet ar cles carried in the passenger's luggage and certain smoking materials carried on the passenger's person. INSECTICIDE NOTICE We recommend that you refer to the DOT list of airports in countries that require airlines to treat the passenger cabin with insec cides prior to the flight or while on the aircra. This list is on the DOT's website and is updated from me to me: h p://www.dot.gov/office-policy/ avia on-policy/aircra-disinsec on-requirements. 7. HEALTH/IMMUNIZATIONS You must have the proper immuniza ons and health screenings and required documenta on of such immuniza ons and screenings before travel. VBS shall not assume responsibility for the accuracy of health, vaccina on, or documenta on prior to departure or upon landing at the final des na on. In some cases, required inocula ons must

be recorded by Client's health prac oner on a valid vaccina on cer ficate, which the Client must carry for proof of inocula on. If you are concerned about taking any medica ons or receiving certain inocula ons, check with your health prac oner BEFORE booking. Check the State Department Web site h p://travel.state.gov, for relevant informa on relang to travel to specific des na ons, and the Center for Disease Control h p://wwwnc.cdc.gov/travel/ rela ng to health issues related to travel. 8. AIR TRAVEL, SCHEDULE RECONFIRMATION, CHECK-IN Your airline cket is a contract between you and the air carrier, even if you purchase through Vaca ons by Sally. If you purchase air travel through Vaca ons by Sally, you acknowledge and agree that Vaca ons by Sally does not have the right to control the opera ons of independent airlines, and agree that Vaca ons by Sally is not liable for any personal injury, property damage related to your purchase of air ckets or air travel, including, but not limited to any act, error, omission, injury, loss, accident, or delay caused by any act, error or omission of the airline, including their failure to deliver services, par al or inadequate delivery of services, airline policies including refund or rebooking policies, fees for checked or carry-on luggage, fuel increases, bankruptcy or cessa on of opera ons. You understand and agree that Vaca ons by Sally func ons solely and exclusively as a booking agent for the air carrier, that we do not handle or hold client funds for airline ckets, and that we are not the Merchant of Record under the meaning of that term under the Department of Transporta on's regula ons. Because Vaca ons by Sally does not hold or handle client funds, you understand and agree that any refund for cancelled or delayed flights, baggage fees or seat assignments must come directly from the airline and not from Vaca ons by Sally. Vaca ons by Sally shall not assume any responsibility for any air schedule changes. In rare instances, upon departure from a country, certain departure taxes must be paid in cash only, and may vary in price. Failure to use a reserva on may result in automa c cancella on of all con nuing and return flights, as well as forfeiture of airfares. Airline e-ckets expire a year from issue date unless carrier fare rules in passenger's i nerary fare provide otherwise. Due to enhanced security, it is strongly recommended that you check in a minimum of 2 hours prior to scheduled departure for domes c flights and 3 hours prior to scheduled departure me for interna onal flights. Reconfirm flight mes at least 24 hours prior to scheduled departure me for domes c flights, and 72 hours prior for interna onal flights. Frequent Flyer mileage accrual is at the discre on of the airline(s). Vaca ons by Sally has no liability if accrual of miles or points is denied or if upgrades are not allowed. Many airlines do not permit upgrades on airfare purchased in certain fare classes or when using frequent flyer miles, loyalty status or cer ficates. Seat assignments are not guaranteed even a er they are assigned, and Vaca ons by Sally has no control over airline seat assignments. Most airlines charge a fee to pre book a seat. 9. RIGHT TO CORRECT ERRORS/OFFERS SUBJECT TO AVAILABILITY We reserve the right to correct errors. In the event of any pricing error or omission, we reserve the right to adjust such pricing or make any other correc ons. All offers, incen ves and Supplier promo ons are subject to availability and may change without no ce. Prospec ve Clients are advised to reserve early to avoid disappointment, increases in fares and addi onal late booking fees. 10. UNUSED ARRANGEMENTS, MINIMUM PASSENGER REQUIREMENTS AND ALTERATIONS TO BOOKINGS When tour, cruise or package prices are based on Suppliers' contract rates, you will not be en tled to any refund for any unused por on of travel. Some group tours are based on minimum numbers of passengers traveling; if the number of passengers falls below the minimum required, a surcharge may be imposed, or the tour may be canceled. Any cancella ons of a tour or package for reason of failing to meet the minimum traveler requirement will be governed by the tour operator's cancella on policy. If you decide to change any por on of your confirmed arrangements prior to departure or during your trip, we will a empt to assist you. Certain bookings may not be able to be changed. All requests for changes to a booking must be made in wring to VBS. The Supplier may

determine that altera ons in i nerary are necessary for any number of reasons, including but not limited to severe weather. Any altera ons to an i nerary are at the sole discre on of the Supplier, and VBS bears no responsibility for any changes. 11. LIMITATIONS OF RESPONSIBILITY AND DISCLOSURE VBS acts solely as a booking agent for disclosed principal Suppliers and is not the source or provider of any travel service. Each Supplier is an independent en ty with its own management and is not subject to the control of VBS. The Suppliers whose names appear in travel documenta on are those actually responsible for providing the travel services purchased, and you consent to the use of those Suppliers. BECAUSE VBS ACTS AS AGENT FOR DISCLOSED PRINCIPAL SUPPLIERS AND DOES NOT HAVE THE RIGHT TO CONTROL THE OPERATIONS OF SUCH INDEPENDENT OPERATORS AND SUPPLIERS, YOU AGREE THAT VBS IS NOT LIABLE FOR ANY PERSONAL INJURY OR PROPERTY DAMAGE, WHICH MAY ARISE OUT OF THESE SERVICES. VBS HEREBY DISCLAIMS ANY LIABILITY WHETHER BASED ON CONTRACT, TORT, STRICT LIABILITY, OR OTHERWISE, INCLUDING WITHOUT LIMITATION LIABILITY FOR ANY DIRECT, PUNITIVE, SPECIAL CONSEQUENTIAL, INCIDENTAL OR INDIRECT DAMAGES IN CONNECTION WITH THE GOODS OR SERVICES PROVIDED BY ANY PRINCIPAL SUPPLIER BOOKING THROUGH VBS, INCLUDING WITHOUT LIMITATION LIABILITY FOR ANY ACT, ERROR, OMISSION, INJURY, LOSS, ACCIDENT, DELAY OR IRREGULARITY WHICH MAY BE INCURRED THROUGH THE FAULT, NEGLIGENCE, WILLFUL ACTS, OMISSIONS OR OTHERWISE OF SUCH SUPPLIER, OR OF ANY SUPPLIER OR THEIR RESPECTIVE EMPLOYEES, AGENTS, SERVANTS, OR REPRESENTATIVES, INCLUDING, WITHOUT LIMITATION, THEIR FAILURE TO DELIVER OR THEIR PARTIAL OR INADEQUATE DELIVERY OF SERVICES, THEIR CANCELLATION AND REFUND POLICIES, FUEL INCREASES, BANKRUPTCY, OR CESSATION OF OPERATIONS AND OTHER MATTERS OUTSIDE OF VBS'S CONTROL, AND YOU HEREBY EXONERATE VBS FROM ANY LIABILITY WITH RESPECT TO THE SAME. VBS HAS SOLELY RECEIVED COMMISSION AND FEES FOR TRAVEL TRANSACTIONS AND CLIENT AGREES AND UNDERSTANDS THAT ANY RECOVERY FROM VBS WILL BE LIMITED TO THE AMOUNT OF COMMISSION AND FEES ACTUALLY RECEIVED BY VBS. We may book wellness travel for clients, which may include yoga, medita on, medi-spa, and other ac vi es, treatments and services intended to maintain, manage, or improve travelers' health and well-being ("Ac vity" or "Ac vi es"). We have no specialized knowledge of the prac ces or techniques employed by our Suppliers, and make no representa ons of the qualifica ons of the professionals and prac oners who offer these Ac vi es. We make no representa ons that by par cipa ng in these Ac vi es there will be any demonstrable improvement in your physical, mental, emo onal, or spiritual well-being. We are not responsible if your par cipa on in these ac vi es leads to a worsening of any condi on you may have. We are not responsible for any injuries you may sustain, illnesses you may contract, including injuries or illnesses that may result in loss of life. You acknowledge that you are voluntarily par cipa ng in the Ac vi es on your i nerary, and that you understand that there are risks associated with your par cipa on in the Ac vi es, such as physical and/or psychological injury, pain, suffering, illness, disfigurement, temporary or permanent disability, death or economic loss. These injuries or outcomes may arise from your own or other's ac ons, inac ons, or negligence, or the condi on of the Ac vity loca on(s) or facility(ies). Nonetheless, you assume all risks of your par cipa on in the Ac vity, whether known or unknown to you, including travel to and from the Ac vity (including air travel) or any events incidental to the Ac vity. 12. RISKS/SAFETY Travel to certain des na ons may involve greater risk than others. VBS urges Clients to remain informed on a daily basis as to current news events, as well as to review travel prohibi ons, warnings, announcements and advisories issued by the United States Government prior to booking travel to interna onal des na ons. BY OFFERING FOR SALE TRAVEL TO PARTICULAR DESTINATIONS, VBS DOES NOT REPRESENT OR WARRANT THAT TRAVEL TO SUCH POINTS IS ADVISABLE OR WITHOUT RISK, AND SHALL NOT BE LIABLE FOR COSTS, DAMAGES, OR LOSSES THAT MAY RESULT FROM TRAVEL TO SUCH DESTINATIONS. CLIENT'S PARTICIPATION CONSTITUTES ACCEPTANCE OF SUCH EVENTS AT CLIENT'S OWN RISK. In the event of emergent health or safety concerns, once VBS has inves gated the prevailing situa on, VBS shall have the sole and absolute discre on whether to proceed with any VBS escorted trip or private departure, or to make altera ons to the inerary. 13. FORCE MAJEURE VBS will not be in breach of these terms and condi ons or otherwise be liable to you, for any failure or delay in performing an obliga on under this Agreement that is due to any of the following causes, to the extent beyond its reasonable control: acts of God, accident, riots, war, terrorist act, epidemic, pandemic, quaran ne, civil commo on, breakdown of communica on facili es, including web host and internet service provider, breakdown or malfunc on of equipment, destruc on of or serious damage to facili es, natural catastrophes including, but not limited to extreme weather events, floods and volcanic erup ons, governmental acts or omissions, changes in laws or regula ons, na onal strikes, fire, explosion, generalized lack of availability of raw materials or energy, and any other unforeseen circumstance which is beyond the control of VBS. THE PURCHASE OF TRAVEL INSURANCE IS HIGHLY RECOMMENDED ON ALL TRIPS. In addi on, each of VBS's Suppliers have terms and condi ons which include Force Majeure provisions. In the event that a Force Majeure event occurs, those Suppliers may be en tled to, and may in their sole and absolute discre on, vary, postpone or cancel any i nerary or arrangement in rela on to the trip. Payment of any refund to you as a result of the non performance of any obliga ons hereunder shall remain in the sole and absolute discre on of the Supplier, pursuant to their policies, although VBS shall use its reasonable efforts to secure reimbursement for you where possible. 14. CLIENT CONDUCT Each par cipant in any trip escorted by VBS is expected to act responsibly and adhere to all behavior guidelines established by VBS and our Suppliers. VBS and all local Suppliers reserve the right to remove you from any facility, hotel or resort property, tour loca on or means of transporta on if your health or your conduct appears to endanger yourself or others, disrupts the general well-being of other clients on any element of your trip, or interferes with the opera on or security of the places we visit. In any such case, there will be no refund. When you book with VBS, you accept responsibility for any damage or loss caused by you. Full payment for any such damage or loss (reasonably esmated if not precisely known) must be paid directly at the me to the accommoda on owner or manager or other Supplier. You must indemnify us for the full amount of any claim (also including legal costs) made against us. We are not responsible for any costs incurred concerning a guest removed from a trip, or any por on of a trip. You agree not to hold VBS or any of its related en es liable for any ac ons taken under these terms and condi ons. Baggage and personal effects are at all mes the sole responsibility of the par cipant. 15. CURRENCY FLUCTUATIONS Currency exchange rates fluctuate. Prices are subject to change based upon currency exchange rate fluctua ons. VBS is not responsible for surcharges or foreign transac on fees imposed by Client's credit card or bank. 16. TRAVEL INSURANCE VBS OFFERS ACCESS TO TRAVEL INSURANCE TO PROTECT PASSENGERS AND THEIR INVESTMENT IN TRAVEL. UNLESS SPECIFICALLY NOTED, TRAVEL INSURANCE IS NOT INCLUDED IN THE COST OF CLIENT'S ITINERARY TO PROTECT AGAINST THIRD PARTY SUPPLIER DEFAULT/BANKRUPTCY PROTECTION, DELAY, INTERRUPTION, MISSED CONNECTION FOR CRUISES, CANCELLATION, MEDICAL

EMERGENCY TRANSPORTATION/EVACUATION & REPATRIATION, BAGGAGE & PERSONAL EFFECTS/LOST LUGGAGE & BAGGAGE DELAY, ILLNESS, JOB LOSS PROTECTION AND CHANGE OF PLANS, ACCIDENTAL DEATH AND DISABILITY, TRAVEL ACCIDENT/SICKNESS MEDICAL EXPENSES, AND MORE. PROPER INSURANCE MAY PROTECT YOU FROM FINANCIAL LOSS IN ALMOST ALL CIRCUMSTANCES. Without appropriate travel insurance, Client understands and agrees that if Client cancels or interrupts Client's travel for any reason, por ons of the trip/tour may not be refunded and VBS's and travel Suppliers' cancella on penal es will apply resul ng in the loss of monies up to the full cost of Client's travel booking and related costs. The purchase of travel insurance is not required in order to purchase any other product or service offered by VBS, however if you decline to purchase insurance, VBS will require that you execute an insurance waiver. VBS is not a licensed insurance broker, and its advisors are not qualified or authorized to answer technical ques ons about benefits, exclusions, and condi ons of any of the insurance offered, nor evaluate the adequacy of the prospec ve insured's exis ng insurance coverage. An addi onal charge applies for any travel insurance selected. VBS CANNOT GUARANTEE THAT ANY INSURANCE PROVIDER WILL APPROVE COVERAGE FOR A CLAIM MADE UNDER THE INSURER'S POLICY AND MAKES NO REPRESENTATIONS ABOUT THE EXTENT OF COVERAGE FOR ANY POLICY IT MAY OFFER OR QUOTE. 17. RESERVATION OF RIGHTS: CHANGES TO THESE TERMS We reserve the right, in our sole discre on, to change these Terms and Condi ons at any me. Updated versions of the Terms will be provided to Clients, will be posted on our website and are effec ve immediately on pos ng. 18. GENERAL The laws of the State of Georgia govern these Terms and Condi ons. You hereby consent to the exclusive jurisdic on and venue of courts in Coffee County, Georgia in all disputes arising out of or rela ng to travel bookings with VBS. If any part of these Terms and Condi ons is determined to be invalid or unenforceable pursuant to applicable law including, but not limited to, the warranty disclaimers and liability limita ons set forth above, then the invalid or unenforceable provision will be deemed superseded by a valid, enforceable provision that most closely matches the intent of the original provision and agreement shall con nue in effect. These Terms and Condi ons (and any other terms and condi ons referenced herein) cons tute the en re agreement between the Client and VBS with respect to travel bookings made with VBS by any means, and it supersedes all prior or contemporaneous communica ons and proposals, whether electronic, oral, or wri en, between Client and VBS with respect to communica ons with VBS. A printed version of this agreement and of any no ce given in electronic form shall be admissible in judicial or administra ve proceedings based upon or relang to these Terms and Condi ons to the same extent and subject to the same condi ons as other business documents and records originally generated and maintained in printed form.
