# **Notes from Meeting with Trainers**

Springfield, OH August 1, 2019

**Issue:** Attendance at PFHA regional shows has been declining and some of the shows are no longer profitable. Regional chapters are at risk of being shut down due to lack of funds.

**Proposed solution:** Kentucky, Great Lakes and Ozarks regions combine to host one annual show with costs and proceeds split between the regions.

### Advantages:

- Larger pool of volunteers to plan and run the show
- Likely to draw more exhibitors classes would be larger
- Larger classes create more excitement

#### Challenges:

- Might require a PFHA rule change
- Would make it much harder for some horses to qualify for Nationals (points system)
- Limits the amount of show experience the horses get prior to Nationals
- Timing need to stay away from Asheville Alive, Murfreesboro and Nationals dates (July, early August or October would work)
- Fall show would require an indoor facility
- Need 200 horses to support a big show
- Great Lakes is under contract with the Champions Center for two more years

#### Options:

- Make the show four-days long
- Hold the show at Kentucky Horse Park
- Offer cash prizes for the championship classes (will need sponsors)
- Regions split the proceeds based on number of horses from each region

#### Other ideas:

- Propose a rule change to eliminate the point system to qualify for Nationals.
- Alternative to point system could be a requirement to attend at least two regional shows
- Build a 'show circuit' one show in the Northeast; one show in the Midwest'; possible schedule:
  - Spectrum in March
  - o Asheville in June
  - Northeast in July/August
  - Nationals in September
  - Midwest in October
- Create farm shows with music and food; could be qualifier shows for the circuit shows and/or could be used to get horses used to the show environment; consider offering "try a Paso Fino" day as part of the farm shows

#### Consensus from all attendees: CHANGE IS NEEDED!

#### **Actions:**

- Attendees provided names and contact numbers with a commitment to help find a solution.
- Joe Hartke to investigate potential use of Kentucky Horse Park.
