- There is no cost for a family to enroll. Tuition Rewards points are provided courtesy of your financial advisor.

- Only private colleges that give "non-need" financial aid are eligible to join.

Yes. Rewards points are not itemized on the FAFSA form. Tuition Rewards represent the minimum scholarship that a member school is obligated to offer. Participating colleges may use Tuition Rewards as part of, or separate from, their normal financial aid packages.

IS ANY MONEY DEDUCTED FROM MY ASSETS?

No. This is a free program. Reward Points are an extra benefit for being a valued customer. Similar to frequent flyer miles, Reward Points are redeemable as tuition discounts, not cash.
