<u>PIAA dues</u> are payable directly to PIAA online. Fees are \$50/sport until January 15th, \$55/sport from January 16th through February 28th. From March 1 until March 31 you will need to add a \$25 late fee. If you are planning to go inactive, contact Melissa Maiolino at pwluasecretary@gmail.com.

<u>PIAA clearances</u>. Background (3) clearances are required of all officials. Check the PIAA website for information. This information was also emailed to each official from PIAA in the <u>Spring Officials Bulletin</u> Please take care of your clearance ASAP. http://www.piaa.org/officials/become/clearances.aspx

Every official needs to purchase their own insurance. PIAA no longer provides this for officials. USAL provides insurance along with other companies. You must have insurance in order to officiate.

<u>USA Lacrosse membership renewal</u> is due. Go to the website to confirm your membership status, if you have not done so already.

Non-PIAA members must attend four (4) meetings, plus a USA Lacrosse Rules Interpretation meeting (online only). Attendance at the online US Lacrosse Rules Interpretation meeting does NOT fulfill the PIAA Rules Interpretation requirement. NOTE: You must attend a meeting in April, per PIAA requirements. There is a PIAA test that will be available for credit as a pre-season meeting. The PIAA test will be available online for one month only (February 14th to March 14th) and will be recorded automatically as a meeting in your PIAA account/profile. This test is on the PIAA website and is the ONLY test that can be used for meeting credit.

You need your test completed <u>prior</u> to a rating session. You also need to complete this test to maintain your certification.

- **Girls' Lacrosse Rules Online Course** All officials (Level 1, 2, 3) are required to complete the Online Rules and Penalty Course one time during their career
