PROPER DRILL PADDLE USAGE

PLEASE READ THESE PROPER USAGE INSTRUCTIONS CAREFULLY.

We want you to enjoy your new Drill Paddle for as long as possible.

ASSEMBLY OF THE DRILL PADDLE

- 1. The EXTENDABLE version of the Drill Paddle has threaded end caps for removal and repair. Always check after each use to make sure they are tight and secure. A few drops of vegetable oil occasionally, on prop and drill ends, will extend the life of the Drill Paddle.
- 2. Insert the Drive Shaft end into the chuck on your selected battery powered drill.
- 3. Tighten chuck to securely hold the Drive Shaft
- 4. Your Drill Paddle is now ready for operation.
- 5. Alway's contract EXTENDABLE version to smallest position when not in use.

USAGE OF THE DRILL PADDLE

- 1. If using an EXTENDABLE version of the Drill Paddle, use the twist lock mechanism (left to loosen, right to tighten) to extend and lock at the desired length.
- 2. Firmly secure one hand on your selected battery powered drill. This will be your direction hand.
- 3. With your other hand, hold the Blue Foam handgrip. This will be your pivoting hand.
- 4. Lower the propeller end of the Drill Paddle into the water while keeping the Drive Shaft at an angle.
- 5. Keeping your pivot hand stationary, move your direction hand in the opposite direction that you want to you move your watercraft. This will put the propeller in the proper alignment to move the watercraft in the desired direction.

PROPELLER REPLACEMENT

CAUTION: Disconnect the power source from the Drill Paddle before beginning any propeller work or maintenance.

- 1. Disconnect the power source from the Drill Paddle prior to changing the propeller.
- 2. Hold the propeller and loosen the Prop Nut with pliers or a wrench.
- 3. Remove the Prop Nut. If the Shear Pin is sheared or broken, you will need to hold the Drive Shaft stationary with pliers or leave in the drill with battery disconnected.
- 4. Turn the old prop to horizontal and pull it straight off. If Shear Pin falls out, put it back in.
- 5. Align the new propeller with the Shear Pin.
- 6. Install the Prop Washer and Prop Nut.
- 7. Tighten the Prop Nut 1/4 turn past snug. Do not over tighten as this can damage the propeller.

TROUBLESHOOTING & REPAIR

- 1. If your Drill Paddle fails to run or lacks power, check the battery of your cordless power drill for proper full charge and make sure that propeller is free from debris that could restrict movement and/ or cause damage.
- 2. If your Drill Paddle loses power after a short running time, check the battery charge of your cordless power drill. If low, restore to proper full charge.
- 3. If you experience prop vibration during normal operation, remove and rotate the prop 180°.
- 4. Recommended voltage for Drill Paddle operation is 18-24v. Any higher voltage may bend or damage the product!

REMEMBER TO KEEP YOUR ORIGINAL RECEIPT

ATTENTION: Never run the Drill Paddle out of the water, as this may result in injuries from the rotating propeller. The Drill Paddle should be disconnected from the power source when it is not in use or is off the water. Disregarding these safety precautions may result in electric shorts of your power source and/or injury to you or others. Always disconnect the power source from the Drill Paddle before cleaning or checking the propeller.

CAUTION: Take care that neither you nor other people approach the turning propeller too closely, neither with body parts nor with objects.
