All tables and chairs must be returned to their pre-event location. All trash should be removed at the end of the event and placed in bins outside.

Users understand that by renting per room and not the full house, other renters may simultaneously rent the available room. The entrance, hallway, The Patricia Bridal Suite, hall bathroom, kitchen and storage room are all common areas and may be used by both users. No furniture or food should be placed in common areas when renting per room, (except when prepping in the kitchen). Ninety Four Investments reserves the right to approve or deny simultaneous rentals based on the event.
