As Senior Policy Advisor for Transportation Equity & Engagement at the Maryland Department of Transportation, Sean supports the Assistant Secretary for Transportation Equity & Engagement in advancing strategic initiatives, policies, government relations, and external communication efforts on behalf of the Secretary of Transportation. 
