# THE PUNJAB LABOUR WELFARE FUND (HARYANA AMENDMENT) ACT, 2019

AN

**ACT** 

further to amend the Punjab Labour Welfare Fund Act, 1965, in its application to the State of Haryana.

Be it enacted by the Legislature of the State of Haryana in the Seventieth Year of the Republic of India as follows:-

1. This Act may be called the Punjab Labour Welfare Fund (Haryana Amendment) Act, 2019.

Short title.

2. For sub-section (1) of section 9A of the Punjab Labour Welfare Fund Act, 1965, the following sub-section shall be substituted, namely:-

Amendment of section 9A of Punjab Act 17 of

'(1) Each employee shall contribute to the Fund every month an amount equal to 1965. zero point two percent of his salary or wages or any remuneration subject to a limit of rupees twenty-five and each employer in respect of each such employee shall contribute to the Fund every month, twice the amount contributed by such employee:

Provided that the limit specified above shall be indexed annually to the consumer price index beginning from first of January each year.

**Explanation.-** For the purposes of sub-section (1), "employee" means an employee on the register of an establishment on the last working day of the month.'.
